We have performed audits of the financial statements of The Dodge Company Savings and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the The Dodge Company Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan with a cash deferral arrangement covering all employees of The Dodge Company (the "Company") who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective on January 1, 1987 and the plan year is January 1 through December 31.

b. Custodian

The Company established a trust with Empower Trust Company, LLC. (the "Custodian"), which consists of such sums of money and other property acceptable to the Custodian that, from time to time, will be paid or delivered to the Custodian, including investments and proceeds thereof and earnings thereon, less the payments made by the Custodian, as authorized. The Custodian has agreed to invest and reinvest the funds as directed by the plan administrator in accordance with the trust agreement.

c. Participant Contributions

Unless they opt-out, each eligible employee is automatically enrolled in the Plan wherein the Company reduces his or her pretax annual compensation by an amount that does not exceed applicable Internal Revenue Service (IRS) regulatory limitations. Participants may also elect to make post-tax basis ("Roth") or a combination of pre and post-tax contributions. Participants may also rollover contribution amounts representing distributions from other qualified plans.

d. Employer Contributions

The Company may make discretionary matching contributions to the Plan. The Company made matching contributions of \$186,137 and \$178,144 for the years ended December 31, 2024 and 2023, respectively. The contributions were based on a percentage of current compensation subject to certain limitations.

e. Participant Accounts

Each participant account is credited with the participant's contributions and allocations of employer contributions, if any, and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

f. Vesting

Participants are immediately fully vested in their voluntary contributions, the Company's matching contributions, and all actual earnings thereon.

g. Forfeitures

All participants are immediately fully vested in their accounts.

h. Investment Options

The Plan offers participants a choice of investing in forty different mutual funds and one common/collective trust offered by the Custodian, each with a specific investment objective. Participants may change investment option specifications daily with respect to contributions to be made in the future and with respect to his or her individual account.

i. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$2,000 up to a maximum equal to the lesser of one-half their vested account balance or \$50,000. Principal and interest are paid ratably through regular payroll deductions.

j. Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum distribution equal to the value of his or her account.

1. Description of Plan

k. Administrative Expenses

Plan administration expenses are paid directly by the Company, whereas participant account administrative expenses are paid by the participants and deducted from their accounts annually.

l. Plan Administration

The Company is the plan administrator. Two of the Plan's trustees are shareholders of the Company.

2. Summary of Accounting Policies

a. Basis of Accounting

The financial statements and supplemental schedule are prepared using the accrual method of accounting, consistent with accounting principles generally accepted in the United States of America.

b. Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

c. Payment of Benefits

The Plan records benefit payments to withdrawing participants when paid.

d. Investment Valuation and Income Recognition

The investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation or depreciation in the fair value of its investments which consists of the realized gains or losses during the year and the unrealized appreciation or depreciation of investments at year-end.

Notes receivable from participants are valued at their outstanding amortized balances, which approximates fair value. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant's individual account. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

e. Subsequent Events

Subsequent events are events or transactions that occur after the balance sheet date but that could affect the amounts or disclosures in the financial statements. Management has evaluated subsequent events through the date that the financial statements are available to be issued, which is the date noted at the bottom of the auditor's report.

3. Related-Party and Party In Interest Transactions

The Plan's investments are managed by Empower Retirement. Empower Retirement is the custodian as defined by the Plan.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Certification of Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule. The plan administrator has obtained certification from the Custodian stating that the information provided to the plan administrator by the Custodian is complete and accurate. Such information includes investments, investment income, realized gains and losses on sales of investments and unrealized appreciation or depreciation in market value of investments.

7. Tax Status

The Plan is a Volume Submitter Profit Sharing 401(k) Plan. The third-party administrator has obtained an Internal Revenue Service determination letter dated June 30, 2020 stating that the Plan, as designed, complies with the requirements under Section 401(a) of the Internal Revenue Code (the "Code"). The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. No provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates all significant tax positions and believes that it has not taken any tax positions that require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would increase or decrease within the next year. The Plan's income tax returns are subject to examination by applicable tax authorities generally for three years after filing.

8. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

8. Fair Value Measurements

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs

The Plan values mutual funds at the net asset value of shares held by the plan at year end. This method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes to the methodology used as of December 31, 2024 and 2023.
