Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Pivot Intermediary, Inc. 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**NOTES TO THE FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF THE PLAN

The following description of the Pivot Intermediary, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution savings plan originally established as the Pivot International 401(k) Profit Sharing Plan & Trust on July 1, 1996, by Pivot International, Inc. The Plan was amended effective June 1, 2021, to change the Plan Sponsor to Pivot Intermediary, Inc. (the “Plan Sponsor”), and to change the name of the Plan to Pivot Intermediary, Inc. 401(k) Profit Sharing Plan & Trust. Effective January 1, 2021, two participating employers, Pivot-DigiTron, Inc. and Pivot-Avator, Inc., combined into a new entity, Pivot Shawnee, Inc.

The following employers are included as participating employers in the Plan (collectively, the “Company”):

- Pivot Holding Company, Inc.
- Pivot International, Inc.
- Pivot Intermediary, Inc.
- Mid Continent Custom Electronics, Inc.
- Pivot – EDM, Inc.
- Pivot – Castle LLC
- Pivot – Solar Breeze LLC
- Pivot – Shawnee, Inc.
- Digital Concepts of Missouri, Inc.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The original effective date of the Plan is July 1, 1996. Effective June 1, 2021, the Plan was amended and restated to adopt the Third Cycle Restatement to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37. Employees of the Company serve as the Plan’s trustees.

On December 1, 2022, Securian’s full-service retirement plan business was acquired by The Standard. During 2023, Securian continued to provide services to The Standard. Effective May 31, 2024, The Standard Insurance Company became the custodian, and The Standard Retirement Services became the recordkeeper. The guaranteed interest account issued by Minnesota Life was also reinsured by The Standard on May 31, 2024. Prior to May 31, 2024, Minnesota Life Insurance Company (“Minnesota Life”) served as custodian and Securian Financial Group’s Participant Recordkeeping System (“Securian”) served as recordkeeper of the Plan.

Eligibility – An individual is eligible to participate in the Plan on their date of hire and may enter the Plan on the first day of each month after meeting the eligibility requirements. The Plan is not open to union employees and non-resident aliens.

Contributions – Participants may elect to contribute pre-tax and Roth contributions up to 100% of their annual compensation subject to certain Internal Revenue Code (“IRC”) limitations.

The Company may make discretionary matching contributions to the Plan, and these contributions may vary by participating employer, and are made on a payroll-by-payroll basis. For 2024, Mid Continent Custom Electronics, Inc. and Pivot – Shawnee, Inc. matched 100% of employee contributions up to 3% of compensation. Castle LLC matched 100% up to 3%, plus 50% up to 5%. Digital Concepts of Missouri, Inc. matched 50% up to 15%. All other participating employers matched 25% of employee contributions up to 6% of compensation.

The Company may also declare a discretionary profit-sharing contribution to the Plan. To be eligible to receive an allocation of any discretionary profit-sharing contribution, a participant must be employed on the last of the Plan year and have 500 hours of service during the year. No profit-sharing contribution was declared for 2024.

Participant Accounts – Each participant’s account is credited with the participant’s and Company’s contributions, and allocations of Plan earnings (losses), and is charged with the participant’s withdrawals and distributions and an allocation of Plan administrative expenses. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – The Plan offers pooled separate accounts and a guaranteed interest account as investment options for participants.

Vesting – Participants’ contributions are fully vested at all times. Participants become 100% vested in Company contributions as follows:

Solely with respect to Digital Concepts of Missouri, Inc. 401(k) Profit Sharing Plan and Trust participants, vesting for employer matching and employer nonelective profit sharing balances that merged into this Plan vest as follows:

A participant is credited with a year of service for each twelve-month period from date of employment. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeiture amounts are used to reduce future employer contributions, or to pay Plan expenses. During 2024, \$33,989 of forfeitures was used to reduce the Company matching contribution, and no funds were used to pay administrative expenses. As of December 31, 2024 and 2023, there are \$0 and \$21,614, respectively, in forfeitures available.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. All loans (except for those made for purchase of a primary residence) must be repaid within five years. Loans bear interest at a reasonable interest rate as determined by the Plan Administrator. A participant may only have one loan

outstanding at any time. A participant's loan shall become due and payable upon termination from employment for any reason, or upon failure to make a principal and/or interest payment, as provided in the loan agreement. Loans are repaid with ACH payments from the borrower's bank account. The balance in the participant's account secures the loan.

Payment of Benefits – Upon termination of service, a participant may elect to receive a distribution of all or any portion of their vested account balance in a single lump sum payment or in installments. For mandatory distributions greater than \$1,000 but not exceeding \$7,000, the vested account balance will be rolled over into an individual retirement account, unless otherwise directed by the participant.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's account balance that is 100% vested.

Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of their vested account balances in a single sum payment.

Administrative Expenses – The Plan may pay certain expenses from Plan assets. During 2023, the Plan paid expenses paid contract administrator fees totaling \$4,506. The Company may pay other professional fees associated with the Plan.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right under the Plan to amend or terminate the Plan at any time subject to the provisions set forth in the Plan and under ERISA. In the event of Plan termination, participants become fully vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in the pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Excess Refundable Contributions – Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants subsequent to year-end.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management’s Review – Subsequent events have been evaluated through September 11, 2025, which is the date the financial statements were available to be issued, and there were no events requiring additional recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled Separate Accounts – Valued at the net asset value (“NAV”) provided by the administrator of the fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets (i.e., common stock, mutual funds, short term securities) owned by the fund, less its liabilities, and then divided by the number of shares outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides the Minnesota Life Guaranteed Return Account, a fully benefit-responsive investment contract issued by Minnesota Life, as an investment option for participants. The objective of this investment option is to guarantee principal and provide a stated interest crediting rate backed by Minnesota Life. The contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Minnesota Life is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is determined on a quarterly basis, as designated by Minnesota Life. The net rate, crediting rate and average yield earned are the same. The crediting interest rate at December 31, 2024, for the contract was 1.66%. The investment contract may be subject to a market value adjustment should the Plan discontinue the contract, as prescribed in the contract. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Minnesota Life may not terminate the contract at any amount less than contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

6. INFORMATION CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard Insurance Company and the The Minnesota Life Insurance Company, the custodians of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments are units of pooled separate accounts and a guaranteed interest account managed by The Standard Insurance Company and Minnesota Life. They are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest. The Plan pays certain expenses to The Standard Insurance Company and Minnesota Life to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest.

8. TAX STATUS

The Company adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with a deferral arrangement which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, employee deferrals of \$42,526 were withheld from participants' payroll and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust and will need to file and pay the appropriate excise tax and contribute lost earnings to the affected participants. These transactions are prohibited according to the provisions of the DOL.

During the year ended December 31, 2023, employee deferrals of \$15,417 were withheld from participants' payroll and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust and has filed and paid the appropriate excise tax and contributed lost earnings to the affected participants. These transactions are prohibited according to the provisions of the DOL.

During the year ended December 31, 2022, employee deferrals of \$15,222 were withheld from participants' payroll and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust and has filed and paid the appropriate excise tax and contributed lost earnings to the affected participants. These transactions are prohibited according to the provisions of the DOL.

During the year ended December 31, 2021, employee deferrals of \$45,178 were withheld from participants' payroll and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust and has filed and paid the appropriate excise tax and contributed lost earnings to the affected participants. These transactions are prohibited according to the provisions of the DOL.
