## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustee of the  
Pacifica Graduate Institute 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Pacifica Graduate Institute 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Pacifica Graduate Institute 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**1. General**

The Plan is a defined contribution plan established by Santa Barbara Graduate School, Inc., dba Pacifica Graduate Institute (the “Employer”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan provides for a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Employer. The plan trustee is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance. American United Life Insurance Company (the “Custodian”) was responsible for the custody and management of certain Plan assets. Effective May 1, 2023, the plan sponsor elected to terminate the fully benefit-responsive insurance contract and convert plan assets to Fidelity Management Trust Company (the “Successor Trustee”). The Employer elected to hold the group annuity contract for 12 months after the transfer of assets to the Successor Trustee, and therefore there was no withdrawal charge. The change in service providers initiated a blackout period from April 21, 2023 through June 9, 2023, during which time participants could not request loans or distributions or make investment allocation changes. Assets of \$13,295,204, including notes receivable to participants, were transferred to the Successor Trustee on May 30, 2023. Effective April 29, 2024, the remaining assets of \$361,293 related to the group annuity contract were transferred from the Custodian to the Successor Trustee (see Notes E, F and I).

**2. Eligibility**

All non-union and non-leased employees who are U.S. residents may participate in the Plan. Employees may begin contributing to the Plan on the first day of each month following eligibility. Employees are also eligible for Employer matching contributions upon one year of service.

**3. Contributions**

Prior to May 1, 2023, participants could elect to contribute, on a tax-deferred basis from 1% to 100% of their eligible compensation, subject to certain limitations under the IRC. Effective May 1, 2023, participants may elect to contribute on a tax-deferred basis or as a Roth 401(k) contribution, up to 100% of their eligible compensation, subject to certain limitations under the IRC (see Note I). Unless a participant elects otherwise the Employer will automatically withhold 4% of the compensation as tax deferred contributions after attaining eligibility. Participant deferrals automatically increase 1% on the first day of the plan year, up to a maximum of 10% of eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may direct contributions, as desired, in any of several investments offered by the Custodian through April 20, 2023 or investments offered by the Successor Trustee as of April 21, 2023, and may change their investment options daily.

In addition, the Employer may make annual discretionary matching contributions of \$0.25 of every \$1.00 deferred, up to a maximum of 1% of participant deferrals.

**4. Participant Accounts**

Each participant's account is credited with the participant's contributions and the Employer's discretionary matching contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**5. Notes Receivable From Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance (not to exceed \$50,000 less the highest outstanding loan balance during the prior twelve-month period). The loans are secured by the balance in the participant's account. Participants may have one loan outstanding at any time. All loans shall bear a reasonable rate of interest as determined by the plan administrator upon issuance. Loans must be paid back within five years of the date of issuance in accordance with terms established by the plan administrator. Prior to May 1, 2023, loans for the purchase of a principal residence may be paid back over thirty years. Effective May 1, 2023, loans for the purchase of a principal residence may be paid back over ten years (see Note I). Loans are due and payable upon the participant's termination of employment with the Employer (see Note J).

**6. Vesting**

Employee contributions, rollovers and actual earnings on all such contributions are fully vested at all times. Vesting of employer discretionary matching contributions and actual earnings thereon, are based upon the participant's years of service with the Employer as follows:

**7. Benefit Payments**

Upon termination of employment with the Employer, a participant may receive a lump sum disbursement if his or her vested account balance is less than \$1,000. If the vested account balance is between \$1,000 and \$5,000, a lump sum will be distributed directly to an individual retirement account unless the participant elects otherwise. For balances greater than \$5,000, the participant is entitled to a lump sum amount. In the event of death or total and permanent disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account. In addition, upon attaining age 59½, participants may receive distributions. Hardship withdrawals are also permitted if certain criteria are met.

**8. Administrative Expenses**

Certain expenses of maintaining the Plan are paid from the assets of the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

**9. Forfeitures**

Forfeitures of terminated participants' non-vested accounts will first be utilized to pay plan expenses and then may be applied against Employer contributions. During the year ended December 31, 2024, \$2,569 of forfeitures was applied against Employer contributions. As of December 31, 2024 and 2023, there was \$1,225 and \$708, respectively of unallocated forfeitures included in net assets available for benefits.

**10. Plan Amendments and Termination**

Although it has not expressed such intent, the Employer, by action of its board of directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**2. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**3. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The American United Life Stable Value Fund is a group annuity contract and is considered fully benefit-responsive and is reported at contract value. The Plan's management determines the Plan's valuation policies utilizing information provided by the Custodian and Successor Trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**4. Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**5. Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding increase to deductions from net assets.

**6. Benefit Payments**

Benefits are recorded when paid.

**7. Subsequent Events**

Plan management has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

**NOTE C - CERTIFICATION BY SUCCESSOR TRUSTEE AND CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all of the investment information, including investment income, and notes receivable from participants and related interest income, included in the accompanying financial statements and supplemental schedule has been certified as complete and accurate by the Successor Trustee and Custodian of the Plan.

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trusts:* Valued at the net asset value of units held by the Plan at year end. The unit value represents the fair value of the underlying assets, as reported by the fund manager. The Plan's investment in the collective trust funds have a readily determinable fair value because they invest primarily in equity investments, such as common stocks and mutual funds, and the net asset value is determined and published daily, is available to participants of the Plan when they log into their online account, and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

**NOTE E - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a benefit-responsive investment contract with the Custodian. The contract is an insurance company issued group annuity with contributions maintained in a general account (see Notes A-1, F and I).

As described in Note B, because the group annuity contract was fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed general account contract. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limited the Plan's ability to transact at contract value with the Custodian. Such events included the following: (a) the complete or partial plan termination of the Plan, (b) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan, or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of subsidiary or division or as a result of group layoffs or early retirement programs.

**NOTE E - INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)**

The group annuity contract did not permit the insurance company to terminate the agreement prior to ninety days written notification.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount that is different from the contract value. Such events include (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation, and (d) a material amendment to the agreement without the consent of the issuer.

**NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Successor Trustee and Custodian are parties-in-interest with respect to the Plan. Investments are held with and managed by the Successor Trustee and were held with and managed by the Custodian through April 29, 2024 (see Notes A-1, E and I). Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than direct payment. Additional fees may be paid directly to the Custodian and Successor Trustee or other parties-in-interest. Notes receivable and the related interest income are considered related party transactions.

**NOTE G - INCOME TAX STATUS**

The IRS has issued an opinion letter to the Successor Trustee dated June 30, 2020, that the adopted non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan did not seek a favorable determination letter with respect to the initial adoption of the plan document, nor with any plan amendments, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expect to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE I - PLAN AMENDMENT AND RESTATEMENT**

Effective May 1, 2023, the Employer elected to terminate the fully benefit-responsive insurance contract and convert plan assets to the Successor Trustee (see Notes A-1, E and F).

Effective May 1, 2023, the Plan was restated in connection with the transfer of assets. The restatement provided for the following modifications to the Plan's provisions:

- Roth deferrals are allowed (see Note A-3).
- Loans obtained for the purchase of a principal residence may be paid back over ten years (see Note A-5).

There were no other material modifications to the Plan.

**NOTE J - SUBSEQUENT EVENTS**

Effective June 3, 2025, the Plan was amended to allow terminated participants to repay notes receivable in accordance with original loan provisions (see Note A-5).

Effective January 1, 2026, the Plan will implement certain provisions of the Secure Every Community Up for Retirement ("SECURE 2.0") Act provisions and will be amended by the required due date.
