INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of
PIP 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the PIP 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the PIP 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General Information and Plan Amendments

The Plan, sponsored by Protective Industrial Products, Inc., is a defined contribution plan covering substantially all employees of Protective Industrial Products, Inc. and its Subsidiaries who do not maintain their own plan (collectively referred to as “the Company”).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees of the Company that attain the age of 21 and complete one month of service are eligible to participate in the Plan on the first day of each month after meeting the eligibility requirements. Employees covered by the terms of a collective bargaining agreement are excluded from the Plan unless the collective bargaining agreement specifies employees must be covered under the Plan. Also excluded are nonresident aliens who receive no earned income from the Company within the United States and part-time, temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours per year.

Contributions

The Plan allows employees to make pre-tax (Traditional) and/or post-tax (Roth) contributions from between 0% and 90% of compensation, subject to certain limitations, under the Internal Revenue Code (IRC). Each participant in the Plan may defer the maximum percentage of their compensation and dollar amount permissible under the IRC as a basic contribution to the Plan. Participants who are projected to be age 50 or older by the end of the calendar year are eligible to make catch-up contributions up to the dollar amount permissible under the IRC. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employees who are qualifying contributing participants are eligible for employer matching contributions. The employer makes safe harbor matching contributions of 100% of the first 3% of eligible compensation that a participant contributes to the Plan, plus 50% of the next 2% of eligible compensation that a participant contributes to the Plan. The Company may also make discretionary employer non-elective (profit sharing) contributions, as defined by the Plan. Participants must be employed on the last working day of a Plan year or work at least 501 hours during the Plan year to be eligible for an allocation of the discretionary profit-sharing contribution. There was no profit-sharing contribution made for the year ended December 31, 2024. Contributions are subject to certain limitations under the IRC.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) Company matching contributions, (b) Plan earnings and losses, and c) administrative expenses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is based on a participant’s vested account.

NOTE 1 — DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants are immediately vested in their contributions, rollover contributions, Company safe harbor matching contributions and profit-sharing contributions, plus actual earnings (losses) thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate, as defined by the Plan. Participants may only have one loan outstanding at a time. The maximum duration of a loan is not to exceed five years, except in cases where funds are used to purchase a principal residence, in which case the duration of the loan is not to exceed 10 years. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Benefits are distributed in a lump sum payment and are based on normal retirement date, disability, death or termination of employment of the participant. Participants are eligible for a distribution as soon as administratively feasible following the participant's termination date. Termination distributions of account balances greater than \$5,000 may be deferred to a later date. Participants may also request an in-service withdrawal after age 59½ or hardship withdrawal upon meeting certain requirements as outlined by the Internal Revenue Service (IRS).

Forfeitures

Forfeitures from participant non-vested accounts may be used to reduce Company contributions or pay expenses of the Plan. At December 31, 2024 and 2023 forfeitures totaled \$115 and \$2, respectively. There were no forfeitures used during the year ended December 31, 2024.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Plan expenses primarily consist of recordkeeping and investment advisory fees. Fees for the administration of notes receivable from participants and benefits paid to participants are included in administrative expenses and charged directly to the participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

Reclassifications

Certain items were reclassified in the 2023 financial statements to conform to the 2024 presentation.

Subsequent Events

Effective April 1, 2025, the Plan was amended to no longer permit future loan requests for participants. This amendment did not impact current outstanding notes receivables from participants.

On May 22, 2025, the Company acquired the Personal Protective Equipment Business ("PPE Business") of Honeywell International Inc. ("Honeywell"), significantly increasing the participation in the Plan in 2025.

The Plan has evaluated subsequent events through August 29, 2025, the date the financial statements were available for issuance.

NOTE 3 — INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy. These certifications are as of December 31, 2024 and 2023, and for the year ended December 31, 2024 and includes investment information related to the fair value of investments, notes receivable from participants, interest income on notes receivable from participants, interest and dividend income and net appreciation (depreciation) of fair value of investments that is included in the Plan's financial statements and supplemental schedule of assets (held at end of year).

NOTE 4 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets, that the Plan has the ability to access, for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices of identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 were not available.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds: Valued at the daily closing net asset value (NAV) as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of the collective trust. The NAV, as provided by the custodian/trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. As of December 31, 2024 and 2023, there were no unfunded commitments related to these investments, and no redemption restrictions.

Stable value fund: Valued at the NAV of units of the fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets which consist primarily of fully benefit-responsive investment contracts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 — TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the non-standardized pre-approved profit-sharing plan adopted by the Plan and related trust, as then designed, is in compliance with the applicable sections of the IRC.

The plan administrator has analyzed the tax positions taken by the Plan as required by generally accepted accounting principles, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company, the trustee and recordkeeper of the Plan, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

Notes receivable from participants also qualify as party-in-interest transactions and are also exempt from the prohibited transaction rules of ERISA.

NOTE 7 — PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 8 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the statements of net assets available for benefits.
