### **Opinion**

We have audited the financial statements of Kumar & Associates, Inc. ## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1 - Plan Description

The following description of Kumar & Associates, Inc. Employee Stock Ownership Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **Administration**

Under the terms of the Plan, the board of directors of Kumar & Associates, Inc. (the "Company") designates the administrative committee and trustee to control the operation and administration of the Plan. The Company is the plan sponsor. The plan sponsor contracted with Blue Ridge ESOP Associates (Blue Ridge) to act as the Plan's recordkeeper to maintain the individual accounts of each plan participant. The administrative committee of the Plan reports all transactions to Blue Ridge so that Blue Ridge is able to perform record keeping for the Plan. The Company provides, at no cost to the Plan, certain administrative, accounting, and legal services to the Plan and also pays the cost of certain outside services for the Plan.

#### **General**

The Plan is a defined contribution plan established on January 1, 2000 and most recently amended on January 1, 2015. The Plan is available to employees who have completed one year of service or 1,000 hours of service during the 12-month period beginning on their commencement date. Upon becoming a participant, the eligibility computation period shall coincide with the plan year. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (the "Code"), as amended, and the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants who do not have at least 1,000 hours of service during the plan year and are not employed on the last day of the plan year are not eligible for an allocation of company contributions and forfeitures for the year, unless the participant has reached normal retirement age, retired due to disability, or died, in which case the participant's termination date is considered the last day of the plan year in which one of these events occurs. Ineligible employees include certain leased employees and those subject to a collective bargaining agreement unless the agreement provides for participation.

During June 2024, the Plan entered into a note payable agreement with an executive of the Company for the purchase of 2,794 shares of company common stock. The note payable is guaranteed by the Company and collateralized by the unallocated shares of the company common stock underlying the note payable agreement. Subsequent to this note payable transaction, during the year ended December 31, 2024, the Company executed a 10-for-1 stock split, which increased the shares of company common stock held by the ESOP from 25,281 to 252,810. The company common stock is held in a trust established under the Plan. As the Plan repays the note payable, a percentage of company common stock will be allocated to eligible employees' accounts in accordance with the note payable agreement, plan document, and applicable regulations under the Code. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to the accounts of participants in allocated common stock (allocated) and common stock not yet allocated to participants (unallocated).

#### **Employer Contributions**

The Company makes annual discretionary contributions to the Plan, as approved by the Company's board of directors. The Company's discretionary contributions are allocated among individual accounts established for each participant in proportion to the ratio that each participant's eligible compensation for the plan year bears to the eligible compensation of all participants for the plan year. There was a \$25,000 discretionary employer contribution into the Plan during the year ended December 31, 2024. Participants are not allowed to contribute to the Plan.

The Company is also required to make contributions to fund the required payment obligations on the Plan's related party note payable, as necessary.

**Note 1 - Plan Description (Continued)**

***Participant Accounts***

Each participant's share of plan assets is recorded in two accounts: the Company Stock Account, which generally represents the participant's allocable portion of the company common stock included in plan assets, and the Other Investment Account, which generally represents the participant's share of earnings and losses on the investments (mutual funds, pooled separate accounts, and interest-bearing cash); interest; dividends, if any; and company contributions and forfeitures in other than company common stock. During the year ended December 31, 2024, the Plan received dividends on company common stock totaling \$655,707, which were allocated to participants based on beginning company common stock balances in their accounts.

Each participant's account is credited or charged as of each last day of the plan year with an allocation of the Company's contributions; dividends, if any; plan earnings or losses; forfeitures; and plan expenses. Allocations are based upon participant and plan eligible compensation, plan earnings or losses, and account balances, as defined by the Plan. The benefit to which a participant is entitled is the vested portion of the participant's account.

***Voting Rights***

Each participant is entitled to direct the trustee as to the manner in which any voting rights under company common stock allocated to such participant's account are to be exercised solely with respect to a corporate matter of the Company, which involves the voting of such shares with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transactions prescribed in the Code. The trustee, with direction from the administrative committee, shall exercise voting rights, with respect to company common stock that is not allocated to a participant's account and with respect to company common stock that is allocated to participants' accounts, except as provided for above.

***Vesting***

The Company's contributions, forfeitures, and the earnings or losses thereon not fully vested when contributed will vest according to the following schedule:

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. In each of the first 5 years after qualifying for diversification, a participant may diversify up to 25 percent of the number of shares allocated to his or her company common stock account, less amounts previously withdrawn, within 90 days of the last day of each plan year. The percentage available for diversification increases to 50 percent after the sixth year, provided the diversification is requested within 90 days after the close of the sixth plan year.

**Note 1 - Plan Description (Continued)**

***Forfeitures***

If a participant terminates employment for any reason other than retirement, total disability, or death, the nonvested portion of the participant's account balance is forfeited and allocated to the other plan participants based upon their proportionate share of eligible compensation subject to certain limits. The amount to be forfeited will be deducted from the participant's balance. Cash forfeitures in the amount of \$71,315 were reallocated to eligible participants during the year ended December 31, 2024. There were no unallocated forfeiture balances as of either December 31, 2024 or 2023.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances, which will be distributed to such participants or their beneficiaries at the time prescribed by the plan agreement and the terms of the Code. In the event of plan termination, the trustee shall distribute all assets remaining in the Plan, after payment of liabilities and expenses properly chargeable against the Plan, to participants in accordance with the value of the units credited to such participants as of the date of such termination.

***Benefit Payments***

Benefit payments are made in accordance with plan provisions. For termination due to death, disability, or attaining normal retirement age, benefits will begin to be distributed as soon as administratively feasible after the close of the plan year in which the participant terminates and the participant or the participant's beneficiary elects a distribution. For termination of service for other reasons, the Plan must begin distributing the vested balance no later than the sixth year after termination from employment and upon receipt of election to receive the distribution from the participant. The plan administrator has the option to distribute the balance in a lump sum or with substantially equal annual installments over a five-year period, which can be extended in certain circumstances depending on the size of the vested account balance, in accordance with plan provisions. The Plan allows for the automatic distribution of participant vested account balances that do not exceed \$5,000.

***Put Option***

Under federal income tax regulations, since the company common stock that is held by the Plan and its participants is not readily tradable on an established market, it is subject to a put option. Participants shall have the right to demand that the Company buy any shares of its stock distributed to these participants for which there is no established market. The put price is representative of the fair value of the stock, as determined by the independent appraisal obtained as of the most recent plan year end. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash. The Plan segregates terminated participant company common stock balances into cash at the end of the plan year in which the termination occurs.

**Note 2 - Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. The most significant assumptions and estimates relate to the valuation of company common stock. Application of these assumptions requires the exercise of judgment as to future uncertainties, and, as a result, actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in interest-bearing cash, a mutual fund, pooled separate accounts, and company common stock. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 17, 2025, which is the date the financial statements were available to be issued.

***Administrative Expenses***

Various administrative costs are paid by the Company.

**Note 3 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 3 - Fair Value Measurements (Continued)**

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Fund***

The mutual fund is valued at the quoted price reported in active markets.

***Company Common Stock***

The administrative committee has an independent valuation performed at the end of each plan year to determine the fair value of the Company's common stock. The independent appraiser contract is renewed and approved each year. The fair value is approved by the administrative committee and trustee each year after reviewing the independent valuation, and an agreement is reached on the appropriateness of the inputs, assumptions, and methodologies used in the valuation. The valuation of the Company's common stock used the income approach (discounted cash flow method), the market approach (guideline public company method, comparable transaction method, and the guideline merged and acquired method), and the asset approach (restated net worth method and book value method) as of December 31, 2024 and 2023. There was no discount for lack of control for the 2024 valuation, since the ESOP holds more than 50 percent of total company common stock due to the 2024 note payable purchase transaction disclosed in Note 5. A discount for lack of control in the amount of 10 percent was applied to the 2023 valuation. A discount for lack of marketability in the amount of 5 percent was applied to both the 2024 and 2023 valuations.

***Interest-bearing Cash***

Interest-bearing cash is valued at the outstanding balance, which is the best estimate of fair value.

***Pooled Separate Accounts***

The pooled separate accounts are valued at net asset value (NAV) per share or its equivalent of the funds, which is based on the fair value of the funds' net underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

**Note 5 - Related Party Note Payable**

During June 2024, the Plan entered into a note payable agreement in the amount of \$471,515 with an executive of the Company. The proceeds from the note payable were used to purchase 2,794 shares of company common stock (prior to the 10-for-1 stock split disclosed in Note 1, which increased the initial unallocated shares to 27,940) from the executive. The note payable bears interest at 4.57 percent. Principal and interest payments in the amount of \$26,506 are due quarterly beginning in September 2024. The note payable matures in June 2029 and is secured by 25,146 unallocated shares as of December 31, 2024.

**Note 6 - Tax Status**

The Plan obtained its latest determination letter on March 19, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note 7 - Party in Interest**

The Plan's investments include company common stock, and transactions related to this stock qualify as party-in-interest transactions. Additionally, the Plan entered into a note payable agreement with an executive of the Company, which matures in June 2029. These transactions are exempt from the prohibited transaction rules.
