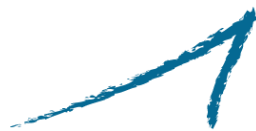

## Independent Auditor's Report

To the Participants and Plan Administrator of  
the Gettysburg College Retirement Healthcare Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Gettysburg College Retirement Healthcare Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## **NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023**

### ***Note 1* Description of the Plan**

The following description of the Gettysburg College Retirement Healthcare Savings Plan (the Plan), formerly known as Emeriti Retiree Health Plan for Gettysburg College, provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### **General**

The Plan, which was established July 1, 2005, is a defined contribution health and welfare plan covering eligible employees of Gettysburg College (the College) or participating affiliates of the College. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The College made a decision to terminate its participation in the Emeriti program effective September 30, 2024 and has adopted a program managed by TIAA as recordkeeper, with all Plan assets remaining with TIAA Trust, N.A. as trustee. In connection with this change, claim management services transferred from CBIZ, Inc. (CBIZ) to Optum Financial. In addition, access to the Aetna insurance coverage under the Plan ended effective December 31, 2024. Concurrent with this change, the Plan was renamed the Gettysburg College Retirement Healthcare Savings Plan.

#### **Contributions**

Employees are eligible to make employee after-tax contributions commencing with their date of hire provided they are at least 21 years of age. Participants may contribute any amount to their account, subject to amounts permitted under the Internal Revenue Code (IRC). Employee contribution amounts and investment elections may be changed at any time by the participants.

The College will begin making employer contributions to the Plan on behalf of each eligible employee on the first day of the month following attainment of age 35 and completion of two years of service. The College's contribution is based on an annual flat dollar amount for each eligible participant, adjusted annually as determined by the Board of Trustees. The College will cease making employer contributions to a participant's account as of the date when the College has made contributions for 25 years, the employee ceases to be employed by the College, or if the participant dies.

In addition, the College contributes a stipend to a certain group of retirees to be used for medical insurance premiums. The College's contribution is adjusted annually as determined by the Board of Trustees.

### ***Note 1* Description of the Plan - Continued**

#### **Contributions - Continued**

Prior to the termination from the Emeriti program, contributions were held in two separate Voluntary Employees' Beneficiary Association (VEBA) trusts, which is a special type of trust where the earnings on contributions are not taxed. Amounts paid out for reimbursement of qualified medical expenses, including premiums for health insurance coverage, are also tax-free. In connection with the withdrawal from the Emeriti program, the Employer-Contribution VEBA Trust and Employee-Contribution VEBA Trust were merged.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the College's contributions, an allocation of Plan earnings and losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provide from the participant's vested account.

#### **Retirement Eligibility and Benefits**

A participant who is employed by the College meets the requirements for retirement eligibility under the Plan upon attaining age 55 and having performed at least 10 years of continuous service and enrolls in Medicare A and B (after attaining age 65). Upon meeting the requirements for retirement eligibility under the Plan, participants are reimbursed for allowable medical expenses, including premiums for health insurance coverage for themselves, spouses, domestic partners, and dependent children. The Emeriti health insurance options are underwritten by Aetna Life Insurance Company (Aetna). Upon termination from the Emeriti program, the Aetna insurance option is no longer available.

Participants that terminate their employment prior to attaining age 55 are eligible for reimbursements for allowable medical expenses from their vested account balance, as described in the Plan agreement.

### ***Note 1* Description of the Plan - Continued**

#### **Vesting and Forfeitures**

Participants are immediately vested in their elective contributions plus actual earnings (losses) thereon. Employer contributions are not vested until the employee is age 55 with 10 years of service and employed by the College. Any residual balance remaining in the Employee After-Tax Contribution Account upon the participant's death and the death of any related dependents will be forfeited to the Plan. Forfeited funds may be used to offset future employer contributions, pay plan expenses, or may be reallocated to remaining participant's accounts. During 2024, \$53,827 of non-vested forfeited accounts were used to offset employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts were \$60,265 and \$24,687, respectively.

#### **Plan Administration**

TIAA Trust, N.A., the Plan's trustee, has authority to execute investment transactions pursuant to participants' elections. Teachers Insurance and Annuity Association of America (TIAA), the recordkeeper, provides administrative services to the Plan and maintains Plan-related records.

Emeriti Retirement Health Solutions (Emeriti) and CBIZ also provide certain administrative services to the Plan. Effective October 1, 2024, Optum Financial provides certain administrative services to the Plan.

### ***Note 2* Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Subsequent Events**

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through September 18, 2025, the date that the financial statements were available to be issued.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

The College pays for certain administrative expenses incurred in connection with the operation of the Plan. The administrative expenses on the statement of changes in net assets available for benefits primarily represent fees deducted from participants' accounts for services performed by Optum Financial, Emeriti, CBIZ and TIAA.

### **Note 3 Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. This guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### ***Note 3* Investment Valuation and Income Recognition - Continued**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: These investments are valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market. Accordingly, the registered investment companies are classified within Level 1 of the valuation hierarchy at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Note 4* Certified Information**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Administrator has obtained certifications from TIAA for the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity (including interest and dividend income and net appreciation in fair value of investments) reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Note 5 Party-in-Interest Transactions**

The Plan invests in shares of registered investment companies managed by an entity related to TIAA and, therefore, transactions involving these investments qualify as party-in-interest transactions. Emeriti, CBIZ and Optum Financial provide certain administrative services for the Plan and, therefore, transactions involving these parties qualify as party-in-interest transactions. Fees paid to parties-in-interest were \$44,410 for the year ending December 31, 2024.

**Note 6 Tax Status**

The Internal Revenue Service (IRS) has determined and informed the College by letters dated August 11, 2006 that the trusts funding the Plan are tax exempt under 501(c)(9) of the IRC. The determination letters have been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator and College believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 Risks and Uncertainties**

The Plan invests in investment securities which are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as inflation, a pandemic or international conflict. Due to the level of risk associated with these securities, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 Plan Termination**

Although it has not expressed any intent to do so, the College reserves the right to discontinue employer contributions, eliminate any form of benefit, or terminate the Plan at any time, subject to the provisions of ERISA.
