## INDEPENDENT AUDITORS' REPORT

To the Participants, Management, and Plan Committee of the  
Jim Keras 401(k) Profit Sharing Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Jim Keras 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### NOTES TO FINANCIAL STATEMENTS

#### 1. PLAN DESCRIPTION

The following description of the Jim Keras 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan with a 401(k) feature covering all full-time employees of Jim Keras Buick Co., Inc., Jim Keras Nissan, Inc., Covington Pike Acceptance Corporation, or Arches Automotive LLC DBA Webster Groves Subaru (the “Company”), who have completed three months of service and are age eighteen or older. Entry dates are the first day of each month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is governed by the Company’s Board of Directors. Empower Retirement serves as the Plan custodian.

##### Contributions

Each year, participants may contribute up to the maximum limitation set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may direct the investment of their contributions among any or all of the investment options offered by the Plan.

The Company contributes a matching contribution based upon a discretionary formula which is determined from year to year. The matching contribution is equal to 2% of a participant’s elective deferral which does not exceed a discretionary percentage of the participant’s compensation. For the year ended December 31, 2024, the discretionary percentage was 10%. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors. Such contributions, if any, and forfeitures are allocated on the basis of the ratio of participant’s compensation to all participants’ compensation.

##### Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, as well as allocations of the Company’s profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## JIM KERAS 401(K) PROFIT SHARING PLAN

### NOTES TO FINANCIAL STATEMENTS

#### 1. PLAN DESCRIPTION (Continued)

##### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

##### Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period of time, not exceeding a participant's life expectancy or the joint life expectancy of a participant and participant's designated beneficiary. An eligible rollover distribution is also permitted. If the value of a participant's account is less than \$5,000, a lump sum distribution will be made without regard to the consent of the participant as soon as administratively feasible.

##### Forfeited Accounts

Forfeitures are used to reduce employer matching contributions and pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,752 and \$12,186, respectively. For the years ended December 31, 2024 and 2023, forfeitures were used to reduce employer contributions of \$8,063 and \$80, respectively.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### NOTES TO FINANCIAL STATEMENTS

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a confirmation date basis. Interest income is recorded on accrual basis. Dividends are recorded on the confirmation date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Payment of Benefits

Benefits are recorded when paid.

##### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

##### Subsequent Events

The Company has evaluated subsequent events through August 29, 2025, the date the financial statements were available to be issued.

#### 3. INFORMATION CERTIFIED BY THE CUSTODIAN

Empower Trust Company, LLC (the "Custodian") has certified the completeness and accuracy of certain information which management used in preparing the financial statements, supplemental schedule and accompanying notes. The following is a summary of information which the Custodian furnished:

- a. Investments as reported in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b. All items of income and expense related to Plan investments and all transactions for the year ended December 31, 2024.
- c. Investments as reported in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1                      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2                      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3                      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds:* Value at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no significant transfers between Level 1 and Level 2 investments during the years ended December 31, 2024 and 2023.

#### 5. GUARANTEED INTEREST ACCOUNT

The Plan has entered into a traditionally fully benefit-responsive guaranteed interest account (GIA) with MassMutual, reinsured by Empower as a result of the December 31, 2020 acquisition. The GIA totaled \$442,385 and \$451,530 for the years ending December 31, 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIA issuer is contractually obligated to repay principal and a specified interest rate that is guaranteed to the Plan. The GIA is valued using a market value formula approach. The estimated fair value of the GIA is determined to be the calculated market value of the GIA. The market value is calculated using the following unobservable inputs (1) the assumed interest rate obtainable by Empower on new investments where a proxy is a blend of multiple indices (i.e. multi-index) as described in the Market Value formula under the Contract. (2) The experience rate for the Contract, which is the weighted average of the investment year interest rates for pension account funds. The weighting reflects the distribution of Contract funds to the various investment years in which the Contract has been in effect.

#### 5. GUARANTEED INTEREST ACCOUNT (Continued)

This account meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### 7. TAX STATUS

The Internal Revenue Service has determined and informed the pre-approved plan provider, by a letter dated November 14, 2022, that the Plan, as then designed, is in accordance with the applicable requirements of the Internal Revenue Code (IRC). The prep-approved plan provider has informed the Plan's administrator that the Plan was restated since receiving the determination letter. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

#### 9. PARTY-IN-INTEREST TRANSACTIONS

The Plan paid certain expenses related to general administration and record keeping to various service providers. These transactions are party-in-interest transactions under ERISA. In addition, the Plan Sponsor pays a portion of these expense and certain accounting fees relating to the Plan.
