NOTE 1: DESCRIPTION OF PLAN

The following description of the Summit Restaurant Group Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 01, 1999, and restated on January 01, 2022, covering all eligible employees of the following companies who are affiliated through common ownership: Summit Restaurant Group, LLC, Summit Pizza, Inc., Summit Eateries LLC, Arkansas Pizza, Inc., Summit Interests, LLC, Bottom Shelf, LLC, Summit Subs, LLC and Summit Pizza West, LLC (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Standard Insurance Company ("Standard") serves as the custodian and recordkeeper. The President of the Company serves as trustee to the Plan.

Eligibility

An individual is eligible to participate in the Plan after one year of service, with 1,000 hours, and upon reaching the age of 21. Employees may enroll in the Plan on the first day of the month following meeting the eligibility requirements. The Plan is not open to union employees and nonresident aliens.

Contributions

Participants may elect to contribute any amount of their annual compensation, subject to certain Internal Revenue Code ("IRC") limitations. The Company may make discretionary matching contributions to contributing employees. In 2024 and 2023, the Company matched participant contributions at an amount equal to 50% of each eligible contribution, not to exceed 3% of compensation.

Additionally, the Plan permits the Company to make discretionary profit-sharing contributions. Profit-sharing contributions are allocated to eligible participants in accordance with the applicable provisions of the Plan. There were no profit-sharing contributions in the years 2024 and 2023.

Participant accounts

Each participant's account is credited with the participant's and the Company's contributions, an allocation of the Plan's investment earnings and losses, and is charged with the participant's withdrawals and distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options

The Plan offers a variety of pooled separate accounts and a guaranteed investment contract ("GIC") as investment options for participants.

Payment of benefits

Upon termination of employment, the participant may elect to receive a single lump-sum distribution equal to the value of his or her account, or installments over the participant's life and partial distributions, subject to the terms of the Plan Document.

In-service withdrawals

Hardship withdrawals are available to Plan participants for reasons as defined in the Plan Document. Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

Vesting

Participants' contributions are fully vested at all times. Employer contributions vest as follows:

In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, Company contributions will become fully vested.

Forfeitures

Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeiture amounts are used to reduce Plan expenses first and then used to reduce future employer contributions. As of December 31, 2024, and December 31, 2023, non-vested forfeited accounts totaled NIL and \$1,566, respectively, which includes adjustments for earnings or losses, amounting to \$6 and \$11 for the year ended December 31, 2024, and December 31, 2023, respectively. Forfeitures of terminated employees' non-vested accounts totaled \$1,834 during the year 2024 and \$4,391 during the year 2023. During the year 2024, \$3,406 forfeitures were utilized for expenses, and during the year 2023, \$2,899 forfeitures were utilized for expenses.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 5 years, except if the loan is to acquire the participant's principal residence, then the loan term can be up to 10 years. Interest rates are established as the Prime rate plus one percentage point. A participant's loan shall immediately become due and payable upon termination from employment for any reason, or upon failure to make a principal and/or interest payment, as provided in the loan agreement. The balance in the participant's account secures the loan. A participant may have only one loan outstanding.

Administrative expenses

The Company pays the professional service fees of the Plan. Forfeitures may be applied to reduce certain administrative expenses before amounts, if any, are charged to the Plan or paid by the Company.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates in financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Participant and employer contributions are recognized in the period in which the related employee services are rendered. Contributions collected subsequent to year-end that relate to services before year-end are recorded as contributions receivable.

Investment valuation and income recognition

The Plan's investments are stated at fair value, except for the guaranteed investment contract, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Guaranteed investment contract (GIC): The fully benefit-responsive investment contract or guaranteed investment contract (GIC) is reported at contract value (the amount participants would receive if they were to initiate permitted transactions), with related crediting-rate mechanics and any limitations on participant-directed transactions described in Note 7 on the Investment Contract with Insurance Company.

Pooled separate accounts. Investments in pooled separate accounts are measured at the unit value (net asset value "NAV") as a practical expedient to estimate fair value. Accordingly, such investments are excluded from the fair value hierarchy disclosures. The Plan had no unfunded commitments, daily redemption frequency, and no advance-notice requirements, lock-ups, gates, or other participant-level redemption restrictions related to these investments as of December 31, 2024, and December 31, 2023. Refer to Note 3 – Fair Value Measurements for further detail.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Excess refundable contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants subsequent to the respective year end.

Payment of benefits

Benefit payments are reported in the year paid. As of December 31, 2024, and December 31, 2023, there were no amounts allocated to participants that were approved for payment but not yet paid.

NOTE 3: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) ASC 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in inactive markets that the Plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset, including assumptions regarding risk.

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and December 31, 2023.

Pooled separate accounts: The investment advisors calculate a unit value (similar to a net asset value “NAV”) of a separate account. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan’s investments are reported at fair value as follows at December 31, 2024, and December 31, 2023:

NOTE 4: RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events that could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 5: INFORMATION CERTIFIED BY STANDARD INSURANCE COMPANY ("CUSTODIAN") (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard Insurance Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements is complete and accurate with respect to investments as of December 31, 2024, and December 31, 2023, and the supplemental schedule for the year ended December 31, 2024. The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for

NOTE 7: INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive investment contract with The Standard Insurance Company ("Standard"). Standard maintains the contributions in a general account, which is credited with earnings or losses on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value and then adjusted to contract value as reported to the Plan by Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract has certain restrictions that impact the ability to collect the full contract value. Such events include termination of the contract, spin-offs,

divestitures, layoffs, partial or total Plan termination, certain retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon the occurrence of any of these events, a market value adjustment may apply. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Standards may terminate the contract at an amount less than contract value with 30 days' advance written notice to the Plan for reasonable cause, which includes the Plan's failure to abide by state or federal law, failure to perform under the terms of the contract, or Plan disqualification. The Guaranteed Investment Contract ("GIC") held by the Plan meets the definition of a fully benefit-responsive investment contract under ASC 962, and accordingly is reported at contract value, which represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Standard is contractually obligated to pay the principal and the specified interest rate that is guaranteed to the Plan. The crediting interest rate is declared each quarter. The crediting rate of the contract will track current market yields on a trailing basis. Under the existing contract, the average yield based on actual earnings and interest credited to participant accounts yielded is 1.87% and 1.59%, for the years ended December 31, 2024, and December 31, 2023, respectively.

NOTE 8: INCOME TAX STATUS

The Company adopted a Prototype Non-Standardized Profit-Sharing Plan with Cash or Deferred Arrangement ("CODA"), which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has since been amended. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024, and December 31, 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9: EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments are pooled separate accounts and a GIC managed by Standard Insurance Company. Standard Insurance Company is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest.

The Plan pays certain fees to Standard Insurance Company to administer the Plan. These transactions qualify as party-in-interest. Notes receivable to participants are party-in-interest transactions.
