INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
Area Teamsters Insurance Benefit Plan
Lyons, Illinois

Opinion

We have audited the accompanying financial statements of Area Teamsters Insurance Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements are prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Investment Valuation and Income Recognition - Area Teamsters Insurance Benefit Plan (the Plan) investments in certificates of deposit and money market funds are carried at fair value in accordance with fair value measurements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recognized on a trade-date basis. Interest income is recognized on the accrual basis.

Administrative Expenses - The Plan pays all administrative expenses.

Employer Contributions Receivable - The Plan estimates amounts receivable from reporting employers at year-end based upon amounts collected subsequent to year-end. Based on review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial. Employer records are subject to audit and additional revenue, if any, that may arise as a result of these audits, is recognized when received.

Property and Equipment - Property and equipment are recorded at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation is computed over the following estimated useful lives of the related assets by the straight-line method.

Statements of Benefit Obligations - The Plan is fully insured for all benefits provided to participants. Further, the Plan does not provide for any postretirement benefits to any participants. Therefore, statements of benefit obligations and changes in benefit obligations are not applicable to the Plan.



NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Insured Benefits - The Plan has nonexperience rated contracts with insurance providers for the years ended December 31, 2024 and 2023. The Plan has no current or future obligation for any excess of claims paid over premiums remitted that may arise. BlueCross BlueShield provides all medical benefits, Delta Dental provides all dental benefits, EyeMed Vision Care provides vision benefits, and Dearborn National provides life insurance benefits.

Claims payable and claims incurred but not reported at year end are payable by the insurance companies listed above and, therefore, are not reflected in the financial statements.

Estimates - The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual amounts could differ from those estimates.

Lease Policy - In its statements of net assets available for benefits, the Plan records a right-of-use asset and lease liability, initially measured at the present value of total lease payments using a risk-free rate that approximates the remaining term of the lease. The Plan considers the likelihood of exercising renewal or termination clauses (if any) in measuring its right-of-use assets and lease liabilities. A single lease cost calculated so that the cost of the lease is allocated over the lease term on straight-line basis. Short-term leases (those with an initial term of twelve months or less and no purchase option) are expensed over their terms, with no corresponding right-of-use asset or lease liability recorded. The Plan does not separate non-lease components (if any) from lease components in determining the lease payments.

NOTE 2. DESCRIPTION OF THE PLAN

The Plan was established in 1999 as a result of collective bargaining agreements to provide medical, life, dental, and vision benefits for eligible employees and their dependents.

Eligibility is determined based on the various collective bargaining agreements, taking into account waiting periods prior to participation. Once establishing eligibility, participants remain eligible as long as they are credited with contributions for hours worked, based on varying contribution rates, on a monthly basis.

The Plan provides varying levels and types of benefits, based on the collective bargaining agreements. Insured health benefits may either be under a PPO or HMO insurance policy. Dental, vision and life insurance benefits are provided on the same basis and are subject to additional contributions by the employer prior to being available.



NOTE 2. DESCRIPTION OF THE PLAN (CONTINUED)

Contributions to the Plan are made for eligible employees, by employers subject to the various collective bargaining agreements, at varying rates depending on the type of benefits provided. Participants may be required, in certain cases, to contribute a portion of the contribution to the Plan. This amount is remitted to the Plan by the employer and is classified as an employer and participant contribution on the financial statements.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by Consolidated Omnibus Budget Reconciliation Act (COBRA) was adopted by the Plan. These contributions are remitted to the Plan by the participant and classified as participant contributions in the financial statements.

Participants should refer to the summary plan description for more complete information.

NOTE 3. PRIORITIES UPON TERMINATION

It is the intent of the Board of Trustees (Trustees) to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to terminate the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining assets will be distributed in such manner as will, in the opinion of the Trustees, be consistent with the intended purposes of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of participants.

NOTE 4. TAX STATUS

The Plan obtained its latest exemption letter dated September 16, 2004, in which the Internal Revenue Service (IRS) stated that the Plan was in compliance with the applicable requirements under Section 501(c)(9) of the Internal Revenue Code (IRC) and, therefore is not subject to taxes.

The Plan has been amended since receiving the exemption letter. The Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. They believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.



NOTE 5. LEASE AND RELATED PARTIES AND PARTIES-IN-INTEREST TRANSACTIONS

The Plan has two related entities, Local Union No. 777 International Brotherhood of Teamsters, School Bus Drivers, Laborers, Miscellaneous and Unskilled Workers, Chicago and Vicinity, Illinois (Local Union) and Local 777 Severance and Retirement Plan (Severance Fund). Both entities are tax-exempt organizations. The financial activities of these organizations are not included in the accompanying financial statements.

The Plan shares office facilities with the Local Union. Effective January 1, 2023, the Plan entered into a lease agreement with the Local Union requiring monthly payments of \$1,494 for office space plus allocated operating expenses through December 31, 2027.

The operating expenses of the combined facility are paid initially by the Local Union and then allocated to the Plan on a basis approved by the Trustees. Reimbursements to the Local Union for rent and operating expenses, totaled \$30,443 and \$30,440 for the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, the Local owes the Plan \$85 and \$14,764, respectively, for operating expenses paid by the Plan.

Reimbursements from the Severance Fund to the Plan for administrative services provided by employees of the Plan totaled \$104,778 and \$91,758 for the years ended December 31, 2024 and 2023, respectively. The Severance Fund owes the Plan \$21,382 and \$7,963 for the Plan's portion of the employee's payroll and benefit expenses as of December 31, 2024 and 2023, respectively.



NOTE 5. LEASE AND RELATED PARTIES AND PARTIES-IN-INTEREST TRANSACTIONS (CONTINUED)

The Plan pays administrative expenses directly to service providers and employees. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 6. CREDIT RISK

The Plan maintains cash in bank accounts which, at times, may exceed the federally insured limits of \$250,000 per bank. At December 31, 2024 and 2023, the balance of funds held in excess of the federally insured limit was approximately \$352,000 and \$322,000, respectively. The Plan has not experienced any losses, nor does it believe it is exposed to any significant credit risk at this time.

NOTE 7. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.



NOTE 7. FAIR VALUE MEASUREMENTS (CONTINUED)

Certificates of deposit: Certificates of deposit held at Union Bank and Trust through a custodial arrangement are valued based on yields currently available on comparable individual certificates of deposit. Certificates of deposit held at local banks are valued at cost, which approximates fair value.

Money market funds: Valued at cost, which approximates fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8. PENSION CONTRIBUTIONS

The Plan's full-time employees are covered by a defined contribution 401(k) fund. The Plan contributes 10% of salary for full-time employees. Contributions paid by the Plan were \$12,492 and \$12,000 for the years ended December 31, 2024 and 2023, respectively.

The Plan's full-time employees are covered by the defined contribution Local 777 Severance and Retirement Plan. Contributions paid by the Plan were \$2,600 and \$1,872 for the years ended December 31, 2024 and 2023, respectively.



NOTE 9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through August 25, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
