1. Plan Description

The following description of Carr Auto Group 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan was established to provide a retirement savings program for eligible employees of Carr Auto Group, Inc. (the “Company” or “employer”) and certain adopting affiliated entities. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”). The Company is the plan administrator; accordingly, certain members of its management have been appointed to be responsible for overseeing the Plan’s operations including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Eligibility

All employees who have completed six months of consecutive service, with 500 hours of credited service or more, or one year of credited service are eligible to participate in the elective salary deferral portion of the Plan and receive employer matching contributions, if any. Upon satisfaction of the respective eligibility requirements, participants may enter the Plan on the first day of the next calendar quarter.

Contributions

Each year participants may contribute a percentage or fixed amount of their annual compensation, as defined. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. Under the terms of the plan document, the employer is permitted to make discretionary matching or profit sharing contributions to the Plan. For the year ended December 31, 2024, the employer elected to remit a matching contribution in the amount of 50 percent of the first 4 percent of compensation, as defined by the plan document, that each eligible participant contributed to the Plan during 2024. For the year ended December 31, 2023, the employer elected to remit discretionary profit sharing contributions totaling \$300,000 to the Plan. Participants direct the investment of all contributions credited to their accounts into the various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer matching contributions, and allocations of plan earnings and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company contributions portion of participant accounts is based on years of credited service. Participants vest according to a six year graded vesting schedule at the rate of 20 percent per year

after two years of credited service. A participant is 100 percent vested after six years of credited service.

Notes Receivable from Participants

Under certain conditions, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are collateralized by the balance in the respective participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan's administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, resignation, discharge, retirement or proven hardship, a participant is eligible to receive a payment or payments in aggregate amounts up to the total value of the participant's vested interest in his or her account. Hardship withdrawals are permitted from the employee deferrals and fully vested employer contributions portions of participant accounts.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,337 and \$45,568, respectively. These accounts may be used to reduce future employer contributions. For the year ended December 31, 2024, employer contributions were reduced by \$27,337 from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan

repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a corresponding benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to certain participant initiated administration expenses are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

In preparing these financial statements, management has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

3. Certified Investments

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Excluding life insurance contracts maintained by National Life Insurance Company and its affiliates, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified

(contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the Plan's investment custodians for all of the Plan's assets as follows:

- **Pooled separate accounts:** Pooled separate accounts are valued at the unit value as reported by the issuer of the accounts each day the principal market is open. The fair value of investments in this category has been estimated by the investment manager using the net asset value of the underlying investments, which consist primarily of mutual funds, per unit of participation. The unit value of the Plan's investments in pooled separate accounts is not a publicly-quoted price in an active market. There are currently no significant redemption restrictions on these investments.
- **Insurance company general accounts:** Insurance company general account assets consist of investments in guaranteed interest accounts and noninterest-bearing accounts offered and maintained by John Hancock Life Insurance Company. John Hancock Life Insurance Company maintains these assets in an insurance company general account; accordingly, the Plan's ability to receive the amounts due under these unallocated contracts is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Guaranteed interest accounts are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because participants transact at contract value, fair value is determined for financial statement reporting purposes only. The guaranteed interest accounts are not considered to be fully benefit responsive; accordingly, they are presented at fair value in the accompanying financial statements. Noninterest-bearing accounts are valued at the amount payable on demand.
- **Life insurance contracts:** Life insurance contracts are valued using the cash surrender values as reported by the insurance carrier which approximates fair value. The Plan's ability to receive the amounts due under these life insurance contracts is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments are managed by John Hancock Life Insurance Company ("John Hancock") or affiliated entities. John Hancock is the Plan's investment custodian as defined; therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid at the investment fund level rather than by direct payments from the Plan. During the year ended December 31, 2024, the Plan made direct payments to certain

vendors totaling \$126,455 for contract administration and other fees. The plan sponsor pays directly certain other fees related to the Plan's operations.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the employer contributions portion of their accounts.

7. Plan Tax Status

The Plan has adopted a volume submitter agreement as the plan document. The volume submitter agreement obtained its latest opinion letter, dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Delinquent Participant Contributions

As reported on the supplemental schedule of (II) Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, certain employee contributions and loan payments were not remitted to the Plan within the time frame specified by the Department of Labor, therefore constituting nonexempt transactions between the Plan and the Company for the years ended December 31, 2024 and 2023. The related lost earnings remittances on the 2023 delinquent participant contributions were funded to the Plan during the year ended December 31, 2024. The related lost earnings remittances on the 2024 delinquent participant contributions were pending funding as of December 31, 2024.
