Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of **Victor C. Neumann Association Tax Deferred Annuity Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Victor C. Neumann Association Tax Deferred Annuity Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 9 to the financial statements, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Victor C. Neumann Association Tax Deferred Annuity Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Victor C. Neumann Association Tax Deferred Annuity Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter - *Supplemental Schedules Required by ERISA*

The supplemental schedules of assets held for investment purposes at the end of the year – Schedule H, Line 4i and prohibited transactions – Schedule G, Part III, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules.

Victor C. Neumann Association Tax Deferred Annuity Plan Notes to the Financial Statements

1. Description of Plan

The following brief description of the Victor C. Neumann Association Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General – The Plan is a defined contribution 403(b) plan covering all employees of the Victor C. Neumann Association (the Organization). Employees are eligible to participate in the Plan upon completion of one year of service. There is no minimum age requirement. An eligible employee who satisfies the minimum service requirement shall be eligible to participate in the Plan on the first day of the calendar month the participant met the minimum service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – For the year ended December 31, 2024, all participants were retired or separated and, therefore, there were no contributions to the Plan.

Participants' Accounts – Each participant's account is credited with the participant's contribution and receives an allocation of Organization contributions, Plan earnings and administrative expenses and forfeitures. Allocations are based on participant compensation or account balances, as defined. Forfeiture allocations are made evenly among eligible participants. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Association's contribution portion of their accounts is based on years of continuous service. A year of service, for vesting purposes, is defined as a Plan year in which the employee is credited with at least 1,000 hours of service. Vesting in the Association's matching contribution portion of accounts occurs at 25 percent per year after two years of service with full vesting upon five years of service.

Investment Options – Upon enrollment in the Plan, a participant directs their account balance in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment distributions, annuity distributions or a partial distribution less than the entire vested balance.

Victor C. Neumann Association Tax Deferred Annuity Plan
Notes to the Financial Statements (cont'd)

1. **Description of Plan** (cont'd)

Participant Loans – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Total outstanding balance of all notes may not exceed the lesser of \$50,000 or 50% of the participant's vested balance. The maximum loan term is five years, unless it is for the purchase of a principal residence. The loans are secured by the balance in the participant's account, not to exceed 50% thereof at the time any loan is made, and bear interest at a rate commensurate with local prevailing rates charged by commercial lending institutions, as periodically determined by the Plan administrator. Interest rates applicable to all outstanding loans range from 5.25% to 5.50% at December 31, 2024. Principal and interest is paid quarterly.

Effective July 1, 2020, participant loans are not permitted by the Plan. Despite this, two new loans were processed during 2024 totaling \$33,000. These constitute prohibited transactions. Management is working with the third-party administrator to rectify the matter.

Forfeited Accounts – At December 31, 2024 and 2023, there were no forfeited nonvested accounts. The Plan sponsor may decide in its discretion how to treat forfeitures under the Plan.

Plan Termination – Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. **Summary of Significant Accounting Policies**

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value except for fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (cont'd)

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits – Benefits are recorded when paid.

CARES Act – On March 27, 2020, President Trump signed into law the Coronavirus Aid, Relief, and Economic Security Act, (CARES Act). As a result, changes were made related to Plan withdrawals and loans to participants, for impacted participants, their spouse and dependent(s) who have been diagnosed with virus SARS-CoV-2 or with COVID-19, as well as participants that have experienced adverse financial consequences. The changes applicable to the Plan are summarized below:

- Impacted participants may receive up to \$100,000 in aggregate withdrawals before December 31, 2020.
- 10% penalty tax for early withdrawal is waived before December 31, 2020.
- Mandatory 20% withholding on distributions will not apply before December 31, 2020.
- No limit to the number of withdrawals an impacted participant can make before December 31, 2020.
- Repayment of withdrawal amount is permitted if repayment occurs within three years of the distribution for applicable amounts before December 31, 2020.
- Required Minimum Distribution (RMD) rules for distributions required for the 2020 calendar year are temporarily waived.

On August 3, 2022, the IRS issued Notice 2022-33, which extends the deadlines for qualified retirement plans to adopt amendments reflecting certain optional and required changes under the SECURE, CARES, and Miners Acts. Plan sponsors of defined contribution plans generally now have until December 31, 2025, to amend their plans if they took advantage of benefit changes permitted by these laws, including changes allowed by the CARES Act as part of COVID-19 relief.

The Plan will formally adopt an amendment to address these changes at a later date in accordance with applicable law and IRS guidance.

Subsequent Events – Subsequent events have been evaluated through September 17, 2025, which is the date the financial statements were available to be issued.

3. Information Certified and Provided by The Variable Annuity Life Insurance Company

The Organization, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by The Variable Annuity Life Insurance Company (VALIC), the Plan's custodian and furnished to the Organization. The Organization has obtained certifications from the custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Level 1 – Valuations are based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2 – Valuations are based on quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; and model-derived valuations whose significant inputs are observable.

Level 3 – Valuations are based on unobservable inputs for the asset or liability that reflect the reporting entity's own data and assumptions that market participants would use in pricing the asset or liability. These unobservable inputs are significant to the fair value measurement.

4. Fair Value Measurements (cont'd)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There were no investments measured at fair value to be classified in the fair value hierarchy at December 31, 2024 or 2023.

Separate accounts are held with VALIC and are valued at net asset value (NAV) per share, as a practical expedient, or its equivalent of the funds, which are based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

- (1) Fixed Income investments aim to provide preservation of capital and income. Investments typically include government and corporate bonds.
- (2) Global & International Equity investments include non-U.S. markets, while global funds may invest in U.S. stocks.
- (3) Hybrid investments include diversification among two or more asset classes. These funds typically invest in a mix of stocks and bonds.
- (4) Large Cap investments include investments in companies with market capitalization of more than \$10 billion.
- (5) Large Growth investments include investments in stocks of large U.S. companies that are projected to grow faster than other large cap stocks.
- (6) Mid Cap investments include investments in companies with a total market capitalization in the range of \$2 billion to \$10 billion.
- (7) Small Cap investments include investments in companies with a total market capitalization in the range of \$300 million to \$2 billion.
- (8) Specialty investments aim to invest in companies within a specific industry. These industries include real estate, science and technology, derivatives and commodities.

5. Guaranteed Investment Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with VALIC totaling \$857,265 and \$889,972 at December 31, 2024 and 2023, respectively. VALIC maintains contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract is contractually obligated to repay the principal and a specified interest rate that are guaranteed to the Plan.

The contract meets the fully benefit-responsive contract criteria; therefore, it is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

VALIC guarantees the principal and accrued interest, based on credited interest rates, for participant initiated withdrawals as long as the contract remains active. Interest is credited at a fixed rate of interest.

The guaranteed investment contract with VALIC declares a current interest rate at the beginning of each month applicable to contributions received during that month. The current rate declared is guaranteed until the end of that calendar year for contributions received that month. The guaranteed minimum interest rates through this investment contract was 1.00% - 4.50% for the year ended December 31, 2024, varying by participant. VALIC permits transfers of up to 20% per year from this guaranteed investment contract. Additionally, participants may generally withdraw up to 10% of the accumulated account value per contract year without charge. For any amounts in excess of the 10%, the surrender charge is the lesser of (1) 5% of the amount of all purchase payments received during the past 60 months or (2) 5% of the amount withdrawn. There are certain conditions that allow for surrender and/or withdrawal charges to be waived.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by VALIC, the custodian, as defined by the Plan; therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to the custodian were \$4,802 for the year ended December 31, 2024.

Certain employees of the Organization are performing services for the Plan and are not compensated by the Plan. Certain other expenses of the Plan are paid by the Organization.

7. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The Organization adopted a volume submitter plan sponsored by VALIC Retirement Services Company (VALIC). VALIC received an advisory letter from the Internal Revenue Service that the volume submitter 403(b) plan is acceptable under the 403(b) of the Internal Revenue Code for use by eligible employers for the benefit of their employees. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Excluded Contracts

The Plan Administrator has elected to exclude from investments certain annuity and custodial accounts which may have been issued to current and former employees without the Plan Administrator's knowledge prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such potential accounts have also been excluded from the Statement of Changes in Net Assets Available for Benefits. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements. The Plan Administrator is not able to determine the amount of these excluded annuity and custodial accounts and the related income and distributions because records relating to these are not available or do not exist.
