1. Description of Plan

The following brief description of the Humberston Auto Group 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan was established to provide retirement benefits to eligible employees of Beaverton Toyota, Inc. and certain other adopting affiliates (collectively referred to as the “Companies”). Beaverton Toyota, Inc. is the Plan’s sponsor and administrator. A committee appointed by the Companies’ board of directors is responsible for oversight of the Plan, including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 as amended (“ERISA”).

Eligibility

Employees are eligible to participate in the elective deferrals portion of the Plan after they have completed six months of service. Employees are eligible to participate in the employer contributions portion of the Plan after they have attained 18 years of age, completed six months of service, and if they are employed on the last day of the plan year or have completed at least 500 hours of service during the plan year. Plan entry dates are the first day of the quarter following the date all eligibility requirements are satisfied.

Contributions

Each year participants may contribute a portion of their annual compensation to the Plan, as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 4 percent of eligible compensation, escalating by 1 percent per year up to 10 percent, and their contributions are invested in a designated fund until changed by the participant. For the year ended December 31, 2024, the employer made discretionary matching contributions equal to 100 percent of the first 3 percent, plus 50 percent of the next 2 percent, of eligible employee contributions. Participants direct the investment of all contributions credited to their accounts into any of the various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The participant's salary deferral contributions are fully vested at all times and shall not be subject to forfeiture for any reason. The employer's discretionary contributions become vested as follows:

Upon attaining normal retirement age, and certain other conditions as defined by the plan document, a participant becomes fully vested regardless of years of service.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are collateralized by the balance in the participant's account and bear interest at rates determined by the plan administrator at the date of issuance. Principal and interest is paid ratably through monthly payroll deductions. Loans shall be made for a term not to exceed five years unless the loan is for the purchase of the participant's principal residence, in which case the loan term may be up to fifteen years.

Payment of benefits

On termination of service due to any reason, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. If the vested amount in the participant's account is less than \$5,000 at termination, the Plan has the option of distributing the vested account balance. All distributions from the Plan will be made in one lump-sum payment.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,647 and \$21,778, respectively. These accounts may be used to pay administrative expenses or to offset future employer contributions.

2. Summary of Accounting Policies

Basis of accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

- Level 1.** Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2.** Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3.** Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and

2023. Fair values are provided by the investment custodian for all of the Plan’s assets as follows:

- Cash held in both interest-bearing and noninterest-bearing accounts consist of deposits with no stated maturity, including bank savings, money market, and brokerage cash accounts, which are valued at the amount payable on demand.
- Investments in registered investment companies, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the fund. Registered investment company investments held by the Plan are primarily open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) per share and to transact at that price. Exchange-traded funds (“ETF”) are valued at the closing price reported on the active market on which the individual securities are traded. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan’s valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-In-Interest Transactions

Certain investments represent funds held and managed by affiliates of Charles Schwab Trust Bank. Charles Schwab Trust Bank is the Plan's investment custodian, as defined; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment management services are included in net appreciation in the fair value of investments, as they are paid through fees charged at the investment level rather than direct payments by the Plan. During the year ended December 31, 2024, the Plan made direct payments totaling \$45,388 for a portion of the Plan's investment advisory and administrative expenses. The plan sponsor pays directly certain other fees related to the Plan's operations.

6. Plan Termination

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, participants would become 100 percent vested in the employer contributions portions of their accounts.

7. Tax Status

The Plan has adopted a volume submitter agreement as the plan document. The volume submitter agreement obtained its latest opinion letter, dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
