For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the D&M Contracting, Inc. Davis Bacon 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of D & M Contracting, Inc. (D&M), Castelli Development Corporation, and, effective January 1, 2020, Castelli Construction LLC (collectively, the Company). The Plan is administered by D&M and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). D&M is the Plan Sponsor. The Investment Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Employees of the Company are eligible to participate in the deferral component of the Plan on the later of their date of employment or upon turning 18 years of age. The Plan also provides for a Davis Bacon Prevailing Wage contribution feature for employees who have performed services during the plan year as a Prevailing Wage Employee under Prevailing Wage Law. The Company may also choose to make nonelective and qualified nonelective contributions to the Plan at its sole discretion.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may make nonelective contributions, qualified nonelective contributions, and Safe Harbor 401(k) Contributions based on the provisions of the Plan. The Company's safe harbor match contribution was 100% of the first 3% of eligible compensation deferred and 50% of the eligible compensation deferred in excess of 3% limited to 5%. In January 2023, the plan was amended to remove the safe harbor matching contribution from the plan provisions effective March 7, 2023. Qualified nonelective contributions are nonelective contributions which are used to satisfy the requirements of the ADP or ACP testing to which the Plan is subject.

The Company also makes Prevailing Wage contributions to the Plan for services performed during the Plan year under Prevailing Wage Law. The contribution for each employee considered a Prevailing Wage Employee is based on the hourly contribution rate required under the applicable Prevailing Wage Law for the respective employee's classification on each corresponding contract at which Prevailing Wage Law services are being performed. The Company elected to contribute 20% of the total hourly rate of each employee's Prevailing Wage rate for each of the years ended December 31, 2024 and 2023.

**Contributions (Continued)**

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. Nonelective contributions are allocated based on specific allocation groups which identify different classes of employees, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their employee contributions, employer safe harbor contributions, qualified nonelective contributions and prevailing wage contributions plus actual earnings thereon. Vesting in the Company nonelective contributions portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested in accrued benefits after six years of credited service with a vesting schedule of 20% per year beginning after the second year of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate the commercial U.S. bank's prime lending rate plus 2%. Principal and interest is paid ratably through payroll deductions. Participants are not permitted to have more than one loan outstanding.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 62 subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name through December 31, 2023.

**Benefit Payments (Continued)**

Effective January 1, 2024, the Plan adopted the optional provision under Section 304 of the SECURE 2.0 Act of 2022 to increase the involuntary cash-out threshold from \$5,000 to \$7,000. As a result, vested account balances exceeding \$1,000 but not more than \$7,000 for terminated participants may be automatically rolled over to an individual retirement account (IRA) designated by the Plan, unless the participant elects otherwise. Vested balances of \$1,000 or less may be distributed directly to the participant. This amendment is intended to reduce administrative burden and improve plan efficiency by minimizing the number of small inactive accounts maintained by the Plan.

**Forfeited Accounts**

Forfeited nonvested accounts are first used to reduce administrative expenses and then are used to reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$201 and \$206, respectively. Forfeitures used to pay administrative expenses totaled \$924 and \$899 for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures used to reduce Company contributions for either of the years ended December 31, 2024 or 2023.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable is recorded as distributions on the basis of the terms of the plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction to contributions. The Plan distributed the 2024 and 2023 excess contributions payable during 2025 and 2024, respectively.

**Administrative Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investment presented in the accompanying statements of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Ascensus, LLC, the agent for Ascensus Trust Company, the trustee of the Plan, has supplied the plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Money Market Mutual Fund and Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contribution.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter dated July 13, 2021, received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 7 PLAN TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Ascensus Trust Company is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9 PLAN AMENDMENT**

Effective April 2020, certain provisions under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) relating to participant distributions and participant loans were enacted. The CARES Act allows for utilization of these provisions immediately, but requires formal adoption of the amendment no later than the last day of the plan year beginning on or after January 1, 2025. As of September 10, 2025, the Plan has not formally been amended to adopt these provisions.
