## 1. Description of Plan

The following description of the Davis/Burkett Food Corp. (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General.* The Plan became effective as of January 1, 1997. The Plan is a defined contribution plan covering all employees of Davis/Burkett Food Corp. (the “Company”) except employees governed by a collective bargaining agreement, non-resident aliens who do not receive any earned income from the Company, or any person considered a leased employee. Employees who have completed one month of service and have attained age 21 are eligible to make contributions to the Plan and can begin contributing to the Plan on the first day of the month after satisfying the requirements. Employees who have worked for the Company for at least one year, have accumulated one thousand hours of service and are age twenty-one or older are eligible to receive matching contributions, which begin on the first day of January or July after obtaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Plan Management is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

*Contributions.* Participation in the Plan is voluntary. Each year, participants may make contributions to the Plan up to a maximum of Internal Revenue Service limits. Participants also may contribute amounts representing distributions from other qualified benefit plans, subject to certain restrictions. The Company may contribute a discretionary matching amount that is determined at the end of each year. Additional amounts called non-elective contributions may be contributed at the option of the Employer. During the year ended December 31, 2024, the Company declared matching contributions of \$117,565 and plans to use forfeitures of \$74,000 to partially fund the match. This net amount (\$43,565) was remitted to the Plan in 2025 and is shown as a receivable on the accompanying financial statements.

*Participant Accounts.* Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting.* Participants are fully vested at all times in their contributions, the non-elective contributions and participant earnings, if any. Vesting in the Company’s portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.

## 1. Description of Plan (continued)

*Payment of Benefits.* In accordance with the Plan document and as allowed under the Internal Revenue Code, a lump-sum distribution of a participant's vested account is available upon termination of service, death, disability, retirement, or attainment of age 59½; or distribution is available to satisfy a financial hardship meeting the requirements of the IRS regulations.

For the Plan year ended December 31, 2024, the Plan reported \$565,508 of plan assets that were allocated to participants who had withdrawn from the Plan, but have not yet been distributed.

*Forfeited Accounts.* At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$74,553 and \$21,154 respectively. These accounts will be used to reduce future fees incurred by the plan. In 2024, \$74,000 of forfeited non-vested accounts were used to offset matching contributions receivable.

## 2. Summary of Accounting Policies

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Payment of Benefits*

Benefits are recorded when paid.

## 2. Summary of Accounting Policies (continued)

### *Operating Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### *Subsequent Events*

For the year ended December 31, 2024, the Plan has evaluated subsequent events for the potential recognition and disclosure through September 1, 2025, the date of financial statement issuance.

## 3. Information Certified by the Plan's Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, USA, the Plan's custodian.

## 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at fair value based on quoted redemption values on the last business day of the Plan year.

*Guaranteed interest accounts:* Valued at the net asset value of shares held by the plan at year end.

*Non-interest bearing cash:* Valued at the net asset value of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Investment Contract with Insurance Company

Contributions to the Plan's funds can be allocated to guaranteed interest accounts, which are not, by definition, an investment contract, but rather are an investment option offered under the John Hancock group annuity contract. Such contributions are held in the John Hancock USA general account. Guaranteed accounts guarantee the return of principal plus compound interest earned over a defined 3-, 5-, or 10-year term, less any applicable contract or participant-level recordkeeping charges, provided all contributions remain in the account until the end of the guarantee period.

Interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed account in that month. This is called the new money regular rate. For other types of contributions, interest rates may differ and may change during the month. The average annual new money rates for the years 2024 and 2023 are as follows:

## 5. Investment Contract with Insurance Company (continued)

At the end of each reporting year, a composite rate of interest is determined for each participant account, depending on the amount contributed and the rate in effect on the day it is allocated under the participant account. The composite rate is the effective annual rate earned by all contributions to that guaranteed account during the respective reporting year for that participant. Contributions continue to earn the calculated composite interest rate for the duration of the guarantee term. The average composite rates for the years 2024 and 2023, are as follows:

## 6. Party-in-Interest Transactions

Certain plan investments are shares of funds managed by John Hancock USA, the Plan custodian, and therefore, these transactions qualify as party-in-interest transactions. Any purchases and sales of these funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

## 8. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Plan is qualified, and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Company and Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

**8. Tax Status (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor (“DOL”). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
