#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Westdale Asset Management, Ltd. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

---

### Note 1 – Description of the Plan

The following description of the Westdale Asset Management, Ltd. 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

**General** – The Plan, established on January 1, 2000, is a defined contribution plan covering employees of Westdale Asset Management, Ltd. (the Sponsor). Effective January 1, 2009, the Plan adopted a non-standardized form of a prototype plan sponsored by Fidelity Management Trust Company (the Trustee). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility** – Employees of the Sponsor are eligible to participate in the Plan upon reaching age 18 and after completing 11 months of service with no minimum work hours required.

### Contributions

*Participant contributions* – Participants may make contributions to the Plan up to the lesser of 75% of compensation, as defined by the Plan agreement, or the maximum amount allowed by the statutes.

*Employer match and profit sharing contributions* – The Sponsor may elect to make discretionary matching and profit sharing contributions to the Plan. The Sponsor currently matches 50% of participant contributions up to a maximum of 3% of a participant's compensation. There were no profit sharing contributions for the year ended December 31, 2024.

**Participant accounts** – Each participant's account is credited with the participant's contribution and an allocation of (a) the Sponsor's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

**Vesting** – Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service. Participants vest in the Sponsor's contributions based on the following schedule:

**Notes receivable from participants** – Participants are permitted by the Plan to borrow funds up to 50% of their vested account balance or \$50,000, whichever is less. No notes are issued for less than \$1,000. Note transactions are treated as a transfer from the investment fund to the participant notes fund. Note terms range from one to five years, unless it is for the purchase of the participant's principal residence in which case the note repayment period may not extend beyond ten years from the date of the note. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid through payroll deductions under a level amortization schedule. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50% with various maturities through December 2029.

**Payment of benefits** – Distributions are made for separation in service upon retirement, death, disability, or termination of employment. Participants who have not separated from service and have reached age 59½ can request distributions subject to certain restrictions. All distributions are made in lump sum amounts and recorded when paid.

**Participant hardship withdrawals** – Under certain conditions of financial hardship, a participant may withdraw all or any portion of the voluntary account values during employment. Financial hardship expenses include deductible medical expenses, funds to purchase a principal residence, tuition, and related post-secondary educational expenses for the participant, spouse, or dependents and funds to prevent eviction or mortgage foreclosure on a participant's principal residence. Amounts withdrawn for the purpose of meeting financial hardship may not be repaid to the Plan.

**Forfeited accounts** – At December 31, 2024, forfeited non-vested accounts totaled approximately \$12,230. These accounts may be used to pay Plan expenses and reduce future employer contributions. In 2024, \$31,477 of forfeitures were used to reduce employer contributions.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Excess contributions payable** – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions payable at December 31, 2024 and 2023 to the applicable participants prior to March 15, 2025 and 2024, respectively.

**Investment valuation** – Investments are reported at fair value. The Plan's Trustee, Fidelity Management Trust Company, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance, plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Payment of benefits** – Benefits are recorded when paid.

**Subsequent events** – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

The Plan administrator has evaluated subsequent events, through August 28, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Information Certified by the Trustee**

The Plan's administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of the following:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. During 2024, the Plan added investment options in collective trusts. There have been no other changes in the techniques used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective trusts* – Units held in collective trusts (CTs) are valued using the NAV practical expedient of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. ### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

#### **Note 7 – Party-In-Interest Transactions**

Certain Plan investments are managed by the Trustee of the Plan. However, transactions with the Trustee qualify as exempt party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. In addition, during the year ended December 31, 2024, the Sponsor paid audit and certain administrative custodial fees on behalf of the Plan.

#### **Note 8 – Tax Status**

The Plan agreement is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
