## Independent Auditors' Report

To the Administrative Committee of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Medical City Dallas Management, Ltd. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matters - Supplemental Schedule Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## 1. Description of Plan

The following description of Medical City Dallas Management, Ltd. (the “Company”) 401(k) Profit Sharing Plan 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

### **General**

The Plan is a defined contribution plan available to all employees of the Company from the first day of employment. The Plan was formed on January 1, 1980 is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is defined by Section 401(k) of the Internal Revenue Code.

### **Eligibility**

All employees, including part-time, seasonal or temporary employees, are eligible from the first day of employment for entry into the Plan and may make salary deferrals and receive employer matching contributions upon entry. To be eligible for employer profit sharing contributions, employees must have completed 12 months of service and worked 1,000 hours during the plan year. Additionally, the Plan provides automatic enrollment with 7% contribution rate unless eligible participants opt out. All investments are participant-directed.

### **Employee Salary Reduction Election**

A participant may elect to defer up to eighty-five percent (85%) of his or her compensation each year instead of receiving that amount in cash. However, total deferred compensation may not exceed the limits set by Internal Revenue Code (“IRC”) Sections 401(k), 404, and 415. In addition, participants who are age fifty (50) or over before the close of the plan year are eligible to make catch-up contributions subject to the limitation imposed by the IRC.

### **Contributions**

#### *Elective Contributions*

The Company must contribute the amount of the total employee salary reduction elections of all participants made during the plan year. The Company must pay elective contributions to the Plan’s trustee as soon as they can be segregated from its general assets, but no later than the fifteenth (15<sup>th</sup>) business day after the month of receipt of the voluntary contribution.

#### *Employer Matching Contributions*

The Company makes an employer matching contribution in an amount equal to one hundred percent (100%) of the participant’s deferred compensation not in excess of seven percent (7%) of the participant’s deferred compensation. This matching contribution follows a six-year grading schedule.

**Contributions (continued)**

*Employer Profit Sharing Contributions*

The Company may make a discretionary profit sharing contribution in an amount to be determined by the Company. This profit sharing contribution follows a six-year vesting schedule.

*Rollover Contributions*

The Plan may accept a rollover contribution on behalf of all participants as well as any employee, regardless whether such employee has met the age and service requirements of the Plan.

*Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are immediately fully vested in their elective contributions plus actual earnings thereon. Vesting in the employer contributions portion of their accounts plus earnings thereon is based on years of continuous services. The vesting for the Company account is as follows:

*Forfeited Accounts*

At December 31, 2024 and 2023, there were \$35,752 and \$43,317 available, respectively. During 2024, amounts totaling \$35,952 were forfeited and \$35,752 in forfeitures were applied to employer profit sharing contributions and employer matching contributions.

**Distribution of Benefits**

*Upon Retirement*

Distributions may be made to a participant who has not separated from service when he or she attains age fifty-nine and one-half (59 ½). Payment may be in the form of a lump-sum distribution or partial withdraw.

*Upon Termination of Employment*

A participant may elect to have his or her account balance distributed as soon as administratively feasible following termination of employment. If the value of the vested account balance does not exceed \$1,000, then a distribution will be made in cash. However, if the value of the vested account balance is more than \$1,000 but less than \$7,000, he or she may elect to receive distribution in cash or to roll over to an IRA or a qualified plan of his or her new employer.

*Hardship Distributions*

A participant may withdraw pre-tax deferrals, including any earnings, in the event of a financial hardship, provided certain conditions are met. The minimum withdrawal amount is \$1,000. Hardship distributions can only be made from the elective deferral and rollover contribution accounts.

*Upon Disability*

A participant's account is distributable upon a participant's disability. Payment may be in the form of a lump-sum distribution or partial withdrawal.

*Upon Death*

Upon the death of a participant, a distribution of the vested account balance be made to his or her designated beneficiary in a single lump-sum payment.

**Administrative Fees**

Distribution and loan fees are charged directly to the requesting participant's account. The Company absorbs the majority of all other administrative fees of the Plan. If expenses paid by the Plan are allocated to participants, expenses are either proportionately based on the value of the account balances or as an equal dollar amount based on the number of the participants in the Plan.

**Investment Options**

Upon enrollment in the Plan, a participant may direct all of his or her accounts to a variety of investments. Participant's accounts are segregated for purpose of determining the earnings or losses on their investment options.

**Notes Receivable from Participants**

Participants may borrow from his or her account with a maximum loan amount not to exceed the lesser of (a) \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one-year period or (b) one-half ( $\frac{1}{2}$ ) of a participant's vested account balance. A participant may only have one (1) loan outstanding at any time and will not be granted an amount less than \$1,000. Principal and interest are repaid by payroll deductions from each regular paycheck. Loans are secured by the balance in the participant's account and bear an interest rate currently being charged on similar commercial loans by persons in the business of lending money.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value with the exception of Guaranteed Investment Contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements. The Plan's fully benefit-responsive investment contract (see Note 5) is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### Benefit Payments

Benefits are recorded when paid.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Pooled Separate Accounts*

Pooled separate accounts ("PSA") invests mainly in domestic stocks or mutual funds. The majority of the underlying securities have observable level 1 quoted pricing inputs. The net asset value ("NAV") of the pooled separate account is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date.

**4. Information Prepared and Certified by Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company ("Nationwide"), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024.
- Investment information included in the accompanying Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**5. Investment Contracts**

This guaranteed investment contract (GIC) is considered a fully benefit-responsive investment contract (FBRIC) and should be reflected at contract value within net assets available for benefits (see ASC 962-10, "Plan Accounting - Defined Contribution Pension Plans" on what defines a FBRIC). ASU 2015-12 states that FBRICs should be measured, presented, and disclosed only at contract value and fair value information is not required. All GICs that are deemed benefit-responsive investment contracts should no longer be included in ASC 820 fair value disclosures. Investment contract balances at December 31, 2024 and 2023 were \$4,642,870 and \$7,022,558, respectively.

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company ("Nationwide"). Nationwide maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rates ranging from 1.81% to 2.17% for 2024, and 2.07% to 2.17% for 2023, respectively. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**6. Related-Party Transactions and Party in Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$59,718 to Nationwide Investment Advisors, LLC for advisory fees, \$6,800 to CecilCo 401(k) Managed Solutions for third-party plan administration fees and \$12,917 to Nationwide Retirement Solutions for recordkeeping fees, during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Company and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
