**Note 1 - Description of Plan**

The following description of Marathon Coach, Inc. Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established by Marathon Coach, Inc. (the Plan Sponsor and Company) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Company and any participating affiliates are subject to the following eligibility requirements (See Note 9):

- Age: 18
- Service: Six consecutive months and 500 hours
- Status Exclusions: Driver employees

Upon satisfying the eligibility requirements, employees may participate in the Plan on the first day of the plan year or the first day of the 7th month of the plan year.

**Contributions**

The Plan is funded through employee elective deferrals and company contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants may be permitted to deposit or "rollover" into the plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The following contribution types are allowed by the Plan:

- Rollover contributions
- Employer profit sharing
- Employer matching
- Elective deferrals

The Company may make discretionary profit-sharing contributions which will be allocated in accordance with the plan document provisions. Participants will always share in the profit-sharing contribution regardless of the amount of service completed during the plan year.

The Company may make a rigid discretionary matching contribution equal to a percentage of salary deferrals. Participants will always share in the rigid discretionary matching contribution regardless of the amount of service completed during the plan year.

The Company makes a matching contribution up to \$25 for each payroll period and no more than \$600 per year.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, allocation of the Company's contributions, and plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. The method for crediting vesting service for company matching and profit-sharing contributions is based on vesting periods of service. Participants are credited with a period of service for 1,000 hours earned. If participants are employed on or after their Early or Normal Retirement Age or if they terminate employment on account of death or disability, they are 100% vested in their company matching and profit-sharing contributions.

**Forfeited Accounts**

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested company contributions to be used as follows:

- Pay administrative expenses

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,711 and \$2,654, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$2,654 were used to pay administrative expenses.

**Investment Options**

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

**Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 (reduced by certain participant notes outstanding at the time the new note is taken or anytime within the 12 months prior to the date of the new note) or 50% of their vested account balance. The loans, in the form of promissory notes, are secured by the balance in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions and generally repaid within 5 years.

**Benefits Paid to Participants**

Upon termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary.

The following types of distributions are also allowed by the Plan:

- In service
- Involuntary cash-outs
- Termination withdrawal
- Death

**Plan Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

**Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Company will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for any fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a framework for measuring fair value. GAAP also allows for a practice expedient whereby the net asset value (NAV) of investment units owned by the Plan, which meet certain conditions, is used as a substitute for fair value. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation of pooled separate accounts (PSAs), is presented in the statement of changes in net assets available for benefits.

**Contributions**

Contributions from plan participants, and related employer matching contributions, are recorded in the year in which the participant contributions are withheld from compensation. Other contributions from the employer are recorded in the year to which they are allocated in accordance with IRC provisions.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid. There were no amounts allocated to persons who have elected to withdraw from the Plan but have not been paid as of December 31, 2024.

**Subsequent Events**

Subsequent events were evaluated through September 8, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Annuity Contract with Insurance Company**

The plan investments are held in an annuity contract issued by John Hancock Life Insurance Company (U.S.A.) (John Hancock). The annuity contract includes various PSAs and is reported at fair value.

Participants electing to invest in the stable value fund PSA can generally transact in the fund at NAV on a daily basis. A participant may be subject to restrictions on payments or transfers out of the fund for withdrawals that are plan-directed. In the event the Plan or Plan Sponsor cause a withdrawal from a participant's account, the trustee of the trust fund underlying the PSA has the option to delay payment for up to 12 months. If the trustee of the fund exercises this option, a contract holder may elect to receive payment without such delay but may be subject to the application of a market value adjustment factor. The amount paid is then the number of units surrendered times the unit value on the withdrawal date, minus the market value adjustment. The Plan Administrator does not believe that the occurrence of any such event, which would cause a withdrawal to be transacted at other than NAV, is probable.

At the beginning of each month, John Hancock announces an interest rate that applies to all money in the stable value fund PSA during that month. During periods of high market volatility, the rate may be reset more frequently.

There are no reserves against the fair value of the annuity contract for credit risk of the contract issuer or otherwise.

The Plan Sponsor can discontinue contributions to the contract at any time by giving written notice to John Hancock. John Hancock may deem a discontinuance to occur and terminate the contract based on factors outlined in the contract, primarily dealing with plan disqualification, sponsor's bankruptcy or other discontinuance of business, lack of participation, or insufficient assets in the Plan.

**Note 4 - Certified Investments**

**Note 5 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan's only investments recorded at fair value are investments in PSAs. Units held in PSAs are valued using the NAV practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, divided by the number of units outstanding. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information. These investments are redeemable daily at NAV by participants and have no commitment provisions.

In accordance with GAAP, all investments valued using the NAV practical expedient have not been classified in the fair value hierarchy.

The fair valuation methodology used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial investments could result in a different fair value measurement at the reporting date.

The following sets forth the significant investment strategies of significant PSAs as of December 31, 2024:

- *John Hancock 500 Index Fund* - Seeks to achieve the approximate aggregate total return of a broad U.S. domestic equity market index.
- *John Hancock Multimanager Aggressive Lifestyle Portfolio* - Seeks to achieve long-term growth of capital by investing 100% of the portfolio's assets in underlying portfolios that invest primarily in equity securities.
- *John Hancock Multimanager Balanced Lifestyle Portfolio* - Seeks to achieve a balance between a high level of current income and growth of capital, with a greater emphasis on growth of capital, by investing approximately 40% of the portfolio's assets in underlying portfolios that invest primarily in fixed-income securities and approximately 60% of its assets in underlying portfolios that invest primarily in equity securities.
- *John Hancock Multimanager Growth Lifestyle Portfolio* - Seeks long-term growth of capital by investing approximately 80% of the portfolio's assets in underlying portfolios that invest primarily in equity securities and approximately 20% of its assets in portfolios that invest primarily in fixed-income securities. Current income is also a consideration.
- *John Hancock Multimanager Moderate Lifestyle Portfolio* - Seeks to achieve a balance between a high level of current income and growth of capital, with a greater emphasis on income by investing approximately 60% of the portfolio's assets in underlying portfolios that invest primarily in fixed-income securities and 40% of its assets in portfolios that invest primarily in equity securities.
- *John Hancock Stable Value Fund* - Seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long-term.

**Note 6 - Related Party Transactions and Transactions with Parties-in-Interest**

A related party is any party who can control or significantly influence plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$54,584 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 - Tax Status**

The Plan Sponsor adopted a plan which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

**Note 9 - Subsequent Events**

Subsequent to year-end the Plan was amended to remove the service hour requirements to become eligible to participate in the plan. Beginning July 1, 2025, the new eligibility requirements will be the following:

- Age: 18
- Service: Six consecutive months
- Status Exclusions: Driver employees

Upon satisfying the eligibility requirements, employees may participate in the Plan on the first day of the plan year or the first day of the 7th month of the plan year.

Subsequent to year-end the Plan was amended to include the option to defer into a Roth 401(k). Participants were able to elect this option beginning on July 1, 2025.
