## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

**Other Matter**

*Supplemental Schedule Required by ERISA*

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **1. DESCRIPTION OF THE PLAN**

The following description of the DSS Sustainable Solutions USA, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan established on September 1, 2019, for which contributions are made by DSS Sustainable Solutions USA, Inc. (the Company or Employer or Plan Sponsor) and its participating employees. The Plan covers substantially all full-time employees of the Company who have completed two months of service, except for nonresident aliens, those subject to collective bargaining agreements, independent contractors, interns, co-ops or leased employees, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments.

### **Plan Administration**

The Plan is administered by the Company which, as Plan administrator, has substantial control of and discretion over the administration of the Plan. Ascensus Trust Company is the Trustee of the Plan, and Ascensus Inc. is the recordkeeper.

### **Eligibility**

The Plan covers all full-time employees of the Company who have completed two months of Service. Effective January 1, 2023, the Company acquired KKS Advisors, LLC (KKS) and the Plan was subsequently amended to adopt KKS as a participating employer. Participants of the KKS Plan were permitted to contribute to the Plan in January 2023.

Effective October 1, 2024, the ADS System Safety Consulting Plan (ADS) was merged into the Plan and the Plan was subsequently amended to adopt ADS as a participating employer. This merger is reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024. Participants of the ADS Plan were permitted to contribute to the Plan in October 2024.

### **Contributions**

Each year participants may contribute from 1% to 100% of pretax or after-tax annual compensation, as defined in the Plan document. Employees may also transfer amounts representing distributions from other qualified plans. Contributions are subject to certain limitations, as defined in the Plan and the Internal Revenue Code (IRC). A participant may change their contribution percentage daily. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their initial deferral rate set at 6% of eligible compensation.

The Company may contribute a matching contribution equal to a discretionary percentage, to be determined by the Employer, of the participant's salary deferral. For the year ended December 31, 2024, the matching percentage was set at 100% of the participants' deferrals up to 6% of compensation. The Company may also make a discretionary profit-sharing contribution each

year, to be determined by the Employer. For the year ended December 31, 2024, the Company made a profit-sharing contribution of approximately \$590,000.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of: (1) the Company's discretionary contributions, and (2) investment earnings (losses), including net appreciation and depreciation in fair value of investments; and charged with participant distributions and an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Notes must be repaid within five years. If the note is made for the purchase of a participant's residence, the note may be repaid over a reasonable period of time longer than five years, up to thirty years. Principal and interest is paid ratably through monthly payroll deductions.

**Vesting**

Participants are immediately vested in their contributions and Employer-matching contribution plus actual earnings thereon. Vesting in Employer profit-sharing contributions is based on years of service. A participant must have at least 1,000 hours of service during a Plan year to earn a year of service and 500 hours of service must be met or exceeded to avoid a break in vesting service. Participants are fully vested in the Employer profit-sharing contributions after three years of service.

Less than three years upon enrollment in the Plan, a participant may direct employee and Plan Sponsor contributions in any of the investment options offered by the Plan.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant or their beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants that have reached the minimum required distribution age, based upon IRC limitations, may be required to take certain minimum distributions, which are paid in annual installments, and which shall not extend beyond the participant's life expectancy. Participants may also withdraw all or any part of their vested account balance after having attained age 59½, incurred a disability, or incurred a hardship in accordance with the Plan document.

**Forfeitures**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$49,771 and \$8,862, respectively. Per the Plan document, these amounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the year ended December 31, 2024, \$6,880 of forfeited nonvested accounts were used to pay Plan expenses.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Risks and Uncertainties**

The Plan's investments include funds which invest in various types of investment securities and companies within various markets. Investment securities are exposed to several risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the Plan's accompanying financial statements and supplemental schedule.

### **Investment Valuation and Income Recognition**

Investments in the Plan are reported at fair value. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. The Plan's Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recognized when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

### **Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Subsequent Events**

Management has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued, and has determined that there are no additional subsequent events that require disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 855, *Subsequent Events*.

**3. INFORMATION CERTIFIED BY PLAN TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to, or derived from information certified as complete and accurate by the Trustee.

**4. FAIR VALUE MEASUREMENTS**

GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value:

- Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.
- Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.
- Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following are descriptions of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy, at December 31, 2024 and 2023:

*Mutual funds:* These public investment vehicles are valued using the net asset value (NAV) provided by the Plan administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is classified within Level 1 of the valuation hierarchy based on the underlying assets of the account, which are traded on an active market.

*Money market fund:* This investment is an investment vehicle valued using the NAV provided by the administrator of the fund. The underlying assets are generally comprised of short-term securities representing high quality, liquid debt, and monetary assets. The Trustee establishes the market and quotes the price, on a daily basis, that is available to market participants, which is a market approach to valuation.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

**5. PARTY-IN-INTEREST TRANSACTIONS**

There are investments held by an affiliate of the Trustee of the Plan, as such these investments and investment-related transactions are party-in-interest transactions. Certain administrative expenses are paid to the investment advisor and recordkeeper of the Plan. These transactions qualify as party-in-interest transactions. These administrative expenses are reflected as administrative fees within the statement of changes in net assets for the year ended December 31, 2024. Notes receivable from participants qualify as party-in-interest transactions.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

**7. TAX STATUS**

The Plan Sponsor adopted a prototype non-standardized profit-sharing plan which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the prototype plan has been amended since receiving the opinion letter. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC; therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of the date of the financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, including the IRS. There are no audits pending.
