### **Basis for Opinion**

### 1. Description of Plan

The following description of Pomeroy Recreation and Rehabilitation Center 403(b) Plan (“the Plan”) provides only general information. Participants should refer to the Plan’s documents for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering all eligible employees of Pomeroy Recreation and Rehabilitation Center (“PRRC”) as defined in the Plan’s provisions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### Contributions

Employees are eligible to make elective deferral contributions when an employee is expected to work 1,000 hours or more for the first 12 months of employment or has worked more than 1,000 hours of service in a 12 month period. Employees are eligible to receive a matching contribution when an employee meets age twenty-one (21) and complete one (1) year of eligibility service during which the employee completes one thousand (1,000) hours of service.

Participants may contribute a percentage or fixed amount of their annual compensation, as defined in the Plan, up to the maximum limit as permitted by the Internal Revenue Code. In addition, participants qualifying for age-based provisions may contribute additional catch-up deferrals.

The Plan may accept a rollover contribution made on behalf of any eligible employee. Participants may contribute amounts representing distributions from other eligible retirement plans.

PRRC may in its sole discretion make a matching and profit-sharing contribution in an amount determined by PRRC. For the year ended December 31, 2024, the Board of Directors elected to make employer’s contribution to the Plan.

#### Participant Accounts

Each participant’s account is credited with his or her contributions, an allocation of PRRC’s contribution and the Plan’s earnings. Each participant is able to direct the investments in their account into a variety of investment choices established by PRRC. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Participants may borrow from their participant 403(b) vested account. Loan repayments are made through payroll deductions.

### 1. Description of Plan, continued

#### **Vesting**

Participants are fully vested in their contribution. Participants are vested in the matching contribution and non-elective contribution will be vested as specified below:

- Less than one year of vesting service of 0%
- One year but less than two years of vesting service of 20%
- Two years but less than three years of vesting service of 40%
- Three years but less than four years of vesting services of 60%
- Four years but less than five years of vesting service of 80%
- Five or more years of vesting service of 100%

#### **Payments of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or they may leave the money in the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered by the trustee. Participants may change their investment options at any time.

#### **Notes Receivable from Participants**

Participants may borrow up to 50% from their vested account balance to a maximum loan of \$50,000. The minimum loan is \$1,000. The maximum loan term is five years unless used for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest as defined by the Plan.

### 2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

#### **Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

#### **Payments of Benefits**

Benefits are recorded when paid.

#### **Fair Value Measurements**

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

**2. Risks and Uncertainties, continued**

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

**Subsequent Events**

Management has evaluated subsequent events through September 17, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

**3. Information Prepared and Certified by the Trustee**

No auditing procedures were performed on the following investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The following summarizes the information certified by American Trust Company, the trustee of the Plan, as of December 31, 2024 and 2023, respectively:

**5. Notes Receivable from Participants**

Notes receivable from participants are repaid bi-weekly at varying interest rates. Notes receivable from participants at December 31, 2024 and 2023 were \$13,065 and \$8,027, respectively.

**6. Related Party and Party-in-Interest Transactions**

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$8,533.

The Plan's investment options include funds managed by American Trust Company or its affiliates. As custodian and recordkeeper, American Trust Company's transactions qualify as exempt parties-in-interest transactions.

**7. Plan Termination**

Although it has not expressed any intent to do so, PRRC has the right under the Plan to suspend or discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested in their total account balances.

**8. Tax Status**

The Plan is designed to operate as a standardized plan based on a favorable opinion letter issued to the prototype PRRC that provides tax-exempt status under appropriate sections of the Internal Revenue Code. PRRC believes that the Plan continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
