NOTE 1 - Description of the Plan

The following description of Wits Solutions Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

The Plan and Trust were established December 1st, 2019 to provide health and other benefits to eligible participants. The sponsoring employer, Wits Solutions Inc. has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides medical, dental, vision, prescription drug coverage, short-term disability benefits, life and accidental death and dismemberment, and supplemental accident benefits for eligible participants and their dependents. The Plan provides most of these benefits through contracts with third party insurance companies' contracts and on a self-funded basis.

Eligible employees will receive an allocation to a separate retirement plan for the remainder of fringe in excess of: \$4.57 for class levels I to III, \$4.48 for class IV base medical plan, and \$4.57 for class IV buy-up medical plan in 2024. Eligible employees will receive an allocation to a separate retirement plan for the remainder of fringe in excess of: \$4.23 for class levels I to III, \$3.92 for class IV base medical plan, and \$4.23 for class IV buy-up medical plan in 2024. These retirement contributions are reported as contribution income and then deducted as an expense.

Eligible employees received an allocation to a separate health savings account in 2024 and 2023. These health savings account contributions are reported as contribution income and then deducted as an expense.

Eligibility rules under the Plan differ based on sites. Benefits terminate on the last day of the month in which a participant's employment terminates.

NOTE 2 - Summary of Significant Accounting Policies

Accounting Method

The accounts of the Plan are maintained on an accrual basis of accounting for financial reporting purposes.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Benefit Claims Payable

The obligation for benefit claims payable is an estimate for self-funded benefits incurred on or prior to December 31, but paid after December 31. The estimate was calculated based on a review of actual claims paid subsequent to year-end, with incurred and received dates of December 31, and prior.

Employer Contributions

Employer contributions are recognized as income in the month the employees worked.

Benefits

Benefits expense is recorded when paid. Hours worked through December provide participants with benefits eligibility through December. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases.

Flexible Spending Account

Eligible participants can elect voluntary health care flexible spending account with a minimum annual election of \$100 to a maximum annual election of \$3,200 and \$3,050 for 2024 and 2023, respectively; or voluntary dependent care flexible spending account with a minimum annual election of \$100 to a maximum annual election of \$5,000 and \$2,500, for single or married filing joint, and for married filing separate, respectively. Eligible participants can elect a maximum of \$315 and \$300 monthly pre-tax contribution for commuter benefit and parking benefit separately for 2024 and 2023, respectively.

Subsequent Events

In preparing the financial statements as of December 31, 2024, management considered the impact of subsequent events occurring through September 22, 2025 the date the financial statements were available to be issued, for potential recognition or disclosure in these financial statements.

NOTE 3 - Party-In-Interest Transactions

FCE Benefit Administrators, Inc. receives commissions and reimbursement of administrative fees from the Plan's insurance carriers of approximately \$2,376 and \$2,995 for December 31, 2024 and 2023, respectively. The insurance commissions and fees are paid by the insurance company and are not an expense of the Plan.

NOTE 4 - Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustee believes that the Trust does not have any net taxable income for the tax years ended December 31, 2024 and 2023 and, therefore, no tax liability is reflected in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - Negative Net Assets

At December 31, 2024, the Plan's net assets available for benefits reflected a deficit of \$13,399. This deficit is primarily attributable to the Plan's increase in benefit expenses. In response, Management presented several cost-neutral plan options that were subsequently approved and implemented for 2025. Based on the first quarter 2025 financials, this strategy appeared to be performing as expected aligning with Management's projections for plan design and utilization.
