Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Solutions 4 Community Health, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Note 1 - Description of Plan

The following description of the Solutions 4 Community Health, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) retirement plan covering all eligible employees of Solutions 4 Community Health, Inc. (the "Company"). Eligible participants may enter the Plan immediately upon meeting the eligibility requirements. Union employees, leased employees, employees of any controlled group employer, as defined by the Plan, and students are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

Contributions

Each year, participants may make salary deferral contributions to the Plan up to 100% of their pre-tax annual compensation, as defined in the Plan. Eligible participants may begin to make salary deferral contributions to the Plan as soon as administratively feasible following their date of hire. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan has an automatic enrollment feature, where all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their pre-tax deferral rate set at 2% of eligible compensation and have their contributions invested in a default investment option until changed by the participant. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year, the Company may, at its discretion, make nonelective contributions to the Plan. Any discretionary nonelective contributions shall be allocated to participants based on a percentage of the participants' eligible compensation. Participants must complete a year of service (with a minimum of 1,000 hours) and be actively employed on the last day of the Plan year to receive an allocation of the Company's discretionary nonelective contributions (except for death, retirement age and disability). For the year ended December 31, 2024, the Company made a discretionary nonelective contribution to the Plan equal to 5.5% of each participant's eligible compensation totaling \$440,327. Participants also direct the investment of Company contributions. All contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of Company discretionary nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. In the event of termination due to death, normal retirement or permanent disability, participants shall become 100% vested in the Company's discretionary nonelective contribution portion of their account. For other participants, vesting in the Company's discretionary nonelective contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the value of the participants' vested account balance. The loans are secured by the balance in the participant's account. The loans bear interest at the Prime Rate, as defined, plus 1% and are determined at the time the loans are made. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon termination of service, a participant with an account balance of \$1,000 or less will receive a lump-sum distribution. If the participant's account balance is greater than \$1,000, but less than \$5,000, the Plan administrator will roll the amount into an individual retirement account established by the Plan administrator, unless the participant elects to receive a lump-sum distribution. Participants with an account balance greater than \$5,000 may elect to receive a single lump-sum amount, partial payments, installment payments for a specified term equal to the value of the participant's vested interest in his or her account or defer payment of benefits until a later date.

Withdrawals from a participant's account (excluding the portion attributable to any Company nonelective contributions) may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's rollover account may be made at any time. Additionally, in-service withdrawals are allowed from the vested portion of a participant's account in accordance with the provisions specified in the Plan for participants who have attained age 59½.

Forfeited accounts

Forfeited balances of terminated participants' nonvested accounts may be applied to Plan administrative expenses or used to reduce future employer contributions. Unallocated forfeitures were \$11 and \$11,801 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$11,948 was utilized from forfeited nonvested accounts to reduce the 2024 employer contribution.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value (see Note 4), is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the trustee, custodian and investment advisers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The nonelective contributions from the Company are recorded in the year in which the contributions are earned.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions, investment management fees, and other participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Other indirect investment-related expenses are included in the net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the daily closing price as reported by the funds. The mutual funds and money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

Note 4 - Investment contract with insurance company

The Plan has entered into a traditional guaranteed investment contract with Transamerica Financial Life Insurance Company ("TFLIC") through an investment in the TFLIC Guaranteed Investment Option. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The balance in the traditional guaranteed investment contract as of December 31, 2024, and 2023 was \$79,180 and \$55,418, respectively.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer which is reviewed periodically for resetting in accordance with the terms of the contract. The minimum crediting rate under the TFLIC Guaranteed Investment Option is 1.40%. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contracts. No

events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuers.

Note 5 - Related party transactions and party-in-interest transactions

Plan investments include shares of mutual funds and a money market fund held by State Street Bank and Trust Company ("State Street") and a guaranteed investment contract held by TFLIC. State Street is the trustee and TFLIC is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

TFLIC provides certain administrative services to the Plan pursuant to a Pension Services Agreement between the Company and TFLIC. State Street provides trustee services to the Plan pursuant to a Trust Agreement between TFLIC and State Street. Direct fees paid to the trustee and custodian for certain recordkeeping services are included in the administrative expenses which amounted to \$4,688 for the year ended December 31, 2024. Other indirect fees paid to the trustee and custodian for investment management services are included in the net appreciation in fair value of investments. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Tax status

The Plan has been designed using a non-standardized pre-approved defined contribution plan document sponsored by Transamerica Retirement Solutions, LLC. Transamerica Retirement Solutions, LLC received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (the "IRS") stated that the non-standardized pre-approved defined contribution plan document, as then designed, satisfies the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Certified investments

Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by State Street Bank and Trust Company, the trustee of the Plan, and Transamerica Financial Life Insurance Company, a custodian of the Plan.

Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
