Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets held at end of year as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS**NOTE A. DESCRIPTION OF PLAN**

The following description of the PVB Fabrications 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

GENERAL

The Plan is a defined contribution plan formed to encourage and assist employees of PVB Fabrications, Inc. (the “Company”) in regularly saving for their retirement through payroll reductions and matching contributions made by the Company. Effective January 1, 2022, the Plan became a safe harbor 401(k) plan.

Effective January 1, 2025, Reliance Trust Company resigned as Trustee of the Plan, and appointed ADP Retirement Trust Services, LLC as the new Trustee.

ELIGIBILITY

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended, and the Internal Revenue Code (the “Code” or “IRC”). Employees who have attained age 21 or older and have completed three months of service are eligible to participate in the Plan as of the first day of the month following completion of the eligibility requirements.

CONTRIBUTIONS

Participants may contribute through payroll deductions up to 90% of their eligible compensation, as defined by the Plan. Contributions may be made on a pre-tax or after-tax basis. Contributions, which may be determined to be excessive in accordance with the discrimination rules of the Internal Revenue Service regulations, are refunded annually.

For each Plan year, the Company will make a matching contribution equal to 100% on the first 3% of compensation and 50% on the next 2% of compensation the employee contributes to the Plan. The employee must contribute to the Plan to receive the Company’s matching contribution. The matching contribution is made each pay period that the employee contribution is made. The Company may also make an additional profit-sharing contribution to the Plan, although the Company is not required to make this non-elective contribution.

INVESTMENT OPTIONS

The Plan provides for participant-directed investment elections among different types of money market funds, common/collective trusts, and mutual funds. Participants may change their investment elections on any business day, and as often as desired by communicating directly with Automatic Data Processing (“ADP”), the Plan’s third-party administrator.

PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, and allocation of Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which an employee is entitled is the benefit that can be provided from the participant’s vested account balance.

VESTING

Participants are immediately vested in their voluntary contributions on their account earnings, and in the Company's safe harbor matching contribution. Vesting in the remainder of their account is based on years of service. An employee is vested in employer non-elective profit-sharing contributions at the rate of 20% after two years, 40% after three years, 60% after four years, 80% after five years, and 100% after six years of service. Upon retirement, disability or death, an employee is 100% vested in their entire account.

NOTES RECEIVABLE FROM PARTICIPANTS

The Plan is permitted to make loans to participants. Each loan is evidenced by a note receivable and must be made for at least \$500 but not to exceed 50% of the participant's vested account balance or \$50,000 at the date the loan is granted. Loans are limited to one outstanding loan per participant. Loans bear interest at the prime rate in effect in the month the loan is effective, plus 2%, and must be repaid within five years (30 years for loans used for the purchase of a participant's primary residence) through payroll deductions. A loan is considered to be in default the last day of the calendar quarter following the quarter in which the participant first missed a payment.

PAYMENT OF BENEFITS

Upon termination of service, an employee may elect to receive a roll-over distribution or lump-sum amount equal to the value of their account. If the account is valued at less than \$5,000, the participant will automatically receive a lump-sum payment if no alternate election is made within 90 days.

The Plan also provides for hardship withdrawals during employment. A hardship withdrawal may come from a participant's voluntary contributions and earnings on those contributions, as well as any vested matching contributions or non-elective contributions. The withdrawal may not be for an amount greater than that which is necessary to satisfy the immediate financial need, plus any income taxes or penalties which are expected to result from the distribution. The minimum request is \$500.

The Plan also provides in-service distributions of vested account balances for participants who have reached age 59 ½. Withdrawals are generally subject to 20% federal income tax withholding and any applicable state income tax withholding unless the participant elects not to have taxes withheld. Also, withdrawal prior to the age 59 ½ may be subject to a 10% early withdrawal penalty.

ADMINISTRATIVE EXPENSES

Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense in the accompanying statement of changes in net assets available for benefits.

FORFEITURES

Forfeitures are the non-vested portion of participant account balances for terminated participants. These funds, which have been retained in the Plan, are available to reduce future contributions by the Company or to pay Plan expenses. The forfeited balance is \$0 as of December 31, 2024 and 2023, respectively.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies followed by the Plan in the preparation of its financial statements are as follows:

BASIS OF ACCOUNTING

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). Receivables and liabilities, other than for benefits, are accrued in accordance with the American Institute of Certified Public Accountants Audit and Accounting Guide, *Audits of Employee Benefit Plans*.

NET APPRECIATION (DEPRECIATION) IN FAIR VALUE OF INVESTMENTS

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported assets and liabilities and disclosure of any contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance. Loan fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded upon the occurrence of a distributable event.

INVESTMENT VALUATION AND INCOME RECOGNITION

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Investment expenses are recorded as a reduction in investment earnings.

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U.S. GAAP establishes the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under U.S. GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Investments for which fair value is measured using net asset value per share as a practical expedient have not been categorized within the fair value hierarchy.

PAYMENT OF BENEFITS

Benefits payments to participants are recorded upon distribution. There were no participants who had elected to withdraw from the Plan but had not yet been paid as of December 31, 2024.

INCOME TAX STATUS

The Plan participates in a defined contribution prototype plan and trust offered by ADP, which is intended to meet the requirements of the Internal Revenue Code as a qualified Prototype Retirement Plan and Trust/Custodial Account. The Plan utilizes the Automatic Processing Prototype 401(k) and Profit-sharing Plan document which obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, followed the applicable requirements of the Internal Revenue Code. Although the Plan document has been amended since receiving the determination letter, the Plan administrator and Company management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in these financial statements.

U.S. GAAP clarifies the accounting for uncertainty in income taxes by creating a framework to recognize, measure, present, and disclose in financial statements uncertain tax positions that have been taken or expect to be taken in a tax return. The Plan administrator and Company management believe that there are no uncertain tax positions for which it is reasonably possible that reported total amounts could significantly differ from amounts that may be determined upon examination by taxing authorities. In general, the Plan's federal returns remain subject to examination by taxing authorities for three years, unless specific conditions are met, from the filing date. Accordingly, the Form 5500 for the period ending December 31, 2020 is no longer subject to examination.

NOTE C. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price, as reported by the fund, of shares held by the Plan at year end. Mutual funds held by the Plan are open-end, actively traded mutual funds registered with the Securities and Exchange Commission and are required to publish their daily net asset value ("NAV") and transact at that price.

Common/collective trust: Valued at the NAV, which approximates fair value of the units held by the Plan, representing a mix of all the underlying assets, as reported by the portfolio manager.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's mutual funds are all Level 1 investments within the fair value hierarchy as of December 31, 2024 and 2023.

NOTE D. COMMON/COLLECTIVE TRUST

The Plan has participant-directed investments held in a common/collective trust (e.g., stable value fund) that contains investment contracts that carry a benefit-responsiveness feature that allows Plan participants to make exchanges or request benefit payments at contract value. A stable value fund contains a pool of fixed income securities (e.g., government securities, mortgage-backed securities, etc.). These securities are wrapped by a synthetic investment contract issued by a bank or insurance company that ensures that participant-initiated withdrawals from the stable value fund will be paid at book value. Participant transactions may occur daily. If the Plan initiates a full redemption, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There is no immediate recognition of gains and losses on the pool of securities. Instead, the gain or loss is recognized over time by adjusting the interest rate credited to the fund under the synthetic wrap.

As required by U.S. GAAP, the statements of net assets available for benefits present the fair value of the Plan's investment contracts. The common/collective trust is reported at net asset value as a practical expedient as the investment does not have a readily determinable fair value and the investment is in an investment company.

NOTE E. UNAUDITED INFORMATION CERTIFIED BY THE TRUSTEE

The following unaudited information in the Plan's financial statements and supplemental schedule was certified to be complete and accurate by Reliance Trust Company (the "Trustee" of the Plan). The Trustee has certified the unaudited information in the Plan's financial statements and supplemental schedule both within the meaning of 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- All amounts reported as mutual funds, common/collective trusts, and notes receivable from participants in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- All amounts reported as net appreciation (depreciation) in fair value of investments, dividend income, and interest on notes receivable from participants in the statement of changes in net assets available for benefits as of December 31, 2024.
- All amounts reported in the supplemental schedule of assets held at end of year.

NOTE F. PLAN TERMINATION

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

NOTE H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the participants' account and the amounts reported in the financial statements.

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of common/collective trusts. The total loss that could occur if the accounts became uncollectible is the stated fair value of the financial instruments reported in the accompanying statement of net assets available for benefits.

NOTE I. SUBSEQUENT EVENTS

The preparation of financial statements in conformity with U.S. GAAP requires management to disclose the date through which subsequent events (i.e., an event or transaction that occurs after the balance sheet date but before the financial statements are issued) were evaluated when determining whether adjustment or disclosure in the financial statements is required. The Company evaluated subsequent events through July 31, 2025, which represents the date the accompanying financial statements were available to be issued.
