Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Effectual 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Notes to Financial Statements

December 31, 2024

1. Description of Plan

The Effectual 401(k) Plan (the “Plan”) is the retirement plan for Effectual Inc. (the “Company”). The following description provides only general information. The Plan document should be consulted for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan with a 401(k) and profit-sharing feature covering eligible employees of the Company who are twenty-one years of age or older. Employees are eligible to make elective deferrals and receive employer contributions on the first day of the month following the date of being hired. The Plan adopted an automatic enrollment feature to enroll eligible employees into the Plan. The initial participant contribution is 5% of gross pay. Accounts of participants who do not affirmatively elect investment options for their account will be invested in a Target Date Fund assuming retirement at age 65. Participants can opt out of the automatic enrollment feature or change their contribution amount or investment allocation at any time. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan administrator oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 90% of eligible pretax compensation up to the maximum allowed by law. Participants are also permitted to make contributions as “Roth” contributions. In addition, participants may contribute distributions from other qualified plans (rollovers). Participants who had attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan has elected to be constituted as a safe harbor plan, which requires an employer matching contribution in an amount equal to 100% of the first 3% of the participant’s contributions and 50% of the next 2% of the participant’s contributions. True-up adjustments are made for participants who are eligible to receive safe harbor contributions for the Plan year. The Plan provides for, at the discretion of the Company’s management, an additional profit-sharing contribution. For the year ended December 31, 2024, the Company has elected not to make any profit-sharing contribution. All participant and Company contributions are subject to limitations by law. All contributions are participant directed and can be redirected daily.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s safe harbor contributions and allocations of discretionary contributions and Plan earnings (and losses) and charged with the participant’s withdrawals or distributions and an allocation of administrative expenses. Allocations are based on participant account balances as defined. The benefit to which a participant is entitled is the participant’s vested account.

1. Description of Plan (*continued*)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon and in any Company safe harbor and discretionary profit sharing contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans require repayment within no more than 5 years, or up to 30 years if for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at equal to 1% above the prime rate. The maximum number of Plan loans that you may have outstanding at any one time is two. Principal and interest must be paid ratably through payroll deductions or otherwise in at least equal quarterly installments.

Forfeited Accounts

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$10 each year. Forfeitures will be used to reduce employer contributions. For the year ended December 31, 2024, \$1 of forfeitures were used to reduce employer contributions.

Payment of Benefits

Upon termination of service due to disability or retirement, a participant, or his or her beneficiary, may elect to receive one of the following forms of payment equal to the value of the participant's vested interest in his or her account: 1) Lump sum; 2) Life annuity; 3) Survivor annuity; or 4) partial distribution. In those cases where the vested balance, excluding rollovers, is less than \$7,000, a participant will receive the value of the vested interest as a lump sum distribution. Death benefits paid to a beneficiary will be paid in a lump sum distribution.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements*, which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

Registered investment companies held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the registered investment companies are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies of the Plan are deemed to be actively traded.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 11, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

As of January 1, 2025, ADP Retirement Trust Company is the trustee for the Plan.

4. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer, ADP, LLC, dated October 6, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and was tax exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

5. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan Document, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various market risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.
