## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator, Participants and Beneficiaries of the  
Gotham Technology Group, LLC 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Gotham Technology Group, LLC 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Notes to Financial Statements December 31, 2024 and 2023**

#### **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Gotham Technology Group, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **[1] General:**

The Plan is a defined contribution plan established in 2001, covering substantially all employees of Gotham Technology Group, LLC, Gotham Government Solutions, LLC, and StrikePoint Marketing, LLC (collectively, the "Company") who have completed three consecutive months of service, during which a minimum of 250 service hours have been completed, and have attained the age of 21. Upon satisfaction of the requirements, participants are eligible to enter the Plan on the first day of each month of the Plan year. The Plan was amended and restated effective August 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The trustee of the Plan is Reliance Trust Company, and the recordkeeper is Automatic Data Processing ("ADP").

Effective January 1, 2025, ADP Retirement Trust Services, LLC is the trustee of the Plan.

##### **[2] Contributions:**

Participants may contribute between 1% and 90% of annual compensation, as defined by the Plan, as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts as after-tax voluntary contributions. In no event may participant pre-tax, Roth, and after-tax contributions exceed any statutory limitations. In addition, participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans. Contributions in any calendar year may not exceed the limits under Internal Revenue Code ("IRC") Sections 401(k), 404, and 415.

The Company is permitted to contribute amounts representing discretionary employer matching contributions, as defined by the Plan. For the year ended December 31, 2024, the Company matched 25% of participant pre-tax and Roth contributions up to 6% of base compensation, as defined by the Plan. Catch-up contributions and after-tax voluntary contributions are not eligible for discretionary employer matching contributions. In addition to discretionary employer matching contributions, the Company is also permitted to contribute amounts representing employer non-elective contributions. Such amounts are also discretionary in nature. In order for a participant to receive an employer non-elective contribution, a participant must be employed on the last day of the Plan year. The Company did not contribute amounts representing employer non-elective contributions during the year ended December 31, 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The Plan also has an escalation feature whereby the deferral rate will increase each year by 1% on the participant's anniversary date up to a maximum of 10%.

Participants direct the investment of participant and Company contributions into various investment options offered by the Plan.

##### **[3] Participant accounts:**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings or (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

#### [4] Vesting:

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's discretionary employer matching contribution and employer non-elective contribution portions of their accounts, plus actual earnings thereon, is as follows:

Participants become 100% vested in the portion of their account related to discretionary employer matching contributions and employer non-elective contributions upon death, disability, or the attainment of normal retirement age during the Plan year.

#### [5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, but in no event may have more than one loan outstanding at any time. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate equal to Prime plus 1% at the inception of the loan. Interest rates on outstanding loan balances ranged from 4.25% to 9.50% as of December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### [6] Payment of benefits:

On termination of service due to death, disability, or upon attainment of normal retirement at the age of 65, a participant (or their beneficiary) may elect to receive either a lump-sum amount, a direct rollover distribution, or installment payments equal to the value of the participant's vested interest in his or her account. A participant balance of less than \$5,000 will be distributed in a lump sum as soon as administratively feasible, even if the participant does not consent to a distribution. If a participant's balance is more than \$5,000, the vested balance will be distributed after a request for payment has been received. In-service distributions may be made from a participant's deferral account at any time upon or after the occurrence of the following events: hardships, as defined in the Plan document, withdrawals of rollover contributions, the participant's attainment of age 59½, or withdrawals after age 70½.

#### **NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)**

##### **[7] Forfeitures:**

Forfeited nonvested accounts may be used to pay Plan expenses or reduce Company contributions. During the year ended December 31, 2024, forfeitures of approximately \$26,700 were used to reduce Company contributions. Forfeited nonvested accounts available at December 31, 2024 and 2023 approximated \$88,000 and \$21,000, respectively. The employer contribution receivable recorded as of December 31, 2024 was reduced by approximately \$58,000 from forfeited nonvested accounts available at the time the amount was paid.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **[1] Basis of accounting:**

The accompanying financial statements are prepared on the accrual method of accounting.

##### **[2] Subsequent events:**

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

##### **[3] Investment valuation and income recognition:**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the accrual basis. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **[4] Payment of benefits:**

Benefits are recorded when paid.

##### **[5] Plan expenses:**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in value of investments.

##### **[6] Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund* – A stable value fund that is composed primarily of fully benefit-responsive investment contracts and that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The trustee of the investment, in its sole discretion, may withhold payment on any distribution or withdrawal for a period of up to 12 months to meet liquidity demands on the fund. The trustee may also terminate the trust at any time upon 30 days' notice.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE E - TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan sponsored by ADP, LLC. On October 6, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Reliance Trust Company and ADP are the trustee and recordkeeper, respectively, of the Plan. These service providers of the Plan charge fees for certain participant-initiated transactions and Plan recordkeeping fees. As service providers to the Plan, these transactions qualify as party-in-interest transactions. Total fees paid to these service providers during the year ended December 31, 2024 approximated \$21,000. The Plan also pays accounting and investment advisory fees. As service providers to the Plan, these transactions also qualify as party-in-interest transactions. Fees paid by the Plan to these service providers approximated \$81,000 during the year ended December 31, 2024.

The trustee provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the trustee provides to the funds. This revenue is used to offset certain amounts owed to the trustee for its administrative services to the Plan. If the revenue received by the trustee from such mutual fund service providers exceeds the amounts owed, the trustee remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During the year ended December 31, 2024, approximately \$99,900 was received from the trustee and is reflected as other investment income in the statement of changes in net assets available for benefits. Approximately \$99,500 was used to pay Plan expenses. The account balance as of December 31, 2024 and 2023 approximated \$76,500 and \$74,700, respectively.

#### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE H - MUTUAL FUND FEES**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

#### **NOTE I - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.
