Independent Auditor's Report

To the Participants and Beneficiaries
Aldora Aluminum and Glass Products, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Aldora Aluminum and Glass Products, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1. Plan Description

The following description of the Aldora Aluminum and Glass Products, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Aldora Aluminum and Glass of Charleston, Inc. (the “Sponsor” or the “Company”) and effective February 8, 2017, Louisville Plate Glass Company, Inc. and effective January 1, 2022, Vista View Windows and Doors, Inc., who have completed six months of service, and are not members of the following classes of employees: (a) leased employees; (b) those subject to a collective bargaining agreement; and/or (c) non-resident aliens who have no earned income from sources within the United States of America. Eligible employees may enter the Plan on the earliest of the monthly enrollment dates following satisfactorily meeting eligibility criteria.

The Plan Administrator is responsible for oversight of the Plan. The Plan entered into an agreement with ADP Strategic Plan Services, LLC (ADPSPS) to be the Investment Manager for the plan. ADPSPS determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Sponsor's management. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions: Eligible participants may elect to make contributions to the Plan by means of a salary deferral agreement of up to 90% of their annual compensation, up to the maximum allowable amount under the Internal Revenue Code (the “IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may also make matching contributions, at its discretion. The Company's contribution percentage was 50% of the first 4% of participants' compensation for the period from January 1, 2022 to December 31, 2024.

The Plan allows participants to designate certain salary deferral contributions as Roth elective contributions. Designated Roth contributions will be currently included in the gross taxable income of the participant, but distributions of designated Roth contributions and earnings thereon will be excludable from gross taxable income for that participant.

Investment options: Upon enrollment in the Plan, a participant may direct all contributions to selected investments, as made available and determined by the plan administrator, in 1% increments. Participants may change their investment options daily. The Plan currently offers various investment options, including common collective trusts, mutual funds and a self-directed brokerage option.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Each participant's account is reduced by any withdrawals or distributions and charged with an allocation of investment losses, if any, and administrative fees paid by the Plan. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Plan Description (Continued)

Vesting: Participants are immediately vested in their contributions, plus actual earnings thereon. The portion of participants' accounts attributable to the Company's discretionary matching contributions become 25% vested after one year of credited service, as defined in the Plan document, 50% vested after two years of service and 100% after 3 years of service. Eligible participants are 100% vested upon death, becoming disabled or reaching normal retirement age. Upon termination of employment, the non-vested portion of a participant's account is forfeited.

Payment of benefits: Upon retirement, total and permanent disability or other termination of service, a participant may elect to receive a lump-sum distribution equal to the participant's vested interest in his or her account. If a terminated participant's vested interest is less than \$1,000, the plan administrator may distribute the vested interest as a lump-sum cash payment without the election of the participant. Upon the death of a participant, the vested balance of the participant's account is distributed to the participant's beneficiary.

The Plan also allows for in-service distributions of participant deferrals, prior to attaining age 59½, in the event of financial hardship. In-service distributions may be withdrawn on the Company's matching or discretionary contributions after the participant attains age 59½.

Forfeitures: Forfeitures are used to reduce future employer contributions or pay Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,687 and \$2,611, respectively. Also, during 2024 and 2023, \$4,895 and \$2,378, respectively, of forfeitures were used to reduce employer matching contributions, and no forfeitures were used to pay administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"), except for benefits paid to participants, which are recorded on the cash basis.

Use of estimates: The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Investment Review Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from participants and the Company's matching contributions are recorded in the year in which the participant contributions are withheld from amounts paid. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed annually under the IRC are recorded as a liability with a corresponding reduction in contributions.

Payment of benefits: Benefit payments to participants are recorded when paid.

Participant Withdrawal from the Plan: There were no participants who left the Plan at December 31, 2024 that had requested a distribution of their account balance.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Note 3. Deemed Distributed Loans

A “Deemed Distributed Loan” (“DDL”) occurs when a participant misses a loan payment for any reason other than certain types of leave of absence and fails to make it up by a specified date, or the term for repaying a loan expires without full payment of the outstanding amount by a specified date. At that time, the participant is taxed on the outstanding amount, including applicable interest accrued to-date, as if it had been distributed. Per IRS instructions, the Plan must continue to treat the DDLs as outstanding loans, while the Plan’s 5500 Schedule H, I or SF must exclude DDLs from the assets reported. For the years ended December 31, 2024 and 2023, interest accumulated on deemed distributed loans was \$1,388 and \$1,493, respectively.

Note 4. Information Certified and Provided by Trustee

The following is a summary of the Plan's asset information for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Reliance Trust Company (Reliance), the trustee under the Plan and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate to the best of their knowledge. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and supplemental schedule related to the following assets:

Note 5. Fair Value Measurements

Fair value measurements in accordance with current accounting standards, established a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under that framework are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consists of common stocks that are valued on the basis of readily determinable market prices.

Common collective trusts: Valued at the NAV of shares in each account held by the Plan at year-end. The NAV is not a public-quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested and the funds of the Plan will be distributed based on individual participant balances.

Note 7. Related Party and Parties-in-Interest Transactions

Reliance is the current trustee of the Plan; therefore, transactions with the current trustee qualify as party-in-interest transactions. Fees paid to the current trustee by the Plan totaled \$75 for each of the years ended December 31, 2024 and 2023. The Company also paid \$3,913 and \$36,588 in certain administrative expenses of the Plan in 2024 and 2023, respectively.

Note 8. Tax Status

Effective May 13, 2022, the Plan adopted a restated prototype non-standardized profit-sharing plan sponsored by ADP, LLC, the record keeper of the Plan. The prototype non-standardized profit-sharing plan has received an opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020, that the prototype non-standardized profit-sharing plan is acceptable with the applicable section of the IRC. The plan administrator believes the Plan is currently designed and operated in compliance with the applicable provisions of the IRC and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participants’ account balances and the amounts reported in the financial statements.

Note 10. Subsequent Events

On December 31, 2024, the Company consented to the appointment of ADP Retirement Trust Services, LLC (ADP Trust) as the Plan’s Trustee upon the resignation of Reliance Trust Company. ADP Trust amended the trust agreement in its entirety which is effective January 1, 2025.

Management has evaluated subsequent events through August 28, 2025, the date on which the financial statements were available to be issued. Other than as described above, there were no material subsequent events that required recognition or additional disclosure in these financial statements.
