NOTE 1 – DESCRIPTION OF PLAN

The following description of the Deutsche Boerse Systems, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company. All employees are eligible to make contributions to the salary reduction program once they complete three months of service and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable provisions of other legislation related to employee benefit plans.

Employer Contributions

The Company contributions to the Plan are discretionary. The matching contribution is 100% of employee salary deferrals not to exceed between 4% to 6% of compensation. The Company makes matching discretionary contributions at end of plan years to all employees who are active participants at end of the year.

Participant Accounts and Allocations

Each participant’s account is credited or charged with an allocation of (a) the participant’s voluntary salary reduction contribution, (b) the Company’s contribution, and (c) Plan earnings.

Allocations are based on participant earnings, years of service, and account balances as defined in the Plan.

Investment Options

Upon enrollment in the Plan, participants may elect the way in which contributions are invested in a variety of investment choices within the Plan as more fully described in the Plan’s literature. The investment elections will apply to both participant and employer contributions. Participants may change their investment options at any time. During any period in which there is no participant direction on file with the Trustees as to the investment of a participant’s account, 100 percent of that participant’s account will be invested in the investment option designated from time to time by the Trustees as the default investment. The Plan currently offers various mutual funds, a self-directed brokerage account, and a stable value fund as investment options for participants.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Salary Reduction Contribution

A participant may elect to defer up to a portion of his/her compensation, subject to limitations under Section 401(k) of the Internal Revenue Service Code.

A participant may withdraw an amount up to his/her salary contribution, excluding income earned thereon, for reasons of extreme hardship, as defined in the Plan. In addition, a participant can elect to make early distributions from the Plan upon attaining the age of 59 ½.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in their profit sharing accounts and their discretionary matching accounts based on years of service as defined in the Plan. A participant is fully vested after three years of service. Breaks in service may be subject to a five-year 'Break in Service' rule. Employees who attain normal retirement age while still being employed will become 100% vested. Upon termination of service, because of disability or death of the participant, the account balance becomes fully vested. Such an account balance shall be paid as soon as administratively feasible following the date the participant becomes disabled. If a termination of service occurs for reasons other than death or disability, payment of vested benefits shall be made as soon as administratively possible following the participant's employment termination date. On retirement, the participant will receive the entire vested account balance as a lump sum.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or a longer term if loan proceeds are used for the purchase of a primary residence. The loans are secured by the balance of the participants and bear interest at a fixed rate (Prime plus 1%) determined at the time of the loan. Principal and accrued interest are repaid ratably through payroll deductions or directly to the custodian by the participant.

Forfeitures

Forfeitures may be used to pay Plan expenses or reduce amounts otherwise required to be contributed to the Plan. For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$56,505 and \$53,717, respectively. In 2024 and 2023, \$44,386 and \$0, respectively, were used to offset the Plan sponsor's matching contribution.

Party-In-Interest Transactions

Certain employees of the Company provide administrative services for the Plan, and the Company is not reimbursed for their services. Also, notes receivable from participants are party-in-interest transactions under ERISA.

Administrative Expenses

The Plan's recordkeeping and custodian fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees, if any, are charged to the Plan as a reduction of investment return and are included in the investment income or loss reported by the Plan. All other expenses of the Plan are paid by the Company.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on an accrual basis of accounting.

Investment Valuation and Income Recognition

The investment assets of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

See Note 4 for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based on the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions, if any, that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

For the period ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through September 19, 2025, the date when the financial statements were available to be issued.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under *ASC 820* are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to valuation methodology include: inputs other than quoted prices included within Level 1 that are observable for the asset or liability either directly or indirectly, such as inputs that are derived principally from or corroborated by observable market data by correlation or other means. If an asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Short-term securities consist of a mutual fund holding US Government securities and high quality money market instruments. The funds are valued at net asset values (NAV) of the shares held by the Plan at the year end.

Mutual funds: The fair values of mutual funds are determined by obtaining the net asset value (NAV) of shares held by the Plan at the year end.

Stable value fund: A stable value fund is composed primarily of fully benefit-responsive investment contracts, designed for the stability of principal, that are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are certain circumstances in which a withdrawal from the fund would be redeemed at fair value rather than contract value. These circumstances may include market value events that occur that are outside of the normal operation of the fund. These circumstances may also include employer initiated events as follows: fund administration changes, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of the fund, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the fund, transfers to competing options without meeting the equity wash provisions of the fund, and Plan sponsor withdrawals without the appropriate notice to the fund and/or issuer.

Self-directed brokerage assets consist of common stock and mutual funds, which are valued at the last reported sales price on the last business day of the year, and uninvested cash, which is recorded at carrying values. These assets are deemed to be a Level 1 investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Assets held by the Plan in 2024 and 2023 are classified as Level 1. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

NOTE 5 – PLAN TERMINATION

The Company has the right to discontinue its contributions to the Plan at any time and may terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested.

NOTE 6 – TAX STATUS

The Plan obtained its latest determination on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken a position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
