## Independent Auditors' Report

The Plan Participants and Plan Administrator  
ATH Retirement Plan and Trust:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of ATH Retirement Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

### (1) Plan Description

The following description of the ATH Retirement Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### (a) *General*

The Plan is a defined contribution plan covering substantially all employees of Advanced Technology Holding, LLC (the Company, Employer, Plan Administrator, or the Plan Sponsor) and its subsidiaries. Advanced Technology Holding, LLC is a subsidiary of General Dynamics Information Technology, a General Dynamics Corporation business unit. Union represented employees, nonresident aliens, and leased employees are not eligible to participate in this Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Vanguard Fiduciary Trust Company (the Trustee or Vanguard) serves as the trustee and custodian of the Plan. Vanguard Group, Inc. serves as the recordkeeper of the Plan.

Effective January 1, 2023, employees under the age of 18 years old are not eligible to participate in this Plan. This does not apply to employees who were eligible to participate prior to January 1, 2023.

#### (b) *Contributions*

Participants are eligible to elect to participate in the Plan upon hire. Effective January 1, 2024, participants may contribute up to 75% of eligible compensation as pre-tax deferrals, Roth deferrals or after-tax contributions, up to the statutory limits defined by the IRC. Prior to January 1, 2024, participants were able to contribute up to 50% of eligible compensation as pre-tax deferrals, Roth deferrals, or after-tax contributions, up to the statutory limits defined by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for Employer matching contributions of up to 100% of the first 6% of eligible compensation contributed to the Plan. The Plan's Employer matching contribution shall not be made with respect to after-tax contributions. The Plan is intended to be a safe harbor plan as defined in the IRC.

The Company may also make a discretionary profit-sharing contribution. Such Company discretionary profit-sharing contributions (if any) will be allocated to the accounts of eligible Plan participants in the ratio that each eligible participant's eligible compensation actually received for the Plan year, bears to the total eligible compensation actually received by all eligible participants for the Plan year. The Company authorized discretionary profit-sharing contributions of \$3,277,891 and \$3,057,424 for the years ended December 31, 2024 and 2023, respectively. These amounts are reflected in Contributions receivable – Employer at each respective period end.

#### (c) *Participant Accounts*

Each participant directs his or her contributions to be invested in various funds. Changes to investment elections can be made according to rules set by the Company. Each participant's account is credited with the participant's contributions, the Employer matching contribution and allocations of (a) the Company's discretionary profit-sharing contribution, if any, and (b) Plan earnings and losses, less an

allocation of administrative expenses. The benefit to which a participant is entitled is the vested balance of his or her account.

**(d) Vesting**

Participants are 100% vested in their elective deferral and safe-harbor matching accounts and actual earnings thereon. Employer discretionary profit-sharing contributions made to participants hired prior to January 1, 2011, are 100% vested. Participants hired on or after January 1, 2011, are subject to three-year cliff vesting. A participant will also be fully vested if they reach 59½ years of age, Normal Retirement Age, or the participant dies, incurs a disability, or satisfies the conditions for Early Retirement Age, as defined in the Plan Document.

**(e) Forfeitures**

Forfeitures may be used to reduce Employer contributions or to pay Plan expenses. At December 31, 2024 and 2023, participants' forfeited nonvested accounts were not significant. Forfeitures used during 2024 to reduce Employer contributions were also not significant.

**(f) Payment of Benefits**

Participants are eligible to receive benefit payments upon retirement, death, disability, or termination of employment. Participants and their beneficiaries may elect to receive a lump sum, partial distribution, installments, or transfer their vested balance to another qualified plan. Withdrawals from eligible accounts are allowed for participants who have attained 59½ or who have a qualifying hardship subject to the Plan Document.

Assets merged into the Plan from the GEO-Com, Inc. Money Purchase Pension Plan in 2002 are distributable only upon termination of the Plan or termination of employment, retirement, or death. Distributions attributable to the assets merged from the GEO-Com, Inc. Money Purchase Pension Plan are subject to the joint and survivor annuity requirements of Section 417(a)(3) of the IRC and any other applicable law.

**(g) Notes Receivable from Participants**

The Plan permits active participants to borrow from their fund an amount not to exceed the lesser of 50% of the participant's vested account balance or \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date on which such loan was made, over the outstanding balance of loans from the Plan on the date on which such loan was made. A participant may request a loan from their account across all available vested sources. Participants are not eligible to request a loan from their Employer discretionary profit-sharing contributions, if applicable, until the participant is fully vested. Loan terms may not exceed five years, except loans granted for the purchase of a primary residence, which may not exceed 15 years as determined at the time of the loan. The loans are secured by the vested balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Sponsor. Principal and interest are paid ratably through payroll deductions. Delinquent loans are reclassified as distributions based upon the terms of the Plan Document. Participant notes receivable at December 31, 2024 and 2023 are carried at their unpaid principal balance plus any accrued but unpaid interest.

**(h) *Risks and Uncertainties***

The Plan invests in various investment securities. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks, as well as risk associated with global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**(2) Summary of Significant Accounting Policies**

**(a) *Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

**(b) *Use of Estimates***

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

**(c) *Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Investment income consists of dividend income, interest income and net appreciation (depreciation) in the fair value of investments. Interest income is recorded on an accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in dividend income.

**(d) *Payment of Benefits***

Benefits are recorded when paid.

**(e) *Administrative Expenses***

Certain administrative expenses are paid by the Company on behalf of the Plan. The Plan Document provides that the Company is entitled to reimbursement for expenses paid by the Company on behalf of the Plan. The Company did not seek reimbursement for these expenses in 2024. The administrative expenses paid by the Company on behalf of the Plan were not significant for the year ended December 31, 2024.

### (3) Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments, at fair value, and notes receivable from participants at December 31, 2024 and 2023, and interest and dividend income, interest on notes receivable from participants and net appreciation in fair value of investments for the year ended December 31, 2024, that are disclosed in the accompanying financial statements, Note 4 and the supplemental schedule, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Vanguard Fiduciary Trust Company (the trustee of the Plan). This information has not been audited by independent accountants.

### (4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the assets or liabilities; and
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the closing price reported on the active market in which the individual securities are traded (Level 1).

*Participant-directed brokerage accounts:* The fair values of interest-bearing cash, mutual funds, common stocks, and units of exchange traded funds are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1). The fair values of certificates of deposit are based on current bid prices (Level 2). The accounts also hold corporate debt which is valued at the most recent bid prices (sales prices if their principal market is an exchange) in the principal market in which they are traded, as determined by recognized dealers in such securities, or are valued on the basis of information provided by a pricing service (Level 2). Government securities are valued based on institutional bid evaluations (Level 2).

*Collective trust funds:* The fair values of these private investment securities are determined using the net asset value as provided by the fund managers (Level 2). Investments in collective trusts are redeemable daily at net asset value, and there are no restrictions on redemptions.

### (5) Tax Status

The Internal Revenue Service (IRS) issued a favorable determination letter on October 15, 2018, indicating that the Plan is a qualified plan under Section 401(a) of the IRC. The Plan is exempt from federal income tax under Section 501(a) of the IRC. Although the Plan has been amended subsequent to the date of the latest determination from the IRS, the Plan Sponsor and the Plan's counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. Under the IRS statute of limitations, the Plan is no longer subject to income tax examinations for years prior to 2021.

### (6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to suspend or discontinue contributions at any time and to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of plan termination, the participants would become 100% vested in their accounts and trust assets of the Plan shall be liquidated and distributed to participants and beneficiaries in proportion to their respective account balances.

### (7) Party-in-Interest Transactions

The Plan invests in investment funds managed by the Trustee or affiliates of the Trustee of the Plan. These funds are considered party-in-interest investments. Fees paid by the Plan to the Trustee also qualify as exempt party-in-interest transactions.

Notes receivable from participants are also considered exempt party-in-interest transactions.
