## 1. Plan Description

The following description of Partners in Care 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective January 1, 2019.

### General

The Plan was adopted on January 1, 2009 as a defined-contribution plan covering eligible employees of Partners in Care (the Employer). All employees are immediately eligible for Plan participation. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is intended to be qualified under Section 403(b) of the Internal Revenue Code (IRC). The Plan Administrator oversees governance of the Plan.

### Contributions

Each year, participants may contribute pre-tax or after-tax Roth compensation up to the limits provided by the Internal Revenue Code (IRC). Employees age 50 or older or who will attain age 50 before the end of the calendar year are eligible to contribute "catch-up" contributions up to Internal Revenue Service (IRS) limits. The Plan also allows for participants to make rollover contributions from existing qualified plans into the Plan.

Participants are immediately eligible upon hire for deferrals. The Plan has an Automatic Contribution Arrangement (ACA) deferral of 4 percent for all newly eligible participants, unless the participant makes an affirmative election not to defer or elects a different amount. The Plan does not have an auto escalation feature.

The Employer may contribute matching contributions to the Plan at its discretion. Such contributions are always fully vested. The percentage of the matching contribution is to be determined by the Employer each year and may be modified during the year. Employees are eligible for matching contributions after 60 consecutive days of service or immediately upon rehire if they have previously met the eligibility requirements. For the years ended December 31, 2024 and 2023, the Employer contributed a match of up to 2 and 4 percent, respectively, of eligible compensation.

Participants may direct the investment of their contributions into various investments offered through Matrix Trust Company.

### Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions and earnings on the specific investments held in the participant's account. Allocation of expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

During 2023, the Plan received corrective contribution funds from the Employer in advance of allocation to participants. Total unallocated assets at December 31, 2023 were \$19,285. There were no such contributions for the year ended December 31, 2024.

**Vesting**

Participants are fully vested in their accounts at all times.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a maximum of the lesser of \$50,000 or 50 percent of their account balance, with a minimum of \$1,000. A participant may not have more than one loan outstanding at a time. Principal and interest installments are paid monthly through payroll deductions over a period of up to 5 years, unless the loan is for the purchase of a principal residence, in which case the loan may be repaid over a period up to 15 years. The loans are secured by the balance in the participant's account and will bear a rate of interest equal to the prime rate prevailing at the time of the loan origination plus 1 percent. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon retirement, disability, death, or termination of employment, a participant may elect to receive the vested value of their account in a lump-sum payment. Participants age 59 ½ or older may take an in-service withdrawal of all or part of their account balance at any time. Participants may also withdraw funds from rollover contributions at any time.

The Plan provides for hardship withdrawals in the event of an immediate and heavy financial need in an amount not to exceed the lesser of the participant's vested balance or the participant's immediate and heavy financial need. Beginning January 1, 2023, the Plan allows for self-certification on hardship withdrawals and early withdrawals related to terminal illness, as provided for under the SECURE 2.0 Act.

**Plan Administration**

The Plan is administered by the management of the Employer. The Plan Administrator has appointed Randall & Hurley, Inc. as the third-party administrator of the Plan.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaces the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

## 2. Summary of Significant Accounting Policies

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### **Contributions**

Contributions from Plan participants and the matching contributions made by the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Investments held by plans qualified under Section 403(b) of the IRC are limited to registered investment companies (mutual funds) and fixed or variable annuity contracts.

Purchases and sales of securities are recorded on a trade date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and the delinquent note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses and Fees**

Third-party administration and investment advisory fees are paid by the Plan and charged to participant accounts. Certain account maintenance, distribution, and loan fees are paid directly from participant accounts. Other expenses of maintaining the Plan are paid by the Employer and excluded from these financial statements. Investment-related expenses are included in net change in fair value of investments or reported as a reduction from investment income.

**3. Information Certified by the Plan's Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

**4. Party-in-Interest Transactions**

Certain Plan investments may be shares of registered investment companies managed by the trustees or affiliates of the trustees of the Plan. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

**5. Plan Termination**

Although the Employer has not expressed any intent to discontinue its contributions and terminate the Plan Agreement, it may do so at any time subject to the provisions set forth in ERISA.

**6. Tax Status**

The Plan adopted the Randall & Hurley, Inc. Volume Submitter 403(b) Plan. Randall & Hurley, Inc., the sponsor of the Volume Submitter 403(b) Plan, has received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2017, that the adoption agreement and basic plan document satisfy IRC Section 403(b). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**8. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**8. Fair Value Measurements, continued**

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end. All mutual funds held by the Plan are open-end mutual funds that are registered with the SEC and are deemed to be actively traded and have a readily determinable fair value.

*Common/collective trust:* Units held in the common/collective trusts are valued using the NAV of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily at NAV. All common/collective trusts investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**9. Non-Exempt Transactions**

During the year ended December 31, 2024 and 2023, it was discovered that participant contributions and loan payments totaling \$8,273 and \$111,657, respectively, were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. The Employer has taken the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest and has further implemented a procedure to ensure that all future remittances are made within the prescribed time period. The total \$119,930 of late contributions were fully corrected with lost earnings in 2024.

**10. Subsequent Events**

Management evaluates events and transactions that occur after the statements of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
