Notes to Financial Statements

December 31, 2024 and 2023 and For the Year Ended December 31, 2024

Note 1 - The Plan and Its Significant Accounting Policies

General - The following brief description of the Laguna Clay Company 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the related Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established on 2000. Terrakotta, Inc. dba Laguna Clay Company (the Company) is the Plan sponsor providing plan benefits to eligible employees, as defined in the Plan document. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective January 1, 2023 and for the year ended December 31, 2024, the Plan has adopted the safe harbor provision of the Plan including an automatic enrollment feature known as a qualified automatic contribution arrangement (QACA). QACA safe harbor provision details are described further below in Note 3. In essence, a QACA safe harbor plan offers a streamlined approach to automatic enrollment in 401(k) plans, while also providing the Company with flexibility in terms of matching contribution formulas and vesting schedules, and relieving the Company of certain administrative burdens.

Administration - Under the terms of the Plan, a group of designated officers of the Company act as the trustee. The Company has appointed an Administrative Committee (the Committee) to manage the operation and administration of the Plan. The Company has contracted with Empower Annuity Insurance Company of America and its affiliates (together referred as Empower), a third-party administrator to process and maintain the records of participant data, and to act as the Plan's custodian. Substantially all expenses incurred for administering the Plan are paid by the Company except for third-party administrative fees, participant benefit withdrawal fees, and certain fund fees of approximately \$6,000 were paid by the Plan during 2024.

Basis of accounting - The accompanying financial statements have been prepared in accordance with U.S. generally accepted accounting principles (GAAP).

Use of Estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Subsequent events - The Company monitors significant events occurring after the financial statement date and prior to its issuance to determine the impacts, if any, of events on the financial statements to be issued. All subsequent events of which the Company is aware were evaluated through the date of the independent auditor's report.

Investments, investment valuation and income recognition - The Plan's investments are stated at fair value. Investments of the Plan are held by Empower and invested based solely upon instructions received from participants. Participants may direct the investment of their contributions and employer contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers pooled separate accounts with Empower with underlying assets of interest-bearing cash, mutual funds and bond funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fair value measurements - Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date.

Fair value hierarchy - Valuation techniques used by the Plan are based upon observable and unobservable inputs. Observable or market inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's assumptions about market participant assumptions based on the best information available. Assets and liabilities are classified in the fair value hierarchy based on the lowest level of input that is significant to the fair value measurement.

Level 1: Quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs for the asset or liability. No level 3 assets were held by the Plan.

The fair value hierarchy gives the highest priority to observable inputs and lowest priority to unobservable inputs.

Valuation techniques - The following is a description of the valuation techniques used to measure fair value. There were no changes in the techniques used to measure fair value for the year ended December 31, 2024.

- Pooled separate accounts with Empower investing in variable annuities are valued at the net asset value (NAV) established by the fund’s sponsor on the last business day of the Plan year, based on the fair value of the assets measured based on daily quoted market prices of underlying mutual funds and bond funds in active markets for identical assets, which are then adjusted to apply the expense factor as disclosed in the annuity contract.
- The Plan’s investments in Guaranteed Portfolio Funds with Empower investing in fixed annuity options have been reported in the financial statements at fair value. Investments are intended to be held until maturity although early liquidation could result in a termination charge. The Guaranteed Portfolio Funds are general account products. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The average yield for the years ended December 31, 2024 and 2023 was 1.41% and 1.23%, respectively, which are derived by averaging the Plan’s quarterly interest rates.

The above investments have no redemption restrictions or future commitments, and they have a daily redemption frequency.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation techniques are appropriate and consistent with other market participants, the use of different techniques or assumptions to estimate fair value could result in a different fair value measurement at the reporting date.

Cash and cash equivalents - All highly liquid investments purchased with an original maturity of three months or less (generally money market funds) are considered to be cash equivalents. These investments are usually held for a short period of time, pending long-term investment.

Forfeited accounts - Forfeited nonvested accounts are used to reduce future plan administrative expenses or employer contributions, as determined by the Company.

Notes receivable from participants - The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested balance. Such loans bear interest at the available market financing rates and must be repaid to the Plan within a five-year period, unless the loan is used for the purchase of a principal residence in which case the maximum repayment period can be longer than 5 years as described by the Plan's current loan policy. The specific terms and conditions of such loans are established by the Plan administrator. Outstanding loans at December 31, 2024 carry annual interest rates ranging from 4.25% to 10.50%.

Participant loans are classified as notes receivable from participants on the Statement of Net Assets Available for Benefits and are valued at their unpaid principal balances, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions in accordance with the Plan's provisions. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Participants can continue to repay their loan post-termination as long as they have not taken a distribution from their account.

Benefit payments - Benefit payments are generally recorded when paid.

Income taxes - The Plan has adopted Ascensus LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan which has received an opinion letter from the Internal Revenue Service indicating it is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Internal Revenue Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

The Plan administrator evaluates any uncertain tax position taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Risks and uncertainties - The Plan provides for various investment options in any combination of pooled separate accounts with variable annuities investing in mutual funds, fixed income securities and other investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 2 - Related Party Transactions

Certain Plan investments in units of pooled separate accounts with variable annuities and in guaranteed portfolio fund are managed by Empower, the custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value and qualify as party-in-interest. The Plan also pays record-keeping and investment advisory fees to a third-party administrator and its affiliates. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 3 - Participation and Benefits

The Plan document definition of compensation is based on when the compensation is "paid" versus when it is "earned." As such, the Company has determined that participant deferrals may not be due to the Plan, and the Plan may have no right to the deferrals, until the compensation is actually paid to the participant.

Effective January 1, 2023 and for the year ended December 31, 2024, the Plan has made the following changes prospectively:

- a. Eligibility requirement is changed from 1 year of service to 90 consecutive days of employment. If an employee does not complete the stated number of days, the employee is subject to a 1 year service requirement based on completion of at least 1,000 service hours.
- b. Implementation of automatic deferral provisions with deferral escalation percentages based on a participant's plan year in which automatic deferrals first apply: 3% of compensation for plan year 1 and 2, 4% of compensation for year 3, 5% of compensation for year 4, and 6% of compensation for year 5 and thereafter, with default investment in Empower's Guaranteed Portfolio Fund.
- c. Adopting safe harbor employer contribution provisions with a 2-year vesting schedule.
- d. Adopting new participant loan rules and requirements.

These plan provision changes are prospective and do not have significant financial impacts on the Plan for the year ended December 31, 2024. Participants should refer to the Plan Sponsor for further details.

Employer contributions - In general, the Company is allowed to make discretionary contributions as defined in the Plan and as approved by the Board of Directors. Contributions are invested in accordance with the participant's direction. For the year ended December 31, 2024, the Company has elected safe harbor provision of the Plan which is designed for the Company to commit in making certain contributions enabling the Company to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met. The safe harbor contributions are equal to 100% of each eligible participant's contribution that do not exceed 1% of eligible compensation plus 50% of participant's contribution between 1% and 6% of compensation. The entire 2024 safe harbor employer contributions have been funded during June 2025 prior to the funding deadline of September 15, 2025 which is the Plan Sponsor's business income tax return extension filing deadline.

Participant contributions - In addition to the automatic deferral provisions, participants may elect to have the Company contribute an amount or a percentage of their eligible compensation as defined by the Plan, subject to annual limits specified under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Contributions withheld are invested in accordance with the participant's direction. Roth 401(k) contribution feature is currently not offered by the Plan.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Vesting - Participants are fully vested in their contributions and earnings thereon. Prior to January 1, 2021, in general, participants are subject to a four-year cliff vesting with regard to Company matching contributions, and earnings thereon, after which time they become 100% vested in their Company matching contributions, and earnings thereon. In addition, participants become 100% vested in their Company matching contributions, and earnings thereon, at attainment of age 65, death before termination of employment, or becoming permanent disabled.

Effective January 1, 2021, the Company has amended the Plan's provision to a six-year cliff vesting with regard to Company contributions. This vesting schedule change is prospective and does not impact participants prior to January 1, 2021.

Effective January 1, 2023, in conjunction with adoption of QACA safe harbor provision, the Company has amended the Plan's provision to a two-year cliff vesting with regard to Company contributions with 0% vesting for less than 2 years of service and 100% vesting for 2 or more years of service. This vesting schedule change is prospective and does not impact participants prior to January 1, 2023.

Participant accounts - Each participant's account is credited with the participant's contributions, applicable Company matching contributions, and Plan earnings, and is reduced for any benefit payments and administrative expenses. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance and share of net earnings or losses of their respective elected investment options. Allocations are determined in accordance with the provisions of the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Forfeitures - If a participant terminates employment before becoming fully vested in their Company matching contributions, the nonvested Company matching contributions (and earnings thereon) are forfeited at the earlier of the date the participant receives a distribution or incurs a five-year break-in-service. Forfeited balances due to taking a distribution of vested amounts are restored if the participant returns to an eligible status within five years of termination and repays any amount previously distributed. Forfeited balances of terminated participants' non-vested accounts are used to pay eligible plan expenses, reduce future Company matching contributions, or restore previously forfeited balances.

Unallocated forfeiture balances as of December 31, 2024 and 2023, were \$2,280 and \$2,248, respectively. During 2024, employer matching contributions were reduced by \$0 from forfeited nonvested account.

Payment of benefits - Upon termination, death, or retirement, participants or beneficiaries may elect to receive a lump-sum amount or a partial or systematic withdrawal amount based on the vested value of their accounts. The Plan allows for in-service and hardship distributions when participants meet certain criteria. Participants may also, at any time, withdraw all or part of their rollover accounts. The Plan also allows for automatic lump sum distribution of participant vested account balances that do not exceed \$5,000.
