Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Daisy Brand Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 1. Description of Plan

The following description of the Daisy Brand Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Daisy Brand, LLC (the Company) who are eligible on the first of the month following one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

Effective May 31, 2024 the Plan was amended to reflect a change in the trustee from Nationwide Life Insurance Company and Nationwide Trust Company, FSB to Fidelity Management Trust Company. As a result of this change, participants may no longer contribute to investment options offered by Nationwide Life Insurance Company and Nationwide Trust Company, FSB. The Employer and investment adviser completed a mapping of the previous investment options to the new investment options provided by Fidelity Management Trust Company. The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Company are considered eligible for participation, except for: (1) nonresident aliens with no U.S. source of income; (2) employees covered by a collective bargaining agreement that does not provide for participation in the Plan; (3) leased employees; and (4) a resident of Puerto Rico.

To be eligible to make a salary deferral contribution an employee is eligible upon completion of one month of service. Once this criterion is met, the employee will be automatically enrolled in the Plan on the first day of each calendar month of the Plan year, coincident with or next following satisfaction of the eligibility requirements. Employees are eligible to receive matching contributions upon one hour of service. To be eligible for non-elective profit-sharing contributions, employees require 1,000 hours of service and must be employed at Plan year-end unless the employee dies, retires, or becomes disabled during the Plan year. To be eligible for non-elective safe harbor contributions, an employee must be of age 21 and have completed one year of service. Once this requirement is met, the employee will enter the Plan on the first day of the Plan year or first day of the seventh calendar month of the Plan year coincident with or next following satisfaction of the eligibility requirement. Effective June 26, 2024 the Plan allowed Roth contributions an employee is eligible upon completion of one month of service.

Contributions

Participating employees may invest in the Plan up to 85% of annual compensation, as defined by the Plan, not to exceed the annual limitation under Internal Revenue Code (IRC) section 402(g) (\$23,000 for 2024). Participants who have attained age 50 before the end of the Plan year are eligible to

make catch-up contributions (\$7,500 for 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The employer matching contribution is equal to a percentage determined each year of each participant's contribution to the extent that the participant's contribution does not exceed 8% of their compensation. The employer safe harbor non-elective matching contribution for the Plan year ended December 31, 2024 is equal to 3% of each eligible participant's compensation. Participants direct the investment of the employer matching contribution into various investment options offered by the Plan.

Each year the employer discretionary profit-sharing contribution is an amount determined and authorized by the Company. The employer discretionary profit-sharing contribution for the Plan year ended December 31, 2024 is equal to 5% of each participant's compensation. Participants direct the investment of their allocated Company contribution into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) earnings and (c) forfeitures of terminated participants' non-vested accounts, and charged with an allocation of administration expenses not paid by the Company, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and in the employer safe harbor matching contributions, plus actual earnings therein. Vesting in the employer matching and in the employer discretionary profit-sharing contribution portion of their accounts is based on years of services, as defined below:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested interest. Only one loan is allowed outstanding at a time. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence up to 20 years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Payment of Benefits

The Plan is intended for long-term savings but provides for earlier withdrawals under certain conditions. On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdraw an amount at age 59½ if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited and unallocated non-vested accounts totaled \$553,473 and \$170,666, respectively. Amounts forfeited may be used to restore forfeited accounts, reduce Plan expenses and, at the option of the Company, to fund future Company contributions to the Plan. During 2024, no forfeitures were used to pay Plan administrative expenses. Approximately \$287,000 of the forfeited funds were used to fund employer contributions in 2024.

Forfeitures may be allocated among eligible Plan participants. During 2024, \$440,746 was allocated to participants from the forfeiture account.

2. Summary of Accounting Policies

Basis of Presentation

The accompanying statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks, Uncertainties, and Concentrations

Plan assets are invested in funds and securities as directed by plan participants. These investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Accordingly, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024 and 2023, there were five investments and two investments that represented 56% and 26% of total investments, respectively. Those investments are the only investments that represented more than 10% of investments held. See the Schedule of Assets (Held at End of Year) for a complete list of investments as of December 31, 2024.

Contributions and Contributions Receivable

Contributions are recorded on the accrual method of accounting. Contributions receivable are obligations arising from amounts owed to the Plan from participants or the Company that have not been included in the Plan's investments at year end. Contributions receivable are recorded at cost, which approximates their fair value.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 or 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Interest on the loan is set at the time of issuance, and the rate is the prime rate plus 1%. At December 31, 2024, interest rates range from 4.25% to 9.50%. Notes receivable from participants are reported at their outstanding principal plus any accrued interest.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefit

Benefits are recorded when paid.

Administrative Expenses

Although not obligated to, the Company pays a portion of all administrative expenses of the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information

certified as complete and accurate by Fidelity Management Trust Company (Trustee) and Nationwide Life Insurance Company and Nationwide Trust Company, FSB (Nationwide or Former Trustees), qualified institutions.

The Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Accounting Standards Codification (ASC) 820 are described below:

Basis of Fair Value Measurement

Level 1 - This level consists of unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 - This level consists of quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3 - This level consists of prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Collective Investment Trusts (CITs) - CITs are valued at the net asset value (NAV) of units held and are published daily on NASDAQ. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing. As a result, these investments are considered to be a Level 2 measurement classification.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. As a result, these investments are considered to be a Level 1 measurement classification.

Pooled Separate Accounts - Pooled separate accounts are valued based upon unit values calculated for each underlying mutual fund, using data including the mutual fund's net asset value, dividends,

capital gains, administrative charge, net investment factor and interest rates. As a result, these investments are considered to be a Level 2 measurement classification.

5. Financial Assets Carried at Contract Value

At December 31, 2023, the Plan's investments included a benefit-responsive investment contract with Nationwide. In May 2024, the Plan entered into a new contract with the Putnam Fiduciary Trust Company, LLC. Nationwide and Putnam Fiduciary Trust Company, LLC maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Nationwide and the Putnam Fiduciary Trust Company, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

6. Related Party and Party-in-Interest Transactions

Plan investments are managed by the Trustees, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. A portion of fees paid by the Plan for the investment management services are included in net appreciation or depreciation in fair value of investments. Remaining fees paid by the Plan for investment management services and fees for contract administrator services amounted to \$254,327 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. Plan Termination

Although it has not expressed such intent, the Company reserves the right to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

8. Tax Status

The Internal Revenue Service has determined and informed the volume submitter by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

9. Subsequent Events

In preparation of its financial statements, the Plan considered subsequent events through September 10, 2025, which was the date the Plan's financial statements were available to be issued.
