### 1. Description of Plan

The following description of H.O. Bouchard, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

#### General

The Plan is a tax-exempt defined contribution plan covering substantially all employees of H.O. Bouchard, Inc. and Comstock Woodlands Corporation (collectively, the Company). The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan, which received a favorable advisory letter dated June 30, 2020, stating that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may contribute up to the maximum amount of their compensation as allowed by the Code. The Company may contribute a matching contribution as well as a discretionary profit sharing contribution. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

### 2. Summary of Significant Accounting Policies

#### Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

The Federated Capital Preservation Fund is a common collective trust. The investment objective of the Federated Capital Preservation Fund is stability of principal and high current income. Withdrawals from the Federated Capital Preservation Fund are permitted at any time by participants for benefit payments, transfer of investment elections, and payment of fees. All other participant redemptions are subject to a twelve-month advance written notice requirement.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued, but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **Administrative Expenses**

Substantially all administrative expenses are paid by the Plan. Administrative expenses paid by the Plan to the Plan recordkeeper and advisor totaled \$57,120 in 2024.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

### **Subsequent Events**

Management has considered transactions or events occurring through September 16, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Information Prepared and Certified by Custodian**

Information included in the financial statements and supplemental schedule relating to investments, investment transactions, notes receivable from participants, net appreciation in fair value of investments, and interest and dividends was obtained by management and agreed to or derived from the information certified to be complete and accurate by Ascensus, LLC, the custodian. ### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability; and  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual funds:* Valued at the quoted net asset value (NAV) of units held by the Plan at year-end.

*Common collective trust - Federated Capital Preservation Fund:* Valued daily based on the established NAV per unit of \$10.00. The fund attempts to maintain a stable price per unit of \$10.00; however, there can be no assurance that the value of the units in the fund will not fluctuate. The principal value per unit of the fund is determined at the end of each day by dividing net assets by the number of units outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
