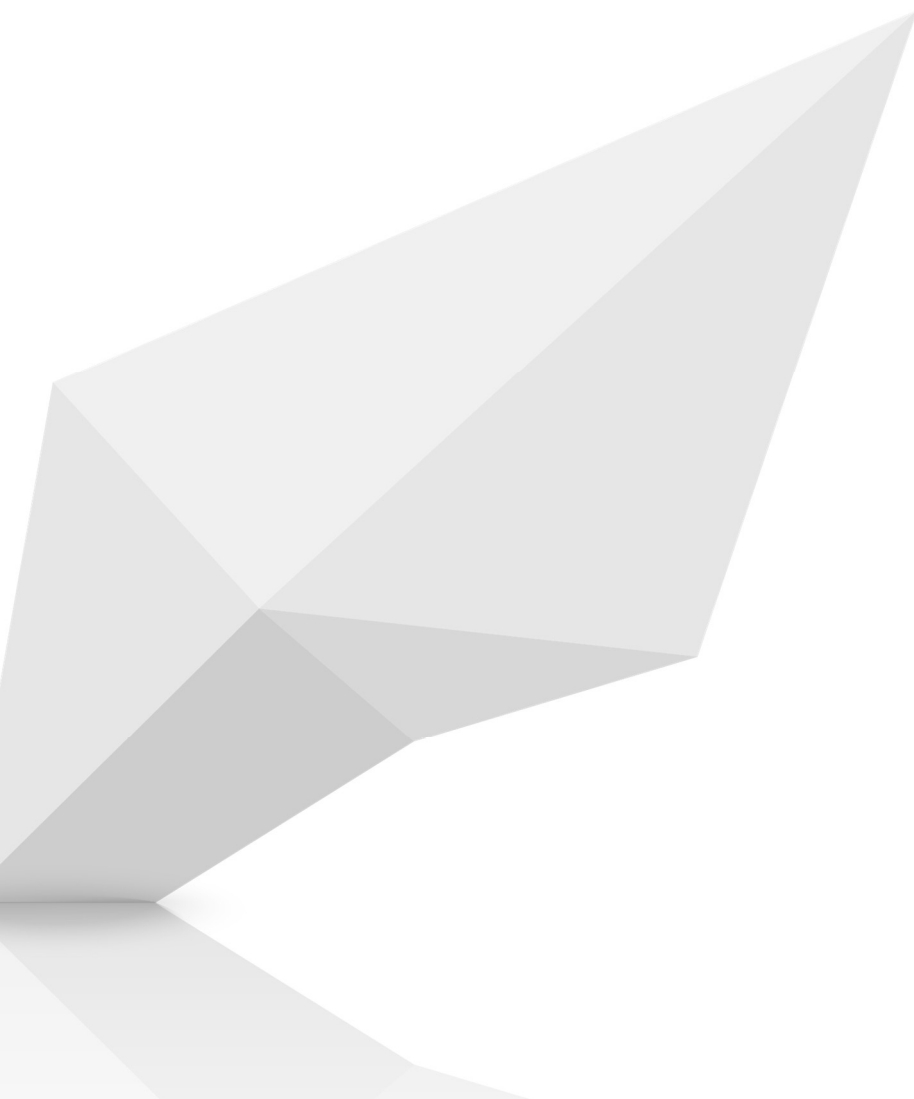

### **Note 1: Description of Plan**

The following description of the Knight Hawk Coal, LLC 401(k) P/S Plan & Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was adopted on August 1, 1998, by Knight Hawk Coal, LLC (the Plan Sponsor) and restated on January 1, 2023. The Plan was also restated subsequent to December 31, 2024 on January 1, 2025. The Plan is a defined contribution plan for the benefit of the Plan Sponsor's employees, who have worked at least 500 hours within six months of service and are age 19 or older. Prior to January 1, 2024, Long-Term Part-Time (LTPT) employees are part-time employees who have not entered the Plan as a regular participant, but who are credited with at least three consecutive years beginning after December 31, 2020, with at least 500 Hours of Service in each year, and are age 21. With the SECURE 2.0 Act (defined below), LTPT employees now only need to have two consecutive years with 500 Hours of Service in each year. An employee will become eligible for participation after completing the Plan's eligibility requirements as stated in the Plan Agreement.

#### **SECURE 2.0 Act**

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. In accordance with SECURE 2.0, the Plan increased the age for required minimum distributions (RMD) from age 72 to age 73 effective January 2023. Further changes set forth in the SECURE 2.0 Act include eliminating pre-death RMD rules for Roth accounts and several voluntary changes to distribution provisions, effective January 2024. The Plan is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### **Contributions**

Participants may defer salary up to an annual maximum of the lesser of 100% of eligible compensation or the amount specified by the Internal Revenue Service (IRS) for the years ended December 31, 2024 and 2023. The total of employee and employer contributions for a given year cannot exceed the lesser of the IRS limits or 100% of the employee's annual compensation. Participants may contribute as pretax 401(k) contributions and Roth 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover distributions from other qualified defined benefit or defined contribution plans.

### **Note 1: Description of Plan (Continued)**

#### **Contributions (Continued)**

The Plan has automatic enrollment at a rate of 5% of compensation after meeting the eligibility requirements above. Employees who opt out of automatic enrollment must complete a form to decline participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Each year the Plan Sponsor may make rigid discretionary matching contributions to be determined annually based on a percentage of employee salary deferrals.

In addition, the Plan Sponsor may make a discretionary nonelective contribution to be determined by the Plan Sponsor. Each eligible participant employed by the Plan Sponsor on the last day of the Plan year will receive a portion of the discretionary nonelective contribution based on a uniform allocation percentage of participant compensation.

#### **Participant Investment Account Options**

Upon enrollment in the Plan, participants may direct contributions in any of the applicable investment options available to Plan participants.

#### **Participant Accounts**

Each participant account is credited with the participant's contributions, employer matching contributions and an allocation of the Plan Sponsor's discretionary nonelective contribution, if any, and an allocation of the Plan's earnings. Each account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account balance is based on years of continuous service. A participant is 20% vested with each annual service year and is 100% vested at the end of five credited service years.

#### **Forfeitures**

Participants who terminate their employment and are less than 100% vested in their employer's contributions forfeit their non-vested portion. Forfeitures are retained by the Plan to reduce employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$105,318 and \$145,755, respectively. Forfeitures of \$145,792 were used to reduce employer contributions during the year ended December 31, 2024.

### **Note 1: Description of Plan (Continued)**

#### **Payment of Benefits**

The Plan provides for retirement benefits to begin at the age of 65. Upon death and total or permanent disability of a participant while employed, the account balance becomes fully vested.

On termination of service, participants with vested account balances less than \$7,000 will receive a lump sum amount equal to the value of their vested account balance. The distribution will be made as soon as administratively feasible. Participants may elect to receive the distribution or have the distribution paid as a direct rollover to another qualified plan. Participants with account balances exceeding \$7,000 will have their funds maintained in the Plan until a written request is submitted to the Plan Sponsor for payment.

Participants may withdraw from the Plan the portion of their account resulting from salary deferrals, employer matching contributions, and discretionary nonelective contributions upon reaching age 59.5. In the event of undue financial hardship as defined by ERISA, participants may withdraw from the Plan only from their participant salary deferrals and cannot exceed the amount of the participant's immediate and heavy financial need.

Benefit payments to participants are recorded upon distribution.

#### **Notes Receivable From Participants**

Participants may borrow from the Plan and may only have one loan outstanding at a time. Loans are made in any amount greater than \$1,000, but less than 50% of the participant's vested account balance. In no event can the participant borrow more than \$50,000. Loan transactions are treated as transfers from the investment funds to the participant loan accounts. Loan terms range from one to five years or up to fifteen years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at 1.0% over the prime interest rate, as determined by the Plan Administrator. Interest rates range from 4.3% to 9.5%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Notes receivable from participants are reported at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Use of Estimates**

The preparation of financial statements, in conformity with U.S. GAAP, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimated amounts.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value with the exception of the common collective trust which is stated at net asset value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 3 for discussion of fair value measurements and investments measured at net asset value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Administrative Expenses**

Administrative expenses of the Plan are paid both by the Plan Sponsor and the participants of the Plan.

#### **Subsequent Events**

As stated in Note 1, the Plan was restated on January 1, 2025 to continue to apply with applicable rules and regulations.

The Plan has evaluated subsequent events through September 18, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs according to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level I - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level III - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These investments are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Common collective trust:* Composed primarily of fully benefit-responsive investment contracts that are valued at net asset value of units of the fund's collective trust. The net asset value is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an account different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments, or other redemption restrictions or notice periods.

### Note 4: Party-In-Interest Transactions

The Plan Sponsor provides certain administrative services at no cost to the Plan.

Certain Plan investments are shares of mutual funds managed by Alerus Financial N.A. Therefore, these transactions qualify as party-in-interest transactions. The fees paid by the Plan for the investment management services are netted with the investment income on each investment option of the Plan for the year ended December 31, 2024. Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee received compensation from the Plan.

### **Note 5: Tax Status**

The Plan is a volume submitter Plan that received a favorable advisory letter from the IRS on June 30, 2020 which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related Plan was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **Note 6: Information Prepared and Certified by Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, at fair value and notes receivable from participants at December 31, 2024 and 2023 and total investment income and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial N.A., the Trustee of the Plan.

### **Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8: Asset Transfer in from ICG Illinois, LLC Retirement Plan**

During the year ended December 31, 2024, certain employees transferred their legal employment from ICG Illinois, LLC Retirement Plan ("ICG Plan") to the Plan. Under IRS regulations, both plans have controlled group status due to the common ownership over the plan sponsors (or companies) over both plans. Therefore, these amounts are presented on the statement of changes in net assets available for benefits as assets transferred in from ICG Illinois, LLC Retirement Plan to align with IRS reporting on the Form 5500.
