

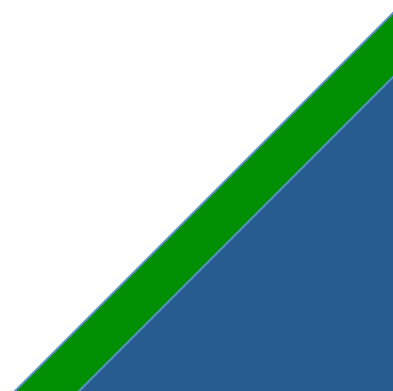

## INDEPENDENT AUDITOR'S REPORT

Board of Trustees and Participants  
Building Crafts, Inc. Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Building Crafts, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Building Crafts, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Building Crafts, Inc. Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Basis of Accounting**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Building Crafts, Inc. Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **NOTE 1 - DESCRIPTION OF PLAN**

The following brief description of the Building Crafts, Inc. Retirement Savings Plan (the "Plan") is provided for general information purposes only. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participants should refer to the Plan document for more complete information.

##### **General**

The Directors of the Association of National Government Contractors, Inc. ("Association"), as Sponsor, established the National Benefit 401-PW Plan effective July 1, 1996. Building Crafts, Inc. (the "Company") executed an Adoption Agreement on October 1, 1997. However, effective January 1, 2002, the National Benefit 401-PW Plan was amended and restated in its entirety by executing the Polaris Plus Adoption Agreement No. 002 and adopting the Beneco Polaris Plan and Trust. The name was changed to Building Crafts, Inc. Retirement Savings Plan. The Sponsor of the Beneco Polaris Master Plan and Trust is Beneco, Inc. promulgates the Plan for the benefit of employees of eligible employers. The Plan was restated January 1, 2022.

Effective January 1, 2023, the Plan was amended to exclude commissions and bonuses from the definition of compensation.

BCI Enterprise, Inc. owns 100% of the Company, BCI Water Resources Group Inc., BCI Water Resources Group International, Inc., and BCI Staffing, Inc. BCI Enterprises, Inc., BCI Water Resources Group, Inc., BCI Water Resources Group International, Inc., and BCI Staffing have adopted the Plan and such Adopting Employer agrees to be bound by the terms of the Plan.

##### **Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Employees have the option to make pension contributions for work performed under prevailing wage contracts. Prevailing wage contributions are made to the Plan by the Company on behalf of the employees are based on the wage rate and job classification of the employees and is subject to certain IRC limitations. Prevailing wage contributions were \$1,381,700 for the year ended December 31, 2024. The Plan has the option to make a discretionary Company matching contribution based on salary deferrals. There were no matching contributions for the year ended December 31, 2024. The Plan may also make a discretionary Company profit-sharing contribution. The profit-sharing contribution was \$273,706 for the year ended December 31, 2023 paid in 2024.

**NOTE 1 - DESCRIPTION OF PLAN (Continued)****Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participants' account is credited with the participants' contribution, the Company's discretionary matching and profit sharing contributions, and earnings or losses generated from the participant's selected investment options. Allocations are based on participant earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan. At all times during 2024 and 2023, the Plan offered at least twenty mutual funds and a stable value fund as investment options for participants.

**Vesting**

Participants are vested immediately in their contributions plus actual net earnings thereon. Vesting in the Company's profit-sharing and matching contributions is based on years of service. Participants are 100% vested in the Company's profit-sharing and matching contributions upon completion of three years of credited service (defined as having worked at least 1,000 hours per year). Participants are vested immediately in the Company's prevailing wage contributions.

**Benefit Payments**

On termination of service or disability, retirement, or death a participant or beneficiary may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, rollover their account balance to another retirement account or plan, or receive annual payments from their account over the participant's life expectancy.

**Administration Expenses**

Administrative expenses of the Plan are paid by the Plan or Plan Sponsor as provided in the Plan document.

**Forfeitures**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account as defined by the Plan, represents a forfeiture. The Plan document permits the use of forfeitures to reduce future employer contributions or pay administrative expenses for the Plan year. At December 31, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$5,713. During 2024, no forfeitures were used to reduce employer contributions.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES****Basis of Accounting**

The accompanying financial statements of the Plan are presented on the modified cash basis of accounting and conform to the accounting requirements of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under that basis, certain revenues and the related assets are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligation is incurred. That basis differs from generally accepted accounting principles primarily because the Plan has not recognized accounts receivable for employer contributions and accounts payable to vendors and their related effects on earnings in the accompanying financial statements.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Common collective trusts are valued at the net asset value of the shares held by the Plan at year-end as a practical expedient, which is based on the fair value of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan in 2024, but had not yet been paid at December 31, 2024.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

**NOTE 4 - INCOME TAX STATUS**

The Company adopted a volume submitter which received an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") stating that the volume submitter document, in form only, meets the requirements under the applicable sections of the IRC and is therefore qualified. The Plan has not obtained a separate determination letter from the IRS, nor is it required to do so. The Company and the Plan Administrator believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 5 - RISKS AND UNCERTAINTIES**

The Plan utilizes mutual fund investment instruments and a stable value fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**NOTE 6 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Matrix Trust Company, the trustee.

**NOTE 7 - FAIR VALUE MEASUREMENT**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were used by the Plan.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Galliard Stable Value C Fund (formerly known as Wells Fargo Stable Value Fund C) is a common collective trust ("CCT"). The CCT invests in a group annuity contract which includes underlying assets that are held in a trust owned by Galliard Capital Management, LLC. The CCT, simulates the performance of a guaranteed investment contract through an issuer's guarantee of a specific interest rate and portfolio of financial investments that are owned by the issuer, Galliard Capital Management, LLC.

**NOTE 8 - COMMON COLLECTIVE TRUST (Continued)**

Participants will receive the principal and accrued earnings credited to their accounts upon withdrawal for allowed events. These events include transfers to other Plan investment options, payments because of retirement, termination of employment, disability, death, and in-service withdrawals as permitted by the Plan. Certain events such as Plan termination or a Plan merger initiated by the Plan sponsor, may limit the ability of the Plan to transact at contract value. The Plan sponsor does not believe any events that may limit the ability of the Plan to transact at contract value are probable.
