Note 1. Description of the Plan

The following description of The B&W Thrift Plan (the “B&W Plan”) provides only general information. Participants should refer to the Summary Plan Description for more detailed information or to the official plan documents for complete information.

General

The B&W Plan is a defined contribution plan administered by The Babcock & Wilcox Benefits Committee (the “Committee”). Vanguard Fiduciary Trust Company (the “Trustee”), a wholly owned subsidiary of The Vanguard Group, Inc. (“Vanguard”), is the trustee of the trust that holds the assets of the B&W Plan. Recordkeeping and investment management of the funds, as selected by the Committee, is the responsibility of Vanguard.

The B&W Plan offers investment funds managed by Vanguard and Babcock & Wilcox (“B&W”).

The B&W Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Substantially all employees of the Babcock & Wilcox Company (“the Company”) and participating subsidiary and affiliated companies are generally eligible to participate in the B&W Plan. Exceptions include non-resident alien employees who do not earn income in the United States, leased employees, independent contractors, employees under certain collective bargaining agreements, and employees who regularly work less than 30 hours per week, unless they complete a year of service, as defined in the B&W Plan document.

Contributions

A participant may generally elect to make contributions to the B&W Plan in an amount ranging from 1% to 75% of the participant’s compensation up to a maximum amount established annually by the Internal Revenue Service (“IRS”), subject to certain limited exceptions for employees under certain collective bargaining agreements. Participants 50 and older are allowed to make certain additional contributions above these normal limits, subject to certain limited exceptions for employees under certain collective bargaining agreements. Contributions on a pre-tax, after-tax or Roth basis, up to the first 8% of a participant’s eligible compensation are considered basic contributions under the B&W Plan and any additional contributions up to 25% of eligible compensation are considered supplemental contributions. Subject to certain limited exceptions for employees under certain collective bargaining agreements, new employees are automatically enrolled in the B&W Plan at the 8% employee contribution level on a pre-tax basis, with the rate of contribution automatically increasing by 1% annually each January until the contribution reaches 10%, and with an option to elect out of contributing to the B&W Plan at any time. Rollover contributions from other plans are accepted provided certain specified conditions are met.

Subject to certain limited exceptions for employees under certain collective bargaining agreements, Company matching contributions are made in amounts equal to one-half of the participants’ basic contributions. Matching contributions are typically made in cash.

Participants’ Accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and investment gains, and charged with withdrawals, investment losses and administrative expenses. The benefits to which a participant is entitled is the benefit that can be provided from the participant’s vested account under the B&W Plan.

Participants in the B&W Plan are entitled to transfer, in 1% increments and in unlimited number, subject to any restrictions set forth in the prospectus of the investment options, their accumulated participant and Company contributions and related fund earnings to other investment options, subject to the following restrictions: (a) transfers to the B&W Stock Fund are restricted to Company contributions plus gains and losses that were originally invested in the B&W Stock Fund and transferred out of that fund, (b) participants cannot transfer into and out of the same fund effective on the same valuation date, (c) if a participant moves money out of an investment fund, the participant cannot move money back into the same fund for 60 calendar days and (d) participants cannot contribute to the B&W Stock Fund.

Vesting

All participants are 100% vested in participant contributions and rollover contributions made to the B&W Plan. Participants vest in Company contributions and earnings at retirement or death while employed, disability, involuntary termination for reasons other than cause or after three years of service.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of (1) \$50,000 minus the highest outstanding loan balance during the one-year period ending on the day before the new loan is made or (2) 50% of their vested account balance. Loans are repaid over a period not to exceed five years with exceptions for loans taken for the purchase of a primary residence. Participants may have only one loan outstanding at any one time. The loans are secured by the balance in the participants' accounts and bear interest at the Prime Rate received by the Trustee from Reuters, plus 1%. Principal and interest are generally paid ratably through payroll deductions.

Forfeitures

Forfeitures due to termination from the B&W Plan before a participant is 100% vested are used to reduce future Company contributions or to defray reasonable B&W Plan administrative expenses. Unallocated forfeited non-vested accounts totaled \$399,349 and \$449,148 on December 31, 2024, and 2023, respectively. During the year ended December 31, 2024, \$42,353 of forfeitures were used to offset B&W Plan expenses.

Payment of Benefits

Participants may elect in-service withdrawals of all or part of the value of their after-tax employee contributions, vested Company contributions, rollover contributions into the B&W Plan and any earnings on those funds. Withdrawals may only be made in any six-month period if the participant is under age 65 and may subject the participant to certain suspension periods during which contributions may not be made. Withdrawals of pre-tax and Roth employee contributions may be requested in the event of financial hardship or upon attainment of age 59 ½.

Upon termination of service for any reason, including death, disability, or retirement, a participant may elect to receive the vested value of his or her account as a lump-sum distribution, to roll over the funds to an IRA or other qualified plan, and/or to receive certain installment payments. Distributions are paid in cash except B&W common stock may be distributed in-kind.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend, terminate or otherwise modify the B&W Plan at any time, subject to the provisions of ERISA, solely at the discretion of the Board of Directors of the Company or its duly authorized delegates. In the event of plan termination, participants will immediately become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (“U.S. GAAP”).

Use of Estimates

The preparation of these financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Such estimates include those regarding fair value. Actual results could differ from those estimates and those differences could be material.

Risks and Uncertainties

The B&W Plan provides for various investment options, including mutual funds, collective trust funds, and B&W stock. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

The B&W Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the B&W Plan. Collective trust funds with underlying investments in benefit-responsive investment contracts are valued at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the B&W Plan. The B&W Stock Fund is valued at its year-end unit closing price (comprised of year-end market price plus un-invested cash position), which approximates fair value.

The B&W Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation in the fair value of its investments, which consists of realized gains and losses upon the sale of investments and the unrealized appreciation and depreciation of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged for investments in the mutual funds and collective trust funds are embedded in their trading prices and are not separately reflected. Consequently, management fees and operating fees are reflected as a reduction of investment return for such investments within the line described as net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable are reclassified as benefits paid based upon the terms of the B&W plan document. Loans bear interest at rates ranging from 2.85% to 9.50%.

Payment of Benefits

Benefits are recorded when paid and are based on the fair value of the respective funds at the effective date of the withdrawal. Benefits are paid in cash except that B&W common stock may be distributed in-kind if elected by the participant.

Administration Fees and Investment Expenses

Administrative expenses of the B&W Plan are paid by the B&W Plan, or the Company as provided in the B&W plan document. Administrative expenses reported in these statements reflect only those expenses paid by the B&W Plan and may include recordkeeping and other participant-initiated transaction-based fees.

Subsequent Events

The Plan has evaluated the effect subsequent events through would have on the financial statements through September 18, 2025, which is the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The FASB Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* ("ASC 820"), defines fair value as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. ASC 820 also expands the disclosure requirements around fair value and establishes a hierarchy for valuation inputs that emphasizes the use of observable inputs when measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Categorization of instruments within the fair level hierarchy is based upon the lowest level of input that is significant to the fair value measurement. The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the primary valuation methodologies used to measure the fair value of each class of B&W Plan assets.

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Company Stock Fund

These funds are valued based on the last quoted price on the listed exchange.

Money Market Fund

These funds are valued at the notional monetary amount held by the B&W Plan.

Note 4. Guaranteed Investment Contracts

The Plan held investments in the Lincoln Stable Value Account, the Vanguard Retirement Savings Trust II and the Vanguard Retirement Savings Trust III, in traditional contracts for the years ended December 31, 2024 and 2023. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the disaggregation of contract for the type of investment contract held by the Plan.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers with a guaranteed minimum interest rate of 1.70%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

Note 5. Unaudited Information Certified by the Trustee

The accompanying financial statements include the following unaudited information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that was obtained from data prepared and certified to be complete and accurate by the Plan's trustee.

Note 6. Income Tax Status

The IRS has determined and informed the Company by a letter dated April 27, 2017, that the B&W Plan is qualified under the applicable regulations of the Internal Revenue Code, subject to the adoption of certain proposed amendments provided by the IRS. The Committee believes that because the B&W Plan is qualified, the related Trust is exempt from taxation.

U.S. GAAP requires plan management to evaluate tax positions taken by the B&W Plan and recognize a tax liability if the B&W Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by the IRS. The Company's management has analyzed tax positions taken by the B&W Plan and has concluded that, as of December 31, 2024, and 2023, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The B&W Plan is subject to routine audits by taxing jurisdictions. Currently no audits for any tax periods are in progress.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 8. Related Party Transactions

Participants in the B&W Plan invest in shares of mutual funds managed by an affiliate of the Trustee. Participant accounts may also hold shares of B&W common stock. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Participant loans also qualify as exempt party-in-interest transactions. The Company also provides administrative services to the B&W Plan and may pay certain administrative expenses of the B&W Plan with no reimbursement from the B&W Plan.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
