**NOTES TO FINANCIAL STATEMENTS**

---

**Note A - Description of the Plan**

The following description of the Graham Corporation Incentive Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan, which was established August 1, 1973, is a defined contribution plan for the benefit of the domestic employees of Graham Corporation (the Company). All domestic employees who have reached 18 years of age, are not interns or co-ops, covered by a collective bargaining unit, or leased employees, are eligible to participate in the Plan (certain temporary, part-time and seasonal employees are subject to a service requirement). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Graham Corporation Retirement Plan Committee, the members of which are identified by the plan document, is responsible for oversight of the Plan. The Graham Corporation Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and oversees Plan administration.

On November 9, 2023, the Company acquired P3 Technologies, LLC ("P3"), a custom turbomachinery engineering, product development, and manufacturing business, located in Jupiter, FL. P3 employees are considered employees of the Company and therefore, eligible to participate in the Plan as employees under the Plan's guidelines.

**Contributions**

Each year participants may contribute up to 100% of pre-tax compensation, as defined by the Plan, subject to maximum annual additions allowed by law. The Plan allows for Roth and Pre-Tax elective deferrals, as well as for traditional after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or to contribute at a different rate. Automatically enrolled participants have their pre-tax deferral rate set at 5% of eligible compensation, and their contributions are invested in a target date retirement fund until changed by the participant. The maximum employer safe harbor matching contribution is 100% of the first 3% and 50% of the next 2% of the employee's pre-tax and Roth contributions. The Company may also elect to make discretionary matching contributions, but has not elected to do so for the years ended December 31, 2024 and 2023.

All employees hired after December 31, 2002 are ineligible to participate in the Company's defined benefit plan. These employees, if employed on the last day of the plan year, receive the employer profit sharing contribution which is 3.25% of total compensation, as defined.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Note A - Description of the Plan - continued**

**Notes Receivable from Participants**

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 100 basis points at the time the funds are borrowed. Principal and interest payments on loans are re-deposited into the participants' accounts based on their current investment allocation elections. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other termination, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or may elect partial payments from the vested account. Hardship withdrawals are available to employed participants who experience qualifying hardships. The Plan also allows for In-Service withdrawals for participants who have attained the age of 59.5 or who are disabled, as well as In-Service withdrawals of after-tax and rollover contributions.

**Vesting**

Participants are immediately vested for employee and employer safe harbor matching contributions. Employees hired after December 31, 2002 who receive the employer profit sharing contribution in lieu of participation in the defined benefit plan vest in these contributions at a rate of 25% per year over four years of continuous service.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to first pay Plan administrative expenses or reduce future Company contributions. In 2024 and 2023, \$19,759 and \$40,562, respectively, of forfeitures were used to pay Plan expenses. The ending balance of forfeitures as of December 31, 2024 and 2023 was \$43,743 and \$7,218, respectively.

**Note B - Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan holds investment securities including a common collective trust, Company stock fund, and mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the financial statements.

**Note B - Summary of Significant Accounting Policies – continued**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance at year end plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. The Plan considers the notes receivable from participants fully collectible at year end; accordingly, no allowance for doubtful accounts is required. Delinquent notes receivable from participants are reclassified as distributions under the terms of the plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative expenses are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

As of January 1, 2023, the participants pay recordkeeping fees and the corresponding alteration of mutual fund share classes.

**Subsequent Events**

Management has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued. As of January 1, 2025, T. Rowe Price Trust Company became the Plan's trustee.

**Note C - Certified Financial Information**

The following information included in the accompanying financial statements and supplemental schedule for the calendar year 2023 was obtained from data that has been prepared and certified to as complete and accurate by the trustee, The Vanguard Group, Inc. The incorporation of this financial information in the accompanying financial statements for calendar year 2023 is based solely on the trustee's certification and has not been audited by independent accountants.

**Note D – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Graham Corporation stock fund** – Valued at the closing price reported on the active market on which the individual securities are traded.

**Common Collective trust** - Valued at the net asset value of shares held by the Plan at year end. This investment is comprised of fully benefit-responsive investment contracts issued by insurance companies and other financial institutions (“Contracts”), fixed income securities, and money market funds. Under the terms of the Contracts, the assets of the fund are invested in fixed income securities (which may include, but are not limited to, U.S. Treasury and agency bonds, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, asset backed securities, and collective investment vehicles and shares of investment companies that invest primarily in fixed income securities) and shares of money market funds. The net asset value (NAV) is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the common collective trust will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**Note E - Federal Income Tax Status**

The Plan adopted a non-standardized form of a pre-approved plan sponsored by the Vanguard Group. The pre-approved plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

**Note F - Party-in-Interest Transactions**

Certain Plan investments are managed by Vanguard Fiduciary Trust Company (Vanguard). Vanguard is the trustee and recordkeeper for the plan and, therefore, these transactions qualify as party-in-interest transactions. Participant loans and fees paid to Vanguard also qualify as party-in-interest transactions.

**Note G – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer profit sharing contributions.
