Notes to Financial Statements

1. Description of Plan

The following description of the Integra LifeSciences Corporation 401(k) Trust (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Integra LifeSciences Corporation 401(k) Trust is a defined contribution plan available to all employees of Integra LifeSciences Holdings Corporation and its domestic subsidiaries (the "Company") that are age eighteen and older. Full-time and part-time employees are eligible to participate in the Plan on the first day of the month following their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan is Vanguard Fiduciary Trust Company (the "Trustee"). The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Company are eligible to participate in the Plan on the first day of the calendar month following their date of hire as an employee, except for: (1) nonresident aliens with no U.S. source of income; (2) employees covered by a collective bargaining agreement that does not provide for participation in the Plan; (3) leased employees.

Contributions

Contributions are made to the Plan by participants through payroll deductions and by the Company on behalf of participants. Such contributions are invested in any of the investment funds offered, at the discretion of the participating employees. Participants can contribute up to 50% of their base compensation on a before-tax basis up to \$23,000 in 2024. Participants age 50 and over are eligible to contribute extra pre-tax contributions above the annual Internal Revenue Service ("IRS") limitations up to \$7,500 in 2024. Plan participants are permitted to make Roth deferral contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans ("rollovers").

The Plan automatically enrolls new eligible employees at a 3% contribution on a pre-tax basis. Each year, the deferral rate will increase by 1% until the participant deferral reaches 6%. Participants may stop contributions, change, or increase their elections at any time, and will be provided opportunity to opt out within 60 days from their eligibility date.

The Plan allows for a discretionary employer matching contribution. For the year ended December 31, 2024, the Company matched 100% of participant contributions not in excess of 3% of participant compensation as defined by the Plan and 50% of participant contributions not in excess of 2% of participant compensation as defined by the Plan, without a maximum in the Plan year. The Company may make additional contribution at the discretion of the Company's Board of Director. There were no additional amounts contributed for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their individual deferral, Roth, and rollover contributions and the allocated earnings thereon. Vesting in the Company contributed portion of participants' accounts plus any earnings are vested 100% after two years of service with the Company.

Forfeitures

If participants leave the Company prior to becoming fully vested in the amounts contributed by the Company, they forfeit their unvested balance. These accounts may be used to pay administrative expenses and reduce future employer contributions.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$160,436 and \$106,647, respectively. \$942,609 of the forfeited funds were used to pay administrative expenses and/or fund employer contributions in 2024.

Investment Options

A participant may invest in one or more funds in increments of 1%. The investment mix chosen by the participant will apply to employee, employer, and any rollover contributions made. All dividend and interest income is reinvested by the Trustee. Distributions to participants are accomplished by liquidating investments.

Participants may change the amount they contribute to the Plan daily and change their allocation between funds daily. However, changes to contribution amounts are processed less frequently based on payroll schedules.

A participant shall be 100% vested upon termination of employment by reason of death, retirement or disability.

Payment of Benefits

Benefits are paid to participants upon termination of employment, deemed severance from employment while performing military service, disability, or retirement. Participants can elect to defer payment until age 72 if account balances are greater than \$5,000. A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments not to exceed the participant's life expectancy upon termination of employment due to death, deemed severance from employment while performing military service, disability, or retirement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

If the balance of a participant's vested individual account, excluding amounts attributable to rollover contributions, is no more than \$5,000, the participant's benefits will be paid in a single lump-sum payment. Generally, a participant may choose to receive the lump-sum payment in cash or to have all or a portion of the payment rolled over to another eligible employer plan which accepts rollovers or to an individual retirement account ("IRA") or annuity in a direct rollover.

Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum note amount is \$1,000. Note terms generally range from one to five years. Longer terms are permitted if the note is for the purchase of a principal residence. The notes receivable are collateralized by the balance in the participant's account and bear interest at rates that range from 4.00% to 9.5%, which are commensurate with prevailing rates as determined by the plan administrator at loan inception. All payments of principal and interest on a note are made ratably through payroll deductions and are credited to the participant's account.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Notes to Financial Statements

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Additional Company's contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expenses when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Plan Revenue Account

The Plan's trust agreement with Vanguard provides for a plan revenue account arrangement, whereby the Plan receives budgeted administrative expense deductions from the revenue credits generated by certain Vanguard investments. Unallocated revenue credits at December 31, 2024 and 2023 are \$53,335 and \$50,555, respectively. No revenue credits were used by the Plan to pay administrative expenses during 2024.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company ("Vanguard"), a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Money Market Funds: Valued at cost which approximates fair value.

Mutual Funds: Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts ("CCTs"): Common collective trusts are valued at the net asset value ("NAV") of units held. The NAV, as provided by the trustee of the CCTs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. The CCTs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Parties-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Vanguard, the trustee. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules. Participant loan processing fees are paid to Vanguard by participants. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. The Plan has a Plan Revenue Account ("PRA") with Vanguard, see Note 2. Transactions through the PRA would qualify as party-in-interest transactions. Participant loans are also considered party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their employer contributions. Any unallocated assets of the Plan should be allocated and distributed in such a manner as the Company may determine.

7. Tax Status

The IRS has determined and informed the Plan by an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan sponsor is responsible for reviewing the annual Required Amendments List issued by the IRS for individually designed plans to retain qualified tax status. Plan management believes that the Plan and the related trust is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated all events subsequent to December 31, 2024 through September 19, 2025, the date the financial statements were available to be issued.
