INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator and Management
Chuy's Opco, Inc. 401(k) Plan**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Chuy's Opco, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of April 1, 2025, and December 31, 2024, and the related statement of changes in net assets available for benefits for the period January 1, 2025, to April 1, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Chuy's Opco, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution for the period January 1, 2025, to April 1, 2025, and as of December 31, 2024, and for the for the period ended April 1, 2025, stating that the certified investment information, as described in Note C. to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Chuy's Opco, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Chuy's Opco, Inc. 401(k) Plan Notes to Financial Statements

A. Description of the Plan

The following description of the Chuy's Opco, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Chuy's Opco, Inc. 401(k) Plan (the Plan), is a defined contribution plan that became effective on November 7, 2006, and is maintained for the benefit of employees of Chuy's Opco, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Principal Life Insurance Company and Principal Trust Company (collectively referred to as "Principal") serve as the Plan custodians.

On October 11, 2024, the Company was acquired by Darden Restaurants, Inc. See further discussion in Note L. below.

Secure 2.0 Act. The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and included mandatory and optional provisions with varying effective dates in 2024, and later. The Company has until the end of the first plan year beginning on or after January 1, 2025, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Eligibility. Each employee of the Company is eligible to participate in the Plan as of the first day of January, April, July, or October after the employee has attained age 21 and completed one year of service, except for leased employees and independent contractors. A year of service for eligibility is defined as the twelve months beginning with the date an employee first performs an hour of service for the Company and in which the employee performs at least 1,000 hours of service. If an employee does not satisfy the year of service requirement in his initial twelve-month period, subsequent twelve-month periods for purposes of determining year of service shall be based on the calendar year.

Contributions. Participants may contribute to the Plan through payroll deductions from 1% to 100% of annual compensation, as defined by the Plan. Participant salary deferral contributions are limited by the Internal Revenue Code to \$23,500 for 2025. In addition, participants who have attained age 50 are permitted to contribute additional "catch-up" salary deferrals. A participant may designate all or a portion of his or her salary deferrals as Roth deferrals contributed on an after-tax basis. Participants are allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans.

At the discretion of the Company, the Company may declare matching contributions. The Company's matching contribution for the year, if any, is allocated to participants who have contributed salary deferrals to the Plan for the year and have completed at least 501 hours of service for the year or are employed on the last day of the year. For the period ended April 1, 2025, the Company declared and funded matching contributions of \$61,275.

The Company may also contribute, but is not required to do so, a profit sharing amount to be allocated to all participants who have completed at least 501 hours of service in the year or are employed on the last day of the year.

The profit sharing contribution, if any, is allocated to all eligible participants based on compensation. The Company did not declare or fund a profit sharing contribution for the period ended April 1, 2025.

Participant Accounts. Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings and may be charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participants are immediately and fully vested in their salary deferrals, participant rollovers, and earnings thereon. Vesting in the Company's profit sharing and matching contributions, if any, plus earnings thereon are based on years of service completed. A participant is fully vested in the Company's profit sharing and matching contributions and earnings thereon, after completing three years of service. A year of service for vesting purposes is any calendar year during which the employee performs 1,000 hours or more of service for the Company. Amounts not vested at the time a participant terminates service are forfeited and are allocated to eligible participants or as noted below, may be used to reduce future employer contributions. Participants who attain age 65 while in the service of the Company or terminate service due to death or total disability become fully vested in their account balances.

Payment of Benefits. Upon termination of employment, a participant will receive the value of the vested interest in his or her account in a lump-sum distribution. The Plan does not permit distributions prior to termination of service except for participants who have attained age 59½ or for hardship withdrawals in the event of immediate and heavy financial needs for the purchase of a principal residence, the payment of medical expenses, payment of post-secondary education, or payment for the cost of preventing eviction from or foreclosure on the mortgage of a principal residence. The amount of the hardship withdrawal may not exceed the amount of the financial need. A participant may not receive a hardship withdrawal unless all other available distributions and loans from this Plan have been obtained.

Forfeited Accounts. At April 1, 2025, and December 31, 2024, forfeited nonvested accounts were \$2,251 and \$2,667, respectively. Forfeitures used to pay certain Plan expenses and forfeitures applied for the period ended April 1, 2025, were \$2,504.

A. Description of the Plan (continued)

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates.

Principal and interest are repaid ratably through payroll deductions over a period not to exceed five years, except in the case of a loan used to acquire a participant's principal residence. Interest earnings on these loans are allocated to the specific participant's account.

Expenses of the Plan. Certain expenses incurred in the administration and operation of the Plan are paid by the Plan and are allocated to participants' accounts. Expenses incurred by the Plan for the period ended April 1, 2025, were \$23,250. The Company pays certain other expenses incurred in the administration and operation of the Plan.

B. Summary of Significant Accounting Policies

Basis of Accounting. The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition. The Plan's investments, other than fully benefit-responsive investment contracts which are reported at contract value, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D. for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

Use of Estimates. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Contributions. Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

B. Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Recent Accounting Pronouncements. The Company reviewed all other recently issued accounting pronouncements and concluded that they were not applicable or not expected to have a significant impact on the financial statements.

Subsequent Events. The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

C. Certified Investments

Certain information in the accompanying financial statements related to certain investments held as of April 1, 2025, and December 31, 2024, totaling \$0 and \$17,115,783, respectively, April 1, 2025, and net appreciation in fair value of investments, and interest and dividends for the year ended April 1, 2025, totaling (\$129,439) was obtained by management agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, the Plan custodians.

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques and used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under "ASC 820, Fair Value Measurements," are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of nonobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 1, 2025, and December 31, 2024.

The Plan maintains direct investments in investment funds, which are fully benefit-responsive investment contracts. The Plan measures the fair value of these investment contracts using the Net Asset Value ("NAV") (or its equivalent) per share practical expedient as of April 1, 2025, and December 31, 2024, and, therefore, not classified using the fair value hierarchy. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Pooled separate accounts: Pooled separate accounts invest primarily in domestic stocks. The majority of the underlying securities have observable Level 1 quoted pricing inputs. The NAV is the basis for current transactions, and the pooled separate accounts can be redeemed at NAV as of the measurement date. Therefore, we believe this investment to have a readily determinable fair value and as it is valued similarly to mutual funds, we believe they should be classified as Level 1 investments.

Common Collective trust funds: Common collective trusts invest in a collective trust fund as well as separate accounts and mutual funds. The fair value of the collective investment trust and separate accounts are not publicly quoted pricing inputs. The fair value of the mutual funds is publicly quoted pricing inputs (Level 1). The fair value of all these investments is used in determining the NAV of the collective trust funds.

The NAV is the basis for current transactions, and the collective trust fund can be redeemed at NAV as of the measurement date. Therefore, we believe this investment to have a readily determinable fair value and as it is valued similarly to mutual funds, we believe they should be classified as Level 1 investments.

Guaranteed investment funds: *Guaranteed* investment funds are valued at contract value, which approximates fair value.

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. As such, they are classified as Level 1 investments.

E. Investment Contracts With Insurance Company

The Plan offered, as an investment option, Principal Fixed Income Guaranteed Option. This is a fully benefit-responsive investment contract with Principal. Principal maintained the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The plan administrator does not believe that any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

The Plan also offered common collective trust funds that include Principal LifeTime Hybrid Collective Investment Trusts (CITs). CITs may invest in various types of investments, including Principal mutual funds, collective trust funds and pooled separate accounts.

The Plan also offered pooled separate accounts that includes Principal U.S. Property Separate Account, The Plan's investments in the separate account hold units of participation in the account.

Contributions and transfers to the separate account for the plan increase the Plan's total units of participation. Disbursements, deducted expenses, and transfers from the separate account for the plan decrease the Plan's total units of participation in the separate account. The Plan shares in the appreciation/depreciation of the separate account through the separate account's unit value.

The Plan's separate account market value at any given date is equal to the plan's units of participation multiplied by the unit value for the rate level chosen by the Plan administrator.

F. Participant-Directed Investments

The Plan permits participants to invest their account balance and contributions among investment options offered by the Plan. The Plan offers numerous investment options through the current plan custodian, Principal.

G. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are invested in pooled separate accounts, common collective trust funds and guaranteed investment funds managed by Principal. Principal is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Participant loans also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules.

H. Tax Status

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

H. Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

J. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

K. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and distributions will be made as soon as administratively practicable after the Plan terminates.

L. Plan Merger

On October 11, 2024, the Company was acquired by Darden Restaurants, Inc. Effective as of April 1, 2025, all associated assets, liabilities, and obligations of the Plan merged with and into the Darden Savings Plan, and each eligible Plan participant was enrolled in the Darden Savings Plan. As a result, the provisions of the Darden Savings Plan essentially replace the provisions of the Plan.

On April 1, 2025, Plan assets in the amount of \$16,228,632 were transferred from the Plan to the Darden Savings Plan.
