We have performed audits of the financial statements of RoadSafe Traffic Systems, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### Note 1. Plan Description

The following description of the RoadSafe Traffic Systems, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan, most recently restated and amended on March 15, 2022, covers all noncasual employees (defined as employees who are expected to work more than 1,000 hours in their first year of employment) and casual employees (defined as employees who are not expected to work 1,000 hours in their first year of employment), except for nonresident aliens, those employees whose employment is governed by a collective bargaining agreement, independent contractors and leased employees of RoadSafe Traffic Systems, Inc. and its wholly owned subsidiaries (collectively referred to as the Employer). Noncasual employees who have reached age 18 and who have completed 60 days of service, and casual employees who have reached age 18 and who have completed one year of service (defined as 1,000 hours worked) are eligible to participate in the Plan (Participants). Noncasual Participants may enter the Plan on the first day of the month after reaching age 18 and completing 60 days of service. Casual Participants may enter the Plan on the first day of the next calendar quarter (January 1, April 1, July 1 or October 1) after reaching age 18 and completing 60 days of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company (Principal), is the Trustee, custodian and record keeper of the Plan.

The Employer's Administrative Plan Committee is the Plan Administrator and is responsible for oversight of the Plan. The Administrative Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. All investments are 100% participant directed.

**Participant contributions:** Participant contributions to the Plan are deferrals of the employee's compensation, as defined. Each year, Participants may defer a minimum of 1% up to a maximum of 50% of their eligible compensation as defined by the Plan, not to exceed a dollar limit established under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (Participant Rollovers).

Employees, upon eligibility to participate in the Plan, will be automatically enrolled to defer 6% of their eligible compensation, as defined. On January 1 of each subsequent year, the automatic elective deferral contributions are increased by 1% up to a maximum of 10%. A participant may choose not to defer or may choose a different percentage once enrolled. Automatic enrollment deferrals are invested in the RetirePilot portfolio accounts based upon the employee's expected retirement date. The 6% pretax deferral election and the default investment option remain in effect until changed by the Participant.

#### **Employer contributions:**

**Matching contributions:** All Employer matching contributions are computed based on eligible compensation. A participant is entitled to Employer matching contributions once enrolled in the Plan and making deferral contributions. The Employer matches contributions in an amount equal to 50% of the elective deferral contributions on the first 5% of eligible compensation.

Under certain circumstances, the Employer may make additional matching contributions. The additional matching contribution percentage must be equal to or greater than the Employer contribution discussed above. No additional matching contributions were made for the year ended December 31, 2024.

#### Note 1. Plan Description (Continued)

**Discretionary nonelective employer contributions:** The Employer, at its discretion, may make nonelective employer contributions to the Plan as determined by its Board of Directors. For the year ended December 31, 2024, there were no discretionary nonelective employer contributions.

**Qualified nonelective contributions:** The Employer may designate all or a portion of any discretionary contributions for a plan year as qualified nonelective contributions and allocate such amount to non-highly compensated employees as required by the IRC. Participants are 100% vested in these contributions when made. For the year ended December 31, 2024, there were no qualified nonelective contributions.

**Participant accounts:** Each Participant's account is credited with the Participant's contributions and an allocation of (a) Employer contributions, (b) investment earnings and (c) investment advisory expenses and loan and/or withdrawal fees, if applicable, and is charged with his or her withdrawals. Allocations are based on Participants' compensation or account balances, as defined by the Plan. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

**Participant investment options:** Upon enrollment in the Plan, a participant directs their account balances to be invested in selected funds as made available and determined by the Plan. Participants are allowed to change their investment options on a daily basis.

**Vesting:** Participants are immediately vested in their deferral contributions and any qualified nonelective contributions, plus actual earnings thereon. Participants are vested in Employer matching and discretionary nonelective employer contributions, if any, plus earnings thereon after two years of continuous service. Participants become fully vested in their account balance upon death, total and permanent disability, or upon reaching the normal retirement age.

**Forfeitures:** A Participant who leaves the Employer forfeits any nonvested balance. At the Employer's discretion, forfeited balances may be used to pay administrative expenses or to reduce the Employer's contributions. At December 31, 2024 and 2023, unused forfeitures amounted to \$3,859 and \$5,949, respectively. Forfeitures of \$453,777 were used to reduce Employer matching contributions and \$46,127 were used to pay administrative expenses during the year ended December 31, 2024.

**Payment of benefits:** Upon termination of service due to death, disability, voluntary termination, or retirement, a Participant or beneficiary may elect to receive either a lump-sum distribution or installment payments in an amount equal to the value of the Participant's vested interest in his or her account. The payment can either be a cash distribution to the Participant or a tax-free rollover to an individual retirement account or another qualified plan. If a Participant's vested account is more than \$1,000, but less than \$5,000, the Plan Administrator, after notification and consent from the Participant, may distribute the benefit into an individual retirement account. If the vested account balance is less than \$1,000, the Plan Administrator, after notification, may distribute the account balance to the Participant.

In-service withdrawals from a Participant's account are permitted by the Plan. If the Participant is over the age of 59½, the Participant is allowed to withdraw his or her entire vested balance. If the Participant has not reached age 59½, he or she is only permitted to withdraw his or her rollover account or if due to financial hardship. Hardship withdrawals may be taken from the Participant's account under certain circumstances as defined in the plan document.

At December 31, 2024, there were no amounts owed to former participants whose employment has been terminated and who requested payouts of their account balances.

**Plan administration:** The Employer is the Plan Administrator and has the authority to appoint persons or entities to carry out the operation of the Plan. Individual Participant accounts may be charged directly for all administrative expenses, if not paid by the Employer.

**Notes receivable from participants:** Subject to approval by the Plan Administrator, Participants may borrow from their vested accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made, or 50% of their vested account balance reduced by any outstanding loan balance. Loan terms range from one to five years or longer for the purchase of a primary residence. Loans are secured by the vested balance in the Participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions or by check if the Participant has terminated employment. Interest rates for outstanding loans were 3.25% to 9.50% at December 31, 2024. If a Participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the Participant's loan balance is reduced and a benefit payment is made in accordance with the plan document.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

**Contributions:** Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the participant contributions are withheld from compensation.

**Investment valuation and income recognition:** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. Refer to Note 4 for information on the Plan's fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the value of the investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Risks and uncertainties:** The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Notes receivable from participants:** Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative fees and expensed when incurred. Loans to Participants are reported as notes receivable from Participants at the unpaid principal balance plus any accrued but unpaid interest. No allowance for doubtful accounts has been recorded as of December 31, 2024 and 2023. Delinquent loans are treated as distributions based upon the terms of the plan document. Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule of assets (held at end of year).

**Payments of benefits:** Benefits are recorded in the period in which the Participants are paid.

#### Note 3. Information Certified and Provided by Principal

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules, that was prepared by or derived from information provided by Principal and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal that information provided to the Plan Administrator by the trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedules related to the following assets and income.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023:

**Shares of registered investment companies:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Units of pooled separate accounts:** Valued at the NAV of the units of pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the pooled separate accounts. This practical expedient is not used when it is probable that the fund will sell for an amount different from the reported NAV.

#### Note 4 Fair Value Measurements (Continued)

**Units of common/collective trusts held at financial institutions:** The fair values of participation units in the stable value collective trusts are based on the NAV per unit as reported by the fund managers. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trusts less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investments for an amount different than the reported NAV. The collective trusts provide for daily redemptions by the Plan at reported NAV per share, with no advance notice requirement, and there are no unfunded commitments at December 2024 or 2023.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Party-in-Interest Transactions

Parties in interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer.

Certain Plan investments include units of participation in pooled separate accounts and collective trusts managed by the Plan's trustee or affiliates of the trustee; therefore, these transactions qualify as party-in-interest transactions. The Plan also held party-in-interest notes receivable in the form of participant notes receivable. The Plan incurred expenses for these services to the trustee or its affiliates of \$280,899 for the year ended December 31, 2024.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become 100% vested in their accounts. Any unallocated assets of the Plan will be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

#### Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through September 22, 2025, the date the financial statements were available to be issued.
