Note 1—Description of the Plan

The following description of the Sky Solutions, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of the Plan’s provisions.

General – The Plan was established on January 1, 2012 by Sky Solutions, LLC (the “Company” or the “Plan Sponsor”) and was most recently amended effective April 1, 2023 to add an age requirement to enter the Plan and update the vesting schedule for the Company’s discretionary matching contributions and profit-sharing contributions. The Plan is a defined contribution plan covering all employees except union employees, non-resident aliens and interns. Employees who are at least age 21 are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Investments are held by Ascensus Trust Company and Newport Trust Company, LLC (“Ascensus” or the “qualified institution”).

Participant Contributions – Participants are automatically enrolled in the Plan immediately after they first satisfy the eligibility requirement. The Company will deduct 3% of their eligible compensation, as defined in the Plan, unless the participant elects otherwise. Participants may make salary deferral contributions in any percentage up to the lesser of 90% of their pretax annual compensation or \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, reflected as rollover contributions.

Employer Contributions – The Company may elect to make discretionary matching, profit-sharing and qualified nonelective contributions to the Plan. For the year ended December 31, 2024, the Company elected to make a discretionary matching contribution equal to 3% of compensation for each eligible employee. To be eligible for the profit-sharing contribution, an employee must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year. For the year ended December 31, 2024, the Company elected to make a profit-sharing contribution equal to a percentage of compensation for each eligible employee. There were no qualified nonelective contributions for the year ended December 31, 2024. Total employer contributions to the Plan were \$906,657 for the year ended December 31, 2024. Contributions are subject to regulatory limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and Company discretionary matching contributions, if any, as well as allocations of the Company’s profit-sharing and qualified nonelective contributions, if any, and Plan earnings (losses). Participant accounts are charged with distributions and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting – Participants are vested immediately in their contributions and the Company’s qualified nonelective contributions plus actual earnings (losses) thereon. The Company’s discretionary matching contributions and profit-sharing contributions vest as follows:

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence. Under the terms of the Plan Agreement, Plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50%, with various maturities through May 2039.

Payment of Benefits – On termination of service, a participant may receive a lump-sum amount equal to the value of the vested balance in their account. The Plan allows for distributions upon termination of service, death, disability, attainment of age 59½ or in certain hardship situations. In the event a participant terminates and participant's vested account balance is less than \$1,000, the balance will be automatically paid in a lump sum. If the participant's vested account balance is greater than \$1,000 but less than \$5,000, the balance will be automatically rolled into an IRA, unless otherwise directed. Hardship withdrawals are subject to Internal Revenue Code ("IRC") restrictions and penalties.

Administrative Expenses – The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensations from the Plan. Administrative expenses are paid either directly by the Plan Sponsor or the Plan.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation – Investments in the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considered the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expense – Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. However, most of the Plan's operating expenses are paid out of Plan assets; investment-related expenses are included in net appreciation in fair value of investments, and expenses relating to specific participant transactions are included in administrative expenses and charged directly to the participant's account.

Fair Value Measurements – U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Mutual Funds – These public investment vehicles are valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is classified within Level 1 of the valuation hierarchy based on the underlying assets of the account, which are traded on an active market.

Money Market Fund – These investments are valued at closing price reported on the active market on which the individual securities are traded and are classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits – Benefits are recorded when paid.

Contributions Receivable – The amount of participant-related contributions that have been deducted from the participant's payroll as of the end of the year but that have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Company are reflected as Employer contributions receivable in the Plan's financial statements.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts permitted by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding decrease to contributions. As of December 31, 2024 and 2023, the Company has excess contribution payables of \$33,947 and \$20,097, respectively. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the following year.

Note 3—Information certified by the qualified institution

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus has certified to the completeness and accuracy of the following data in the accompany financial statements:

- Investments, at fair value, and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

Note 5—Tax status

The Plan utilized a prototype plan document sponsored by Ascensus. The prototype plan sponsor has obtained a favorable opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 6—Party-in-interest transactions

Certain Plan investments are managed by Ascensus. Certain administrative expenses are paid to Ascensus which qualify as party-in-interest transactions for which statutory exemption exists under DOL Regulations. Fees paid to these qualified institutions totaled \$4,290 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

Note 7—Plan termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 8—Prohibited transactions

During the years ended December 31, 2024 and 2023, the Plan failed to remit in a timely manner certain participant contributions from its assets within the required time period as specified by DOL Reg. 2510.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Plan made the deposit after the required timeframe and has remitted lost earnings and late remittances in 2025.
