## INDEPENDENT AUDITOR'S REPORT

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Ocean Bank (the “Bank”) 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of the Bank who have completed 90 days of service and are age twenty-one or older. Eligible employees are automatically enrolled in the Plan by the Bank, unless a specific election is made by the employee to opt out of plan participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions: Each year, participants may contribute up to 75% of their eligible compensation, as defined in the Plan, and subject to certain IRS limitations. For participants classified as highly compensated, the Plan limits contributions to 8% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants automatically enrolled in the Plan by the Bank that do not elect otherwise, will be established with a 6% contribution rate, which will also automatically increase at a rate of 1% annually, up to a maximum of 10%. Participants may also contribute amounts representing distributions from other qualified plans. For every dollar contributed by eligible employees from their compensation the Bank will match 50%, up to 6% of their eligible compensation. Plan participants may direct the investment of the contributions to their account into the various investment options offered by the Plan. Automatically enrolled participants that do not make an election will have their contributions invested into a default target retirement fund based on their age.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Bank’s contributions, (b) Plan earnings, and (c) forfeitures of Bank contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are at all times 100% vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on continuous service as follows:

1 year	0%
2 years	40%
3 years	60%
4 years	80%
5 years	100%

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest equal to the prime rate charged for a loan made under similar circumstances. Principal and interest are paid through payroll deductions.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant’s vested interest in his or her account. Benefit payments under \$5,000 are distributed to participants in a single lump sum payment upon a distribution event. Participants (of their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum, installment payments, or partial payments. The Plan allows for in-kind distributions from only the self-directed brokerage investment fund. A participant may elect distributions in more than one form of payment. In certain circumstances, participants may make hardship withdrawals, as defined by the Plan. Active participants may also take distributions from the Plan upon attainment of age 59.5.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

Administrative and Investment Management Expenses: Expenses of maintaining the Plan are paid directly by the Bank and are excluded from these financial statements. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Forfeitures: Participant forfeitures of Bank contributions are first used to pay administrative expenses and then available to offset any future Bank contributions. As of December 31, 2024 and 2023, \$1,915 and \$5,373, respectively, of forfeited Bank contributions were available to offset future administrative expenses and Bank contributions. During 2024, \$76,688 were used to pay Plan administrative expenses.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of investment securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a distribution is recorded and declared.

Contributions: Participant and Bank contributions are recorded in the period during which the Bank makes payroll deductions from the participants' earnings.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 – RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Bank has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Bank contributions and earnings thereon.

#### **NOTE 4 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company (the trustee of the Plan).

#### **NOTE 5 – FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement supported by limited or no market activity.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds and Self-Directed Brokerage Account: The fair values of mutual fund investments and the investments held in the self-directed brokerage account are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

Collective Trusts: The fair values of participation units held in collective trusts are based on their net asset values, as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement except for the stable value collective trust that requires a 12 or 30-months' advance written notice for any Plan sponsor-initiated transactions, although the notice period may be shortened or waived by the trustee in its sole discretion.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Bank, and certain others. The Plan holds units of a stable value fund issued by T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee and therefore, these transactions and the Plan's payment of administrative fees to T. Rowe Price Trust Company qualify as party-in-interest transactions. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA. Notes receivable from participants are also considered party-in-interest transactions. Some administrative expenses of the Plan are paid directly by the Bank. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated August 19, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through September 2, 2025, which is the date the financial statements were available to be issued.
