Independent Auditor's Report

To the Administrator of
the Alta Forest Products 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alta Forest Products 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Alta Forest Products 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Alta Forest Products 401(k) Retirement Plan 's ability to continue as a going concern for within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial

statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule of assets (held at end of year) that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS**

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Alta Forest Products 401(k) Retirement Plan (formerly known as TMI Division 401(k) Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was originally effective January 1, 1997. On April 30, 2014, TMI Forest Products, Inc. finalized a transaction with Welco Lumber Company ("Welco") that resulted in both TMI Forest Products, Inc. and Welco Lumber Company contributing substantially all of their assets to a new entity called Alta Forest Products, LLC. Effective May 1, 2014, the Plan name was changed to TMI Division 401(k) Plan, and the sponsor became Alta Forest Products, LLC.

The Plan was restated and renamed Alta Forest Products 401(k) Retirement Plan as of January 1, 2016. In connection with the Plan's restatement, employees of the Company who worked in Welco-related divisions, were rolled into the plan on January 1, 2016, and their 401(k) accounts were transferred to the Plan. The Plan is periodically restated and updated to conform to current regulations.

(a) General

The Plan is a contributory, defined contribution plan covering eligible U.S. employees of Alta Forest Products, LLC (the Company or Plan sponsor). Employees are eligible to participate in the Plan upon reaching at least 18 years of age. In addition, employees must have completed at least six months of service in order to be eligible for participation in the Plan. Eligible participants may enter the Plan on the first day of the calendar month following completion of the eligibility criteria.

(b) Contributions

Participants may contribute to their deferred contribution account on a pre-tax basis or as designated Roth deferrals up to the statutory limits prescribed by the Internal Revenue Code, including catch-up contributions for those participants who have reached age 50. Effective January 1, 2016, the Company makes a safe harbor matching contribution on deferrals of non-union participants, including catch-up deferrals, of 100% of deferrals that are not in excess of 4.5% of compensation. The Company may also make discretionary profit-sharing contributions; there were none for 2024 and 2023. The employee deferrals and match are funded with each pay period.

(c) Participants' Accounts

Each participant's account is credited with the participant's contribution, employer contributions, and an allocation of net earnings of the Plan. Allocations of Plan earnings are based on participants' account balances, as defined by the Plan. Allocations of the profit-sharing contributions, if any, are based upon eligible participants' compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participants' account.

Note 1 - continued

Each participant directs the investment of their account by selecting from alternative investment funds offered by the trustee.

(d) Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions, plus earnings thereon. Participants are vested in the discretionary employer matching and profit-sharing contributions at a rate of 20% after two years of service with full vesting after six years of service. All employer contributions vest upon death, attainment of normal retirement age (65), or total and permanent disability.

(e) Payment of Plan Benefits and Other Distributions

Participants are eligible for distributions upon termination of service, retirement, death or disability. Upon termination, if the participant's account balance is less than \$1,000, it will be paid in cash. If the participant's account balance is greater than \$1,000 but less than \$5,000, upon termination of employment, the amount will be distributed from the Plan, either in cash, or by rollover to an IRA or other employer qualified plan. Account balances in excess of \$5,000 may stay in the Plan until the participant requests a distribution, or becomes subject to minimum distributions.

In certain limited circumstances, a participant may request a hardship withdrawal of elective deferrals. Upon attainment of age 59-1/2, a participant may receive a distribution of vested balances.

Active employees may also request loans from the Plan. Loans are limited to \$50,000 or 50% of their vested account balance in the Plan. Payments on the loans will be made with each pay period, and upon termination of employment, the loan becomes payable in full.

(f) Plan Expenses

Participants are assessed a fee for custodial, trustee, and investment advisory services. These fees are offset by revenue sharing amounts received from investment sponsors. In 2024, \$40,999 in revenue sharing was received by the Plan, which is included as investment income.

(g) Forfeitures

The non-vested portion of a terminated participant's account balance will be forfeited and generally used to reduce the employer's matching contribution or used to offset administrative costs of the Plan. At December 31, 2024 and 2023, there was \$4 and \$0, respectively, in forfeited non-vested accounts. During the year ended December 31, 2024, \$41,041 was used to reduce the employer contribution or plan expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Method of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Investments

The Plan's assets consist primarily of mutual funds, and are stated at fair value as determined by quoted market prices, which represent the net asset values of shares held by the Plan at year-end. At December 31, 2024 and 2023, the common collective trust is stated at the year-end net asset value provided by Reliance Trust, the trustee of the common collective trust, which is the relevant measure as this is the value at which participants transact.

The change in market value and realized gains and losses during the year are recognized as net appreciation (depreciation) in fair value of investments in the accompanying statement of changes in net assets available for plan benefits. Purchases and sales of securities are reflected on a trade date basis. Interest is recorded when earned. Dividends are recorded on the ex-dividend date basis.

(c) Notes Receivable from Participants

Notes receivable from participants are stated at the unpaid principal balance and are secured by the participants' Plan account balance. Interest is recognized on the loans based on the prime rate in effect at the inception of the loan plus 1%. Payments are made with each payroll and upon termination of employment, any unpaid balances are due. Due to adequate collateral supporting loans, no allowance for credit losses is provided.

(d) Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from these estimates.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan administrator has obtained certification from Matrix Trust Company as of and for the years ended December 31, 2024 and 2023, that the following information is complete and accurate.

1. Amounts included as investments in the statement of net assets available for benefits at December 31, 2024 and 2023;
2. Investment income included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 4 - INVESTMENTS

Fair value is a market-based measurement, determined based on assumptions that market participants would use in pricing an asset or liability. There are three-levels, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

As of December 31, 2024 and 2023, the fair value of mutual funds was determined using Level 1 inputs, which are the fund-reported daily closing prices. Cash was also valued using Level 1 inputs.

The fair value of the common collective trust was determined by use of values of its underlying investments less liabilities as determined by the trust's management, resulting in a net asset value (NAV) per share type. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Were the Plan to initiate a full redemption of the collective trust, the investment adviser may delay withdrawal from the trust in order to ensure that the liquidation occurs in an orderly manner.

NOTE 5 - TAX STATUS

Effective January 1, 2021, the Plan trustees adopted a volume submitter plan. It is the intent of the volume submitter plan to be exempt from federal income taxes. An opinion letter, dated June 30, 2020, from the Internal Revenue Service has been obtained by the volume submitter plan sponsor. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirement of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has concluded that, as of December 31, 2024, the Plan has not taken any uncertain positions that would require recognition or disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress, and years prior to 2021 are no longer subject to examination.

NOTE 6 - PLAN TERMINATION

Although it has not expressed an intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 9, 2025, the date on which the financial statements were available for issue.
