As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

The following description of the Three D Metals Inc 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-union employees, as defined in the Plan Adoption Agreement, of Three D Metals Inc (the Company, Plan Sponsor, or Employer) who have completed three months of service with at least one hour of service in each month or worked at least 1,000 hours of service during the previous Plan year depending on full-time/part-time status of the employee, as defined in the Plan Adoption Agreement, and attained 18 years of age. Williams Metals and Welding Alloys, Inc. (WMWA) was acquired by the Company effective February 9, 2016, and effective August 16, 2016, the Plan was amended to allow WMWA's employees to participate in the Plan. Periods of service with WMWA are counted for purposes of eligibility and vesting in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make voluntary before-tax or Roth contributions up to 92% of their compensation as defined each year. Effective August 1, 2019, once participants are eligible to contribute to the Plan, they are automatically enrolled to contribute on a pre-tax basis at 3% but may elect to contribute on a pre-tax and/or Roth basis from 1% to 92% of Plan compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. If automatically enrolled, the participant invests in target date funds. In addition, the Plan allows for employer safe harbor matching contributions. The Company authorized safe harbor matching contributions equal to 100% of each participant's elective deferrals not to exceed 3% of the participant's compensation, plus 50% of each participant's elective deferrals in excess of 3% but not in excess of 5% of the participant's compensation. Qualified nonelective contributions (including profit-sharing contributions) may be made to the Plan solely at the discretion of the Company's Board of Directors. There were no qualified nonelective contributions authorized for either the 2024 or 2023 Plan years. There were no profit-sharing contributions authorized for either the 2024 and 2023 Plan years. The Company and participant contributions are subject to the limitations imposed under Internal Revenue Code Sec. 404(a)(3)(A).

Participant Accounts

Each participant's account is credited with the participant's elective deferral, including amounts rolled over from other qualified plans, any contributions by the Company, and earnings or losses on those contributions.

Vesting

Participants are immediately vested in elective deferrals and safe harbor matching contributions, plus actual earnings thereon. The profit-sharing contributions are subject to a vesting schedule, as defined in the Plan Adoption Agreement, with the participant becoming 25% vested in the Plan after one year of credited service and being fully vested after four years of credited service. WMWA's employees' matching contributions made prior to the Plan merger are subject to a vesting schedule,

as defined in the Plan Adoption Agreement, with the participant becoming 20% vested in the Plan after two years of credited service and being fully vested after six years of credited service.

Forfeitures

Forfeitures are used to pay expenses of the Plan or to reduce future employer contributions to the Plan. As of December 31, 2024 and 2023, there were unallocated forfeitures of \$14,397 and \$11,936, respectively. During the 2024 and 2023 Plan years, \$625 and \$3,600, respectively, was used to pay for expenses of the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance under the Plan, as defined in the Plan Adoption Agreement. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money. No participant may have more than two outstanding loans. The participant's outstanding loan balance will be offset upon receiving any type of distribution after severance of employment. As required by federal tax regulations, a participant's defaulted loan will remain on the books until a qualifying event occurs, even though income has been reported to the Internal Revenue Service (IRS). As of December 31, 2024 and 2023, interest rates ranged from 3.25% to 9.50% and had various maturity dates ranging through 2031.

Payment of Benefits

Upon death, disability, retirement, or termination of services, a participant's elective deferrals plus the vested amount of Company contributions, and earnings thereon, are paid in a single lump-sum payment or installments as provided by the Plan Adoption Agreement. If the participant's account is between \$1,000 and \$5,000, the Plan makes an automatic rollover of the participant's vested interest in his or her account to a qualified individual retirement account. If the participant's account balance is less than \$1,000, the Plan may make an automatic lump-sum distribution to the participant equal to the participant's vested interest in his or her account. Distributions of a participant's account balance may be authorized at any time by the Plan administrator under certain hardship conditions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Accounting Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could vary from estimates that were used.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment guaranteed interest fund, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan's fully benefit-responsive guaranteed interest fund with Empower Annuity Insurance Company of America (Note 3) is valued at contract value. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less distributions.

Notes Receivable - Participant Loans

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Adoption Agreement.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

As provided by the Plan Adoption Agreement, the Plan's administrative expenses are paid by either the Plan or the Company, at the Company's discretion.

Evaluation of Subsequent Events

The Company has evaluated subsequent events that occurred between December 31, 2024 and September 17, 2025, which is the date the financial statements were available to be issued. There were no subsequent events to be reported.

3. Guaranteed Interest Fund

The Plan has a benefit-responsive guaranteed interest fund with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments in the entire medium-long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. In addition, the account is charged for participant withdrawals and administrative expenses. The guaranteed interest fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest fund. The guaranteed interest fund is presented in the statements of net assets available for benefits at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include certain amendments to the Plan Adoption Agreement, such as a complete Plan termination. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The average yield based on actual earnings was 2.66% and 1.48% for the years ended December 31, 2024 and 2023, respectively. The average yield based on interest rate credited to participants was 2.66% and 1.48% for the years ended December 31, 2024 and 2023, respectively.

Participants may transfer their account balance to any other investment option offered under the Plan at any time with no restrictions or penalties. If a participant transfers out of the Guaranteed Interest Fund, Empower Annuity Insurance Company of America reserves the right to restrict transfers for 30 days. These transactions are processed after the resolution of closed or disrupted financial exchanges or markets.

4. Information Certified by Trustee

The Plan has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, Empower) have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate.

- Investments, as reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Notes receivable from participants in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Interest income on notes receivable from participants in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments, as reflected in the Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

5. Tax Status

The Plan is a prototype non-standardized profit-sharing/money-purchases plan with cash or deferred arrangement provided by Empower Retirement LLC, which has received an opinion letter, dated November 14, 2022, from the IRS. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all rights and benefits of the participants will become fully vested.

7. Party-in-Interest Transactions

Certain Plan investments are managed by Empower. Empower is the trustee, and therefore, these transactions qualify as exempt party in interest transactions and are exempt from the prohibited transaction rules of ERISA. The Plan made direct payments for recordkeeping fees to the trustee for the years ended December 31, 2024 and 2023 in the amount of \$36,942 and \$31,433, respectively.

8. Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies (mutual funds) - These are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
