Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Globe Union Group Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Globe Union Group Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General: The Plan was established January 1, 2001, by Globe Union Group, Incorporated (the Sponsor or Company). The Plan was adopted by all employers of the Sponsor's controlled group of employers and affiliated services group.

The Plan document was restated through adoption of a non-standardized prototype plan sponsored by Fidelity Management Trust Company (Fidelity), effective January 25, 2010. This restatement provided for automatic enrollment at a percentage of the participants total salary, pay or earned income from the Company upon the participant's entry date unless the participant elects not to participate. In addition, it confirmed the Plan's existing provisions and incorporated certain elements required by ERISA.

Participation: The Plan is a defined contribution plan covering all employees who are not covered by a collective bargaining agreement. An eligible employee is defined as any person regularly employed by the Company, over 18 years of age and who has completed three months of service. An eligible employee enters the Plan immediately upon satisfying the eligibility requirements described herein, unless participation is declined.

Contributions: The Plan allows participants to contribute an amount equal to a percentage of the contributing participant's compensation on a pre-tax or post-tax basis, as defined in the Plan, but not to exceed statutory limits of the Internal Revenue Code (IRC). If upon becoming eligible, if an employee does not elect a deferral percentage on-line or by calling Fidelity or opted out of the Plan, the employee will be automatically enrolled into the Plan and 3% of the employee's compensation will be withheld and contributed to the Plan as a salary deferral. In subsequent years, this automatically increases annually by 1%, up to a maximum of 6% unless the participant affirmatively elects to opt out of the increase or a different percentage increase. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). For the year ended December 31, 2024, the Company made non-discretionary Company matching contributions calculated by 100% of the participants' deferrals on the first 1% of the participants' compensation and 50% of the next 5%. The Company match is calculated and contributed to participant accounts during each pay period.

In addition to the matching contribution, the Company may make a discretionary contribution which is determined and approved by the Board of Directors annually. No Company discretionary contribution was made in 2024. Contributions are subject to certain limitations.

Investment options: Participants direct the investments of total account balances among various investment options consisting of shares of registered investment companies and a common/collective trust.

Note 1. Plan Description (Continued)

Participant accounts: Each participant's account is credited with his or her contribution, the Company matching and discretionary contributions, if any, and an allocation of investment earnings or losses and expenses, if any. Allocations are based on participant earnings or account balances, as defined. Discretionary contributions are allocated based on compensation for participants employed on the last day of the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants: Participants can borrow up to 50% of the vested portion of their accounts subject to a maximum of \$50,000. The minimum note receivable amount is \$1,000. Notes receivable are subject to interest based on prevailing market rates at the time of loan origination as determined by the Company. The notes receivable are repaid through payroll deductions over periods ranging from 12 to 60 months, with the exception of notes used to purchase a principal residence, which are repayable over a maximum of 10 years. The interest rate on outstanding notes receivable was 6% for the years ended December 31, 2024 and 2023.

Vesting: Participants are immediately 100% vested in their elective deferrals, rollover contributions and the earnings thereon. Participants are vested in the Company matching contributions as follows:

In the event of death, permanent disability or retirement, the participant's account becomes fully vested. A participant who reaches age 65 will become fully vested.

Payment of benefits: On retirement, death, disability or termination of service, a participant or beneficiary may elect to receive a lump-sum distribution. In-service distributions are permitted as described in the Plan. A participant may be allowed to receive a distribution by determination that a financial hardship, as defined, has occurred.

Forfeitures: In the event of termination of employment before full vesting has occurred, the non-vested portion of the Company contribution shall be used to reduce the Company's contribution or Plan expenses as determined by the Plan Administrator. Forfeitures available as of December 31, 2024 and 2023, were \$7,787 and \$14,202, respectively. In 2024, \$11,994 of forfeitures were used to offset Plan expenses.

Note 2. Summary of Significant Accounting Policies

Administration of the Plan and Trust: Globe Union Group, Inc. administers the Plan. The Trust created by the Plan, which holds the Plan's assets, is administered by Fidelity. According to an agreement between Fidelity and the Company, Fidelity invests the assets and makes payments to participants.

Basis of accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Accounting estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities and additions to and deductions from net assets, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan agreement.

Payments of benefits: Benefits are recorded when paid.

Note 3. Information Certified and Provided by Fidelity (the Trustee)

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by Fidelity and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Fidelity that the information provided to the Plan Administrator by Fidelity related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule related to the following assets and income:

Note 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: These shares are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Units of common/collective trust fund: Valued at the NAV of units of the common/collective trust fund. The NAV, as provided by Fidelity, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investment from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

Note 5. Tax Status

The Plan adopted a non-standardized prototype plan sponsored by Fidelity. The prototype plan has obtained a favorable determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan is in compliance with the applicable requirements of the IRC and, therefore, is exempt from income taxes. The prototype plan's opinion letter has been relied on by the Plan. The Plan has been amended since receiving this letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 6. Related-Party and Party-in-Interest Transactions

The Company is the plan sponsor. Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan. Certain of the Plan's investments are mutual funds and common/collective trust managed by Fidelity. In addition, amounts reflected as administrative expenses in the amount of \$27,313 were paid to Fidelity for the year ended December 31, 2024. Fidelity is the Trustee of the Plan and, therefore, these transactions are party-in-interest transactions.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all participants shall be fully vested and receive any amounts then credited to their accounts after adjustment for expenses, profits and losses of the Plan and any previously unallocated funds to the date of termination.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Globe Union Group Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1. Plan Description

The following description of the Globe Union Group Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General: The Plan was established January 1, 2001, by Globe Union Group, Incorporated (the Sponsor or Company). The Plan was adopted by all employers of the Sponsor's controlled group of employers and affiliated services group.

The Plan document was restated through adoption of a non-standardized prototype plan sponsored by Fidelity Management Trust Company (Fidelity), effective January 25, 2010. This restatement provided for automatic enrollment at a percentage of the participants total salary, pay or earned income from the Company upon the participant's entry date unless the participant elects not to participate. In addition, it confirmed the Plan's existing provisions and incorporated certain elements required by ERISA.

Participation: The Plan is a defined contribution plan covering all employees who are not covered by a collective bargaining agreement. An eligible employee is defined as any person regularly employed by the Company, over 18 years of age and who has completed three months of service. An eligible employee enters the Plan immediately upon satisfying the eligibility requirements described herein, unless participation is declined.

Contributions: The Plan allows participants to contribute an amount equal to a percentage of the contributing participant's compensation on a pre-tax or post-tax basis, as defined in the Plan, but not to exceed statutory limits of the Internal Revenue Code (IRC). If upon becoming eligible, if an employee does not elect a deferral percentage on-line or by calling Fidelity or opted out of the Plan, the employee will be automatically enrolled into the Plan and 3% of the employee's compensation will be withheld and contributed to the Plan as a salary deferral. In subsequent years, this automatically increases annually by 1%, up to a maximum of 6% unless the participant affirmatively elects to opt out of the increase or a different percentage increase. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). For the year ended December 31, 2024, the Company made non-discretionary Company matching contributions calculated by 100% of the participants' deferrals on the first 1% of the participants' compensation and 50% of the next 5%. The Company match is calculated and contributed to participant accounts during each pay period.

In addition to the matching contribution, the Company may make a discretionary contribution which is determined and approved by the Board of Directors annually. No Company discretionary contribution was made in 2024. Contributions are subject to certain limitations.

Investment options: Participants direct the investments of total account balances among various investment options consisting of shares of registered investment companies and a common/collective trust.

Note 1. Plan Description (Continued)

Participant accounts: Each participant's account is credited with his or her contribution, the Company matching and discretionary contributions, if any, and an allocation of investment earnings or losses and expenses, if any. Allocations are based on participant earnings or account balances, as defined. Discretionary contributions are allocated based on compensation for participants employed on the last day of the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants: Participants can borrow up to 50% of the vested portion of their accounts subject to a maximum of \$50,000. The minimum note receivable amount is \$1,000. Notes receivable are subject to interest based on prevailing market rates at the time of loan origination as determined by the Company. The notes receivable are repaid through payroll deductions over periods ranging from 12 to 60 months, with the exception of notes used to purchase a principal residence, which are repayable over a maximum of 10 years. The interest rate on outstanding notes receivable was 6% for the years ended December 31, 2024 and 2023.

Vesting: Participants are immediately 100% vested in their elective deferrals, rollover contributions and the earnings thereon. Participants are vested in the Company matching contributions as follows:

In the event of death, permanent disability or retirement, the participant's account becomes fully vested. A participant who reaches age 65 will become fully vested.

Payment of benefits: On retirement, death, disability or termination of service, a participant or beneficiary may elect to receive a lump-sum distribution. In-service distributions are permitted as described in the Plan. A participant may be allowed to receive a distribution by determination that a financial hardship, as defined, has occurred.

Forfeitures: In the event of termination of employment before full vesting has occurred, the non-vested portion of the Company contribution shall be used to reduce the Company's contribution or Plan expenses as determined by the Plan Administrator. Forfeitures available as of December 31, 2024 and 2023, were \$7,787 and \$14,202, respectively. In 2024, \$11,994 of forfeitures were used to offset Plan expenses.

Note 2. Summary of Significant Accounting Policies

Administration of the Plan and Trust: Globe Union Group, Inc. administers the Plan. The Trust created by the Plan, which holds the Plan's assets, is administered by Fidelity. According to an agreement between Fidelity and the Company, Fidelity invests the assets and makes payments to participants.

Basis of accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Accounting estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities and additions to and deductions from net assets, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan agreement.

Payments of benefits: Benefits are recorded when paid.

Note 3. Information Certified and Provided by Fidelity (the Trustee)

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by Fidelity and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Fidelity that the information provided to the Plan Administrator by Fidelity related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule related to the following assets and income:

Note 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: These shares are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Units of common/collective trust fund: Valued at the NAV of units of the common/collective trust fund. The NAV, as provided by Fidelity, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investment from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

Note 5. Tax Status

The Plan adopted a non-standardized prototype plan sponsored by Fidelity. The prototype plan has obtained a favorable determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan is in compliance with the applicable requirements of the IRC and, therefore, is exempt from income taxes. The prototype plan's opinion letter has been relied on by the Plan. The Plan has been amended since receiving this letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 6. Related-Party and Party-in-Interest Transactions

The Company is the plan sponsor. Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan. Certain of the Plan's investments are mutual funds and common/collective trust managed by Fidelity. In addition, amounts reflected as administrative expenses in the amount of \$27,313 were paid to Fidelity for the year ended December 31, 2024. Fidelity is the Trustee of the Plan and, therefore, these transactions are party-in-interest transactions.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all participants shall be fully vested and receive any amounts then credited to their accounts after adjustment for expenses, profits and losses of the Plan and any previously unallocated funds to the date of termination.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
