Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bear Holdings, LLC 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

The following description of Bear Holdings, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of JES Payroll Clearing, Inc., FWM Payroll Clearing, Inc., Bear Land Development, Inc., JES Dev Co., Inc., Fairway Construction Co., Inc., Fairway Management, Inc., Affordable Equity Partners, Inc., Capital Health Management, Inc., Country Club Care Center of Warrensburg, L.C., Crown Care Center of Harrisonville, L.C., Lakewood Care Center of Lee's Summit, L.C., Metro Equipment Rental Co., L.C., Missouri Air Services, LLC, JES Prime Payroll Clearing, Inc., Wilshire at Lakewood Memory Care, LLC, JES Prime Senior Living, LLC, and Village of Bedford Walk, LLC (collectively the "Company") who have at least three months of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company is the trustee of the Plan.

Country Club Care Center of Warrensburg, L.C., Crown Care Center of Harrisonville, L.C., and Lakewood Care Center of Lee's Summit, L.C. ceased operations after December 31, 2021, and were formally removed as participating employers effective January 1, 2023.

Contributions

Participants may contribute up to the maximum of their total compensation for the plan year subject to limitations as prescribed by the Internal Revenue Code. Effective January 1, 2023, the Plan was amended to permit Roth contributions. Employee rollover contributions are also permitted.

The Company provides a safe harbor matching contribution equal to 100% of a participant's salary deferral amount not to exceed 4% of each participant's eligible compensation, as defined. In addition, the Company may make discretionary matching and profit-sharing contributions. To participate in all employer contributions, participants must have completed one year of service. To participate in the discretionary profit-sharing contributions, participants must also be actively employed on the last day of the plan year. No discretionary matching contributions or discretionary profit-sharing contributions were made for the plan years ended December 31, 2024 or 2023. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants have the option of directing their contributions as well as the Company's contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon and the Company's safe harbor contributions plus earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested after six years of credited service.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$63,899 and \$46,690, respectively. These accounts will be used to reduce future employer contributions or to pay Plan administrative expenses. During 2024 and 2023, forfeited nonvested accounts of \$2,995 and \$14,707, respectively, were utilized for fees.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates equal to the prime lending rate. The rate of interest on the loan is fixed for the duration of the loan repayment period. Generally, loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. A participant is considered to be in default if a participant fails to make all or any part of a required loan repayment by the end of the calendar quarter which follows the calendar quarter in which the repayment was due. In the event of default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Payment of Benefits

Upon termination of service, a participant whose account balance exceeds \$5,000 may elect to either remain in the Plan or receive a lump sum equal to the value of their account. A lump sum distribution will automatically be made for those terminated participants with an account balance of \$5,000 or less. Absent an election by the participant, a rollover to an individual retirement account designated by the administrator will automatically be made for those terminated participants with an account balance greater than \$1,000 but not more than \$5,000. Withdrawals other than for termination are permitted under certain circumstances. Under the SECURE 2.0 Act, the mandatory distribution threshold was increased from \$5,000 to \$7,000 effective January 1, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the related employer matching contributions are recorded in the year in which the employee contributions are deducted from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by an affiliate of Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan paid \$4,783 and \$2,498 of direct recordkeeping fees to an affiliate of Fidelity Management Trust Company during 2024 and 2023, respectively. The Plan paid direct fees of \$48,426 and \$46,180 for investment advisory services during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan and directly pays other fees related to the Plan's operations.

Note 5. Disclosures About Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include money market mutual funds and mutual funds. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of investments with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Tax Status

The Plan operates under a nonstandardized pre-approved profit-sharing plan document sponsored by FMR LLC. This pre-approved plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service dated June 30, 2020, stating the form of the Plan is acceptable for use under Section 401 of the Internal Revenue Code. Therefore, the plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 9. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the employer's general assets. Contributions and loan repayments of \$108 and \$9,625, respectively, were not remitted within the required time period for the years ended December 31, 2024 and 2023, and are pending full correction with lost earnings. In addition, delinquent contributions and loan repayments totaling \$17,899 for plan years 2022 through 2019 are still pending full correction with lost earnings.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11. Subsequent Events

Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued.
