Independent Auditor's Report

To the Plan Administrator

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the National Automotive Roads Fuel Association Multiple Employer Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statement of net assets available for benefits (in Liquidation) as of December 31, 2024 and the statement of net assets available for benefits (Ongoing basis) as of December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

*Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting*

As further discussed in Note 1 to the financial statements the Plan administrator approved a plan of liquidation on September 1, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting to the liquidation basis of accounting used in presenting the Plan's financial statements. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements December 31, 2024

### Note 1 - Description of Plan

The following description of the National Automotive Roads Fuel Association Multiple Employer Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution, multiple employer plan operated by Automotive Wholesalers Association of New England d/b/a NARFA (the "Plan Administrator") and covering participating employers which have adopted the Plan (collectively, referred to as the "Participating Employers"). The Plan covers employees of each Participating Employer as defined in the individual adoption agreements. Each Participating Employer may modify the provisions of the Plan for its own employees based on their individual adoption agreements. The Plan Administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective September 1, 2024, the Plan terminated. As a result of this transaction, all Participating Employers were notified of the termination date and were provided with 90 days advanced notice to transfer out of the Plan or be subject to the termination proceedings. Also, participants were no longer permitted to make contributions to the Plan. These participants became 100% vested in the Company contribution portion of their account as a result of this Plan termination. As of December 31, 2024, all assets were distributed to participants or transferred to other plans.

#### Contributions

Each year, participants may make salary deferral contributions to the Plan equal to a percentage of their annual pre-tax compensation, as defined by the Plan. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participating Employers may make contributions to the Plan in the form of safe harbor matching, regular matching, nonelective or prevailing wage contributions. These contributions are determined annually by the Participating Employers, and may vary for each of the Participating Employers within the Plan. Participants also direct the investment of Participating Employers' contributions. All contributions are subject to certain Internal Revenue Code (the "IRC") limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions and Participating Employers' contributions, as well as an allocation of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their salary deferral contributions and any rollover contributions plus actual earnings thereon. Vesting in the Participating Employers' contribution portion of their accounts is based on years of continuous service and the related provisions of the individual adoption agreements of each Participating Employer.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set based on the provisions of the individual adoption agreements of each Participating Employer. Principal and interest is paid ratably through monthly payroll deductions.

### Payment of benefits

On termination of service for any reason, participants will receive benefits equal to the value of the vested interest in his or her account. Participants with a vested account balance less than \$1,000 will receive a mandatory distribution. For terminated participants with a vested account balance greater than \$1,000, but less than \$5,000, the Plan Administrator will make a direct rollover of the participant's account to an individual retirement account designed by the Plan Administrator. Participants with a vested account balance greater than \$5,000 may elect to receive their benefit as a lump sum or may defer payment of benefits until a later date.

Withdrawals from certain portions of a participant's account balances may also be made in the event of a financial hardship or upon reaching age 59½, in accordance with the provisions specified by the Plan.

### Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$70, respectively. These amounts may be used to reduce future employer contributions or to pay Plan expenses. Forfeited nonvested accounts of \$259 were utilized to pay Plan expenses the year ended December 31, 2024.

## Note 2 - Summary of accounting policies

### Basis of accounting

In accordance with accounting principles generally accepted in the United States of America ("GAAP"), due to the termination of the Plan on September 1, 2024 (see Note 1), the financial statements as of and for the year ended December 31, 2024 were prepared using the liquidation basis of accounting to determine the amounts at which Plan assets are stated. The financial statements as of December 31, 2023 were prepared on the ongoing basis of accounting.

### Use of estimates

The preparation of financial statements in accordance GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value

of investments includes dividends and the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### Contributions

Contributions from Plan participants and the discretionary matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### Payment of benefits

Benefits are recorded when paid.

### Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (the "IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Administrator. Expenses that are paid by the Plan Administrator are excluded from these financial statements. Fees related to the administration of distributions and an asset-based administration fee are charged directly to participant accounts and are included in administrative expenses. All other investment related expenses are included in the net appreciation in fair value of investments.

### Subsequent events

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

## Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2023.

*Pooled separate accounts:* Valued using the accumulation unit value, which is based on the fair value of the underlying assets of the accounts. The accumulated unit value is deemed equivalent to the net asset value ("NAV"), which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. In accordance with Subtopic 820-10, investments measured at NAV per share (or its equivalent) are not classified in the fair value hierarchy. Therefore, no fair value hierarchy table is included in the accompanying notes to the financial statements.

#### Fair value of investments in entities that use NAV

The following tables summarize investments for which fair value is measured using NAV per share practical expedient as of December 31, 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

#### Note 4 - Fully benefit-responsive investment contract

The Plan has entered into a group annuity contract with Transamerica Financial Life Insurance Company, Inc. ("Transamerica") which provides participants a stable value account investment option. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer which is reviewed semi-annually for resetting in accordance with the terms of the contract. There is no stated minimum or maximum crediting rate under the contract.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Examples of such events include: (1) the Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC, (2) premature termination of the contracts, (3) plan termination or merger, (4) change to the Plan's prohibition on competing investment options, or (5) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

#### **Note 5 - Related party transactions and party-in-interest transactions**

Plan investments include a variety of pooled separate accounts and a stable value account managed by Transamerica. Transamerica is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Direct fees paid by the Plan to the custodian for administrative expenses amounted to \$77,112 for the year ended December 31, 2024. The Participating Employers pay for any other fees related to the Plan's operations.

The Plan has entered into a revenue sharing agreement with Transamerica to establish an expense budget account for purposes of paying certain Plan expenses. The expense budget account totaled \$0 and \$339 as of December 31, 2024 and 2023, respectively. There were no amounts contributed into the expense budget account for the year ended December 31, 2024. Pursuant to the agreement, the expense budget is treated as a Plan asset and must be used only for appropriate Plan expenses. The Plan earned \$50,272 from the revenue sharing agreement, which is recorded as other income on the statement of changes in net assets available for benefits and utilized \$50,613 from the expense budget account to pay administrative fees for the year ended December 31, 2024.

#### **Note 6 - Tax status**

The Plan has been designed using a pre-approved multiple employer plan document designed by CCH Incorporated DBA ftwilliam.com. CCH Incorporated DBA ftwilliam.com received an opinion letter dated June 30, 2020 in which the IRS stated that the pre-approved multiple employer plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Certified investments**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Transamerica, the custodian of the Plan.

#### **Note 8 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain Plan contributions were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. The supplemental schedule includes delinquent participant contributions of \$66,590 pertaining to the year ended December 31, 2021, 2022, and 2023 for which the Company made a corrective contribution of lost earnings that was deposited into the Plan and allocated to the affected participants during 2024. The Company is currently working with its third-party administrator to correct the remaining \$13,571 of delinquent participant contributions relating to payroll for the year ended December 31, 2024. The Company believes that these transactions should not affect the tax-qualified status of the Plan.
