INDEPENDENT AUDITORS' REPORT

To the Plan Trustees of the

SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed audits of the financial statements of Systemtec, Inc. 401(k) Salary Reduction Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE A -- GENERAL DESCRIPTION OF THE PLAN

The following description of the Systemtec, Inc. (the “Employer” or “Company”) 401(k) Salary Reduction Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of the Company, who are age twenty-one or older, full-time, have three months of service and then can be enrolled at the following enrollment date, which is quarterly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions: Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan, subject to the limitations as defined in the Internal Revenue Code (IRC). Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides a matching contribution equal to 50% of up to the first 5% of compensation deferred by the participant. During the years ended December 31, 2024 and 2023, the Company made matching contributions of \$138,472 (net of forfeitures of \$98,836) and \$167,956 (net of forfeitures of \$66,745), respectively. Additional employer profit sharing contributions may be made at the discretion of the Company, there were no additional profit-sharing contributions made during 2024 or 2023.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, as well as allocations of the Company’s profit-sharing contributions, if applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company’s profit-sharing and matching contribution portions of their accounts is based on years of service. A participant is 100% vested after five years of credited service.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest, or installments until the balance is depleted (installments only apply to required minimum distributions). For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan provides for mandatory distributions following severance from employment for any participant who has an account balance less than \$5,000. A hardship distribution may be made to eligible participants to satisfy certain immediate and heavy financial needs in connection with qualifying expenses, as defined by the Plan.

NOTE A -- GENERAL DESCRIPTION OF THE PLAN – Continued

Forfeited Accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,326 and \$71,576, respectively. Forfeitures may be used to reduce employer contributions, pay administrative fees or the Company can elect to have the funds directly disbursed back to them. For the years ended December 31, 2024 and 2023, the Company used forfeitures to reduce administrative expenses and employer contributions by \$98,836 and \$66,745, and had \$0 returned directly, respectively.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the processing of participant withdrawals are charged directly to the participant's account and are included in administrative expenses. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events: The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

NOTE C -- INFORMATION PREPARED AND CERTIFIED BY THE PLAN CUSTODIAN & TRUSTEE
- (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.) (custodian from January 1, 2023 through December 2, 2024) and Empower Trust Company, LLC (trustee from December 3, 2024 through December 31, 2024) the custodian and trustee, have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

- Investments shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment activity as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the footnotes for the years ended December 31, 2024 and 2023, and supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D -- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE E -- FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: The fair value of the investments in collective trust funds is determined by each fund's trustee based on the fair value of the underlying securities within the fund, which represent the NAV of shares held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective investment trust, the issuer reserves the right to require 1 business day notification in order to ensure that the securities will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024.

Fixed annuities: The Plan's investment in a fixed annuity contract is valued at the contract value, which represents contributions made under the contract, plus earnings, less withdrawals. The contract is backed by the general account of the insurance company and provides a guaranteed return of principal and a stated interest crediting rate. The fixed annuity is valued using the contract's surrender value as provided by the insurance company. The surrender value represents the amount the Plan would receive if it were to terminate the contract at the reporting date. Because this value is based on observable inputs provided by the issuer but is not quoted in an active market, the investment is classified as Level 2 in the fair value hierarchy.

NOTE F -- RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by the custodian or trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

NOTE G -- TAX STATUS

The Company adopted a non-standardized pre-approved profit-sharing/money purchase/CODA plan (the plan) sponsored by a Third-Party Administrator. The Internal Revenue Service (IRS) has determined and informed the Third-Party Administrator by a favorable opinion letter dated November 14, 2022, that the plan is designed in accordance with the applicable sections of the Internal Revenue Code (the Code). The opinion letter is being relied on by the Plan. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
