### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the accompanying financial statements of Connexus Energy Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Connexus Energy Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Connexus Energy Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally established January 1, 1999. The Plan was last amended and restated effective December 1, 2023. The Plan covers substantially all employees of Connexus Energy (the Employer) who have assumed a regular full-time position with the Employer or have worked 500 hours of service in a year. Employees are eligible to make salary deferral contributions and receive matching contributions immediately upon date of hire. Employees are eligible to participate in the Employer nondiscretionary contribution upon completing a year of service, which is defined as being credited with 500 hours of service in a 12-month consecutive period. Union employees may participate in the Plan only if the applicable collective bargaining agreement allows for participation in the Plan. The Plan excludes employees working outside the United States, nonresident aliens with no U.S. source income, independent contractors, and leased employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as Pre-tax 401(k) or Roth contributions. The Plan allows catch-up contributions for those participants age 50 or older. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The Plan also includes an auto-escalation feature of 2% each year up to a maximum of 6% of compensation (shall not exceed 6% of compensation when considering both the participant's Pre-tax contributions and Roth contributions) for any participant whose deferral percentage election is below 6%. The Employer must make a mandatory Employer matching contribution, equal to 50% of the first 6% of eligible compensation deferred.

The Employer is required to make a nondiscretionary contribution. For a participant who (a) actively accrued a benefit for the 2021 plan year under the Connexus Energy Defined Benefit Pension Plan and (b) was an eligible employee of the Company on December 31, 2021 and January 1, 2022, the Employer nondiscretionary contribution will be equal to a percentage of the participant's earnings determined from the following table based on the participant's full years of vesting service as of the last day of the period:

**Contributions (Continued)**

For all other participants, an Employer nondiscretionary contribution of 7% of eligible earnings will be made. During the years ended December 31, 2024 and 2023, the total amount of nondiscretionary contributions were \$1,903,223 and 1,709,622, respectively. The statements of changes in net assets available for benefits reflect the total amount of nondiscretionary contributions net of forfeitures and excess pension assets used. During the years ended December 31, 2024 and 2023, the amount of forfeitures and excess pension assets used to reduce nondiscretionary contributions amounted to \$1,903,274 and \$1,601,106, respectively.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Employer's contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Employee contributions, plus actual earnings thereon, are immediately 100% vested.

Employer contributions are subject to a graded vesting schedule based on years of service, as defined in the Plan, as follows:

Notwithstanding the above, a participant becomes fully vested upon the completion of five years of service, death, disability as defined in the Plan or the attainment of retirement age (65).

**Forfeitures**

Forfeited nonvested accounts are used to pay Plan expenses or to reduce future Employer contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$150,061 and \$56,276, respectively. Forfeiture amounts used to reduce Employer matching and nondiscretionary contributions were \$24,295 and \$30,000 during the years ended December 31, 2024 and 2023, respectively. There were no forfeiture amounts used to pay Plan expenses during the years ended December 31, 2024 and 2023.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The interest rate is 1% over the prime rate. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service, death, disability, or retirement (age 65), the participant may receive the value of vested interest in his or her account in the form of a lump sum or partial distribution. If a participant terminates employment and the participant's account balance is not greater than \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, prior to January 1, 2024, or \$1,000 and \$7,000, effective January 1, 2024, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. The Plan also allows for in-service withdrawals in the case of financial hardship, as defined in the Plan, and in-service withdrawals upon attainment of age 59 ½.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are expensed when they are incurred and included in the amount of the note issued to the participant. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments, as well as a recordkeeping expense, are charged directly to the participant's accounts and are included in administrative expense. In addition, certain investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

Vanguard Fiduciary Trust Company, the qualified institution of the Plan through November 30, 2023, has certified to the completeness and accuracy of the investment income and interest income on notes receivable from participants for the period from January 1, 2023 through November 30, 2023, in the accompanying financial statements.

Fidelity Management Trust Company, the qualified institution of the Plan effective December 1, 2023, has certified to the completeness and accuracy of all investment information and notes receivable from participants as of December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024 and for the period from December 1, 2023 through December 31, 2023, in the accompanying financial statements and ERISA-required supplemental schedule.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included with Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Money Market Funds:* Valued at the daily closing price as reported by the fund.

*Collective Trust Fund:* Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their Employer contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the qualified institutions of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9 TRANSFER OF ASSETS FROM AFFILIATED PLAN**

Effective December 31, 2021, the Employer resolved to terminate the Connexus Energy Defined Benefit Pension Plan (Pension Plan). During 2022, all of the benefit obligations for the Pension Plan were distributed in full to the respective participants and there were excess pension assets available to liquidate from the Pension Plan. The excess pension assets remaining in the Pension Plan were transferred into the Plan in December 2022. These excess pension assets are to be used in the Plan for future Employer non-matching contributions. There were \$1,903,274 and \$1,586,106 of excess pension assets used to reduce Employer non-matching contributions during the years ended December 31, 2024 and 2023, respectively. The excess pension asset balance as of December 31, 2024 and 2023 in this account was \$9,447,937 and \$10,830,292 respectively.

**NOTE 10 NONEXEMPT TRANSACTIONS**

During 2024, the Company failed to remit employee 401(k) deferral contributions for a certain payroll period within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. The Company has taken corrective action in 2024.
