## Independent Auditor's Report

To the Participants and Beneficiaries  
Stryker Electrical Contracting, Inc. 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Stryker Electrical Contracting, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1. Plan Description**

The following description of the Stryker Electrical Contracting, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all eligible employees of Stryker Electrical Contracting, Inc. and its affiliates (the “Sponsor” or the “Company”) who are age 21 and have completed six (6) consecutive months of continuous (minimum 12 hours) of service, and are not members of the following classes of employees: (a) leased employees; (b) those subject to a collective bargaining agreement; and/or (c) non-resident aliens. Affiliates include Diversified Electrical Systems, Inc., and Stryker Electric and Air, Inc. Effective January 1, 2024, the Plan provides conditions or limitations on immediate participation to employees of Watts Texas, LLC dba Edge Electric hired on or before October 1, 2023. Eligible employees may enter the Plan on the earliest of the monthly enrollment dates following satisfactorily meeting eligibility criteria.

The Plan Administrator is responsible for oversight of the Plan. The 401(k) Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Sponsor's management. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions:** Eligible participants may elect to make contributions to the Plan by means of a salary deferral agreement of up to 100% of their annual compensation, up to the maximum allowable amount under the Internal Revenue Code (the “IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan allows participants to designate certain salary deferral contributions as Roth elective contributions. Designated Roth contributions will be currently included in the gross taxable income of the participant, but distributions of designated Roth contributions and earnings thereon will be excludable from gross taxable income for that participant.

The Company may make matching contributions, at its discretion. The Company's contribution percentage was 50% of the first 5% of participants' compensation for the period from January 1, 2022 to December 31, 2023. Effective for the period from January 1, 2024 to December 31, 2024, the Company's Safe Harbor matching contribution percentage was 100% of the first 3% of each eligible participant's compensation, plus 50% of the amount of the participant's matched employee contribution that exceeded 3% of the participant's compensation but that did not exceed 5% of the participant's compensation. Further, the Company pays locally prevailing wages determined by the Department of Labor to applicable employees under the Davis-Bacon Act, which allows the contribution of the wage fringe benefit component to be an employer non-elective contribution. The respective employees are immediately 100% vested in these contributions, which must be made at the end of the Plan year.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments, as made available and determined by the plan administrator, in 1% increments. Participants may change their investment options daily. The Plan currently offers various investment options, including mutual funds, an insurance company investment contract, and a self-directed brokerage option.

**Note 1. Plan Description (Continued)**

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Each participant's account is reduced by any withdrawals or distributions and charged with an allocation of investment losses, if any, and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions, plus actual earnings thereon. The portion of participants' accounts attributable to the Company's discretionary matching contributions become 100% vested after six years of credited service (at the rate of 20% per year starting with two years of vesting service), as defined in the Plan document. The Company's Davis-Bacon contributions are 100% vested immediately. Eligible participants are 100% vested upon death or becoming disabled. Upon termination of employment, the non-vested portion of a participant's account is forfeited.

**Notes Receivable from Participants:** Participants may borrow from their account balances with interest charged at a rate fixed by the Plan, which remains in effect for the duration of the loan. The maximum loan term is five years except for loans used for a primary residence, which may be as long as 15 years. The loans are secured by 50% of the vested portion of the participant's account. The maximum loan is \$50,000 less the highest outstanding loan balance during the one-year period prior to the new loan application date, or 50% of the participant's vested account balance less any current outstanding loan balance. Principal and interest are repaid through payroll deductions. As of December 31, 2024 and 2023, the Plan had notes receivable from participants with principal balances totaling \$71,218 and \$88,011, respectively.

**Payment of benefits:** Upon retirement, death, total and permanent disability or other termination of service, a participant may elect to receive a lump-sum distribution equal to the participant's vested interest in his or her account. If a terminated participant's vested interest is less than \$5,000, the plan administrator may distribute the vested interest as a lump-sum cash payment without the election of the participant. Upon the death of a participant, the vested balance of the participant's account is distributed to the participant's beneficiary.

The Plan also allows for in-service distributions of participant deferrals, prior to attaining age 59½, in the event of financial hardship. In-service distributions may be withdrawn on the Company's matching contributions after the participant attains age 59½.

**Forfeitures:** Forfeitures may be used to restore participant forfeitures, reduce future employer contributions or pay Plan expenses. During 2024 and 2023, \$13,986 and \$1,048, respectively, of forfeitures were used to reduce employer matching contributions and no forfeitures were used to pay administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

**Basis of accounting:** The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments in mutual funds and self-directed brokerage accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fixed Select Insurance Contract is reported at contract value. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's 401(k) Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from participants and the Company's matching contributions are recorded in the year in which the participant contributions are withheld from amounts paid. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed annually under the IRC are recorded as a liability with a corresponding reduction in contributions.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Participant Withdrawal from the Plan:** There were no participants who left the Plan at December 31, 2024 that had requested a distribution of their account balance.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Note 3. Information Certified and Provided by Trustee**

The following is a summary of the Plan's asset information for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Nationwide Life Insurance Company (Nationwide), the trustee of the Plan and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate to the best of their knowledge. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and supplemental schedule related to the following assets:

Nationwide has certified to the completeness and accuracy of \$488,556 and \$501,904 of net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, respectively.

**Note 4. Fair Value Measurements**

Accounting principles generally accepted in the United States of America establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under that framework are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Self-directed brokerage accounts:** Accounts primarily consists of common stocks that are valued on the basis of readily determinable market prices.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

**Note 5. Investment Contract with Insurance Company**

The Plan holds a group fixed annuity contract, which is a fully-benefit responsive contract with Nationwide. The contract is a traditional investment contract that offers participants a conservative option and provides a competitive interest rate. Both principal and interest payments, minus applicable fees and expenses, are guaranteed by Nationwide. Because the annuity contract meets fully benefit-responsive investment contract criteria, it is reported at contract value in the accompanying Statements of Net Assets Available for Benefits.

The crediting rates for the years ended December 31, 2024 and 2023 ranged from 1.34% to 1.70% and from 1.60% to 1.70%, respectively. The contract does not have a maturity date and continues in force until all assets have been distributed and no further payments are due. Certain events would limit the Plan's ability to transact at contract value. However, the Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value are probable of occurring. The contract value was \$555,743 and \$531,176 as of December 31, 2024 and 2023, respectively.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested and the funds of the Plan will be distributed based on individual participant balances.

**Note 7. Related Party and Parties-in-Interest Transactions**

Nationwide is the current trustee of the Plan; therefore, transactions with the current trustee qualify as party-in-interest transactions. The notes receivable from participants are also considered to be party-interest transactions. Fees paid to the current trustee by the Plan totaled \$22,383 and \$25,366 for the years ended December 31, 2024 and 2023, respectively. These transactions, while considered party-in-interest transactions under ERISA regulations, are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

**Note 8. Tax Status**

Effective January 1, 2022, the Plan adopted a prototype non-standardized profit-sharing plan sponsored by The Retirement Advantage, Inc., the Plan's third-party administrator. The prototype non-standardized profit-sharing plan has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, that the prototype non-standardized profit-sharing plan is acceptable with the applicable section of the IRC. The plan administrator believes the Plan is currently designed and operated in compliance with the applicable provisions of the IRC and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires the Plan's management to evaluate tax positions taken by the Plan, and recognize a tax liability if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**SECURE ACT 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included the SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2024 financial statements related to SECURE Act 2.0.

**Note 9. Risks and Uncertainties**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

**Note 10. Subsequent Events**

Management has evaluated subsequent events through September 12, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
