INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the
Mid Florida Community Services, Inc. 403(b) Thrift Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mid Florida Community Services, Inc. 403(b) Thrift Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: DESCRIPTION OF THE PLAN

The following description of the Mid Florida Community Services, Inc. 403(b) Thrift Plan (“the Plan”) provides only general information. Refer to Plan documents for a more complete description of Plan provisions.

General

The Plan is a 403(b) defined contribution plan covering all employees of Mid Florida Community Services, Inc. (the “Company,” the “Agency,” or “Employer”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by American United Life Insurance Company (OneAmerica), Reliastar Life Insurance Company (Reliastar), National Life Group – Life Insurance Company of the Southwest (LSW), and Allianz Life Insurance Company of North America (Allianz) (collectively, the “contract issuers”), the custodians and qualified institutions for the Plan. OneAmerica acts as the third-party administrator for the Plan and performs certain recordkeeping, plan administration and annual ERISA compliance testing. Also, Florida Retirement Consultants (FRC) serves as Plan Administrator.

Eligibility

All employees of the Employer are eligible for participation in the Plan. An eligible employee may enter the Plan on the first day of each calendar month.

Contributions

Each year, participants may contribute any amount of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. Employer matching contributions are not permitted under the Plan. Participants who have attained age 21 and have completed one year of service, as defined by the Plan, are eligible to receive an employer base contribution equal to 8% of the participant’s compensation for the year ended December 31, 2024, whether or not the participant has made salary deferral contributions to the Plan.

During the year ended December 31, 2024, the Company made contributions totaling \$908,854. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Agency’s contribution, and allocations of the Plan’s earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Mid Florida Community Services, Inc. 403(b) Thrift Plan Notes to Financial Statements

Note 1: DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants are immediately vested in their contributions and employer based contributions, plus any earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant can have only two loans currently outstanding from the Plan. Annuities are treated as loans directly from the contract issuers, and balances are used as collateral. At December 31, 2024 and 2023, the vested interest in accounts used as collateral for loans made outside of the Plan were approximately \$32,000 and \$33,000, respectively.

Benefit Payments

On termination of service due to death, disability, retirement, or other reasons a participant may receive the value of the vested interest in his or her account as a lump sum distribution or an annuity.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements, contract value, and NAV.

The Plan Administrator determines the Plan's valuation policies utilizing information provided by the contract issuers.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

During the year ended December 31, 2024, expenses of \$50,849 were paid by the Plan and allocated to participant accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, September 18, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

- e) All amounts included in Note 5, *Contract with American United Life Insurance Company*.
- f) All amounts included in Note 6, *Annuity Contracts with Other Contract Issuers*.
- g) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: valued at NAV of units of the separate account. The NAV, as provided by the contract issuer, is based on fair value of the underlying investments, which are traded on an active market, held by the account less its liabilities, then divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Fixed annuity contracts: valued at fair value based on a discounted cash flows methodology using a rate of interest as of the financial statement date that reflects a market rate of interest for a contract with similar terms and credit risk.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 5: CONTRACT WITH AMERICAN UNITED LIFE INSURANCE COMPANY

In a prior year, the Agency entered into a deposit administration group annuity contract with OneAmerica to which contributions under the Plan are made. Participants can elect to invest their account balances in either a fixed option account or a pooled separate account maintained by OneAmerica.

Fixed option account: considered a cash equivalent as it presents the following characteristics: 1) there are no front-end or back-end charges, so the investments in the general account are completely liquid; 2) the interest rate credited is a current rate and is not dependent on the length of time the assets are invested with OneAmerica; 3) withdrawals can be made at any time and are processed on the day the request is received; and, 4) the published value is the redeemable value of the fund as there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of the withdrawal request. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. OneAmerica is contractually obligated to repay the principal and a specified interest rate (1% at December 31, 2024) that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer. The crediting rate is reviewed periodically for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Stable value account: alternatively, participants may direct that all or a portion of their account balance be used to purchase units in various funds of the OneAmerica Pooled Separate Account. The Separate Account funds include a wide variety of managed portfolios, including registered investment companies. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. OneAmerica does not guarantee the monies invested in the Separate Account as to principal or income. Benefit payments to participants or their beneficiaries are made directly by OneAmerica from the funds accumulated under the contract.

Note 6: ANNUITY CONTRACTS WITH OTHER CONTRACT ISSUERS

Prior to entering into the deposit administration group annuity contract with OneAmerica, the Plan allowed for several 403(b) fund providers to accept new contributions under the Plan. From the Plan's inception through February 28, 2009, contributions were made to fixed annuity contracts issued by Reliastar, LSW, and Allianz. The contracts accumulate value by receiving contribution premiums and earnings as defined in each type of annuity contract. The annuity contracts accumulate earnings based on the current crediting interest rate, and certain annuity contracts are subject to bonus adjustments if certain length-of-contract criteria are met. Each annuity contract is subject to guaranteed crediting interest rate reflected at the time of contract issuance. Withdrawals may be subject to a fee, as defined in the annuity contract, based on certain length-of-contract criteria and provisions of federal law. There are no reserves against contract value for credit risk of the contract issuers or otherwise.

Note 7: TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC. The Plan administrator and the Plan's tax counsel believe that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by OneAmerica. OneAmerica provides certain administrative services to the Plan. As such, these transactions qualify as party-in-interest transactions.

Note 9: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
