INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Decision Analyst, Inc. 401(k) Plan and Participants:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Decision Analyst, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Decision Analyst, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. NOTE 1: DESCRIPTION OF PLAN

The following description of the Decision Analyst, Inc. 401(k) Plan (the “Plan”) for the employees of Decision Analyst, Inc. (the “Company”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan available to eligible employees of the Company. The Plan was adopted by the Board of Directors of the Company on October 15, 2014. Fidelity Management Trust Company is the trustee of the Plan, and serves as both the custodian and the record-keeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

A participant may elect to defer up to the maximum allowable per federal regulations. Contributions can be made on a tax-deferred basis, on an after tax-basis, or a combination thereof. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Contributions are subject to certain Internal Revenue Code limitations.

Newly-hired employees who do not opt out of automatic Plan enrollment are enrolled in an automatic contribution increase program, which provides for a 1% increase in the contribution percentage on an annual basis, unless and until the participant affirmatively opts out of the program or attains a 3% contribution percentage.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary profit sharing or matching contribution. The Company did not fund discretionary matching or profit contributions during the years ended December 31, 2024 or 2023.

Investment Options

Participants may direct their individual and Company contributions in and among various investment options. Participants may change their investment elections and transfer money between investment options on a daily basis. The investment options consist of publicly-traded mutual funds, including various mutual funds managed by Fidelity or a Fidelity affiliate as well as common/collective trust funds.

Participant Accounts and Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contribution plus actual earnings thereon, is based on years of continuous service. Each participant’s benefits become 33% vested at the end of his or her second year, 66% vested at the end of his or her third year, and 100% vested at the end of his or her fourth year of credited service.

NOTE 1: DESCRIPTION OF PLAN, continued

Forfeited Accounts

At December 31, 2024 and 2023 forfeited, non-vested accounts totaled \$1,075 and \$602, respectively. Forfeitures of non-vested Company contributions can be used to pay administrative expenses of the Plan or to reduce future Company contributions.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Certain expenses incurred in the administration of the Plan are paid directly by the Company, which are excluded from these financial statements.

Revenue Sharing

The Plan provides that revenue sharing earned in connection with Plan investments will be returned to the Plan on a quarterly basis and placed in an "ERISA Account". The ERISA Account is invested in the Fidelity Government Money Market Fund, an interest-bearing cash account, and is included in participant-directed investments in the accompanying statement of net assets available for benefits (modified cash basis). The balance of the ERISA Account was \$19,797 and \$24,228 as of December 31, 2024 and 2023, respectively. The Plan allows for the funds to be used to pay plan expenses, to be allocated back to eligible participant accounts, or a combination of both. No funds from the ERISA Account were allocated to participant accounts in 2024.

Notes Receivable from Participants

Loans are available to all participants and beneficiaries on a uniform and non-discriminatory basis. Loans may not be made available to highly compensated employees (as defined in section 414(q) of the Internal Revenue Code) in an amount greater than the amount made available to other employees. The loans are secured by the balance in the participant's account and bear interest at rates reasonable for similar loans made by other lenders on the date of the loan. Loans may not exceed the lesser of 50% of the present value of a participant's vested accrued benefit or \$50,000, and are generally repaid via payroll deductions with the period of loan amortization not to exceed five years, unless such loan is for the purchase of a participant's primary residence. Loan fees for setup and maintenance are paid by the participant.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or any other reason, a participant may elect to receive a lump-sum distribution equal to the value of that participant's vested interest in his or her account. Participants qualifying for in-service distributions may receive up to the value of the vested interest in his or her account with no minimum amount.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's policy is to prepare its financial statements on the modified cash basis of accounting; consequently, certain income is recognized when received rather than when earned and certain expenses are recognized when cash is disbursed rather than when the obligation is incurred.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Specifically, the open-ended mutual fund shares held by Fidelity Management Trust Company are valued daily using the shares current unit value as determined by the closing values of the underlying securities from established exchanges. The Plan's common/collective trust fund investment in the Fidelity Advisor Stable Value Fund (the "Fund"), is valued at net asset value per unit as reported by Fidelity Management Trust Company.

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid. Benefits paid during the year represent interests in accounts and their vested portions for terminated or retired employees, normal and hardship distributions.

NOTE 3: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 4: INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the advisory opinion, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is exempt from taxation.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, respectively, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income examinations for years prior to 2021.

NOTE 5: STABLE VALUE FUND

The Plan is invested in the Fidelity Advisor Stable Value Fund (the “Fund”), a common/collective trust that invests primarily in fully benefit responsive investment contracts issued by insurance companies, banks, other financial institutions, and other authorized instruments, which are benefit responsive.

The fair value of the Fund is calculated by applying the Plan’s ownership interest in the Fund to the total reported net asset value at fair value of the Fund at the end of the reporting period.

The Plan’s investment in the Fund, which is a stable value pooled fund and carries a “benefit responsiveness” feature that allows plan participants to make exchanges or request benefit payment at contract value. The Fund satisfies the requirements to be a “fully benefit-responsive” investment contract and is eligible for contract value accounting. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Fidelity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The average market yield earned by the Fund was approximately 3.92% at December 31, 2024. The average yield based on actual interest rates credited to participants was approximately 2.15%.

Certain events, such as Plan termination or a plan merger initiated by the Plan sponsor, may limit the ability of the Plan to transact at contract value or may allow for the termination of the wrapper contract at less than contract value. Plan management believes that the occurrence of events that may limit the ability of the Plan to transact at less than contract value is not probable.

NOTE 6: ADMINISTRATIVE COSTS

Certain administrative functions are performed by officers of the Company. No such officer receives compensation from the Plan. Certain administrative expenses are paid directly by the Company. Certain brokerage and processing expenses are paid to the trustee and record-keeper from the Plan. Fees incurred by the Plan for investment management services of \$58,262 were paid via revenue sharing and are presented within net appreciation in fair value of investments in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

NOTE 7: RISK AND UNCERTANTIES

The Plan utilizes various investments, including mutual funds and common/collective investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 8: INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified the completeness and accuracy of all investments and related activity as of December 31, 2024 and 2023 included in the financial statements and supplemental schedules. The following is a summary of that information:

NOTE 9: FAIR VALUE MEASUREMENT

Accounting Standards Codification 820 (ASC 820), “*Fair Value Measurement*”, provides a framework for measuring fair value and establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value on the last business day of the Plan year.

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- **Level 2** – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - quoted prices for similar assets and liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in markets that are not active
 - observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- **Level 3** – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own estimates about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety. The following is a description of the valuation methodologies used for major categories of assets measured at fair value by the Plan.

Mutual Funds

These instruments are public investment vehicles valued using the net asset value provided by the trustee of the fund. The net asset value price is quoted on an active market and is classified within Level 1 of the valuation hierarchy.

NOTE 11: SUBSEQUENT EVENTS

For the plan year ended December 31, 2024, the Plan failed the Average Deferral Percentage (“ADP”) nondiscrimination test. As required by the Plan document, corrective distributions of excess contributions were made to certain highly compensated employees (“HCEs”) subsequent to the plan year-end but prior to the issuance of the financial statements. The total excess contributions, including earnings, amounted to \$7,572. These amounts were distributed to the affected participants on or about January 24, 2025.

The corrective distributions did not result in an adjustment to the net assets available for benefits as of December 31, 2024, but were recorded as a reduction of participants' accounts and a corresponding payment of benefits subsequent to that date.

The Plan has evaluated subsequent events from December 31, 2024 through September 22, 2025, the date the financial statements were available to be issued. The Plan’s management has determined that there are no additional events to disclose.
